ALTIUM RECEIVES A REQUEST TO CONVENE A GENERAL MEETING

SYDNEY, Australia – 23 Oct 2012 – On Monday, 15 October 2012, the Board of Altium announced that Mr Nicholas Martin, the Chief Executive Officer of Altium, had stepped down from his positions with Altium ("Announcement").

Altium advises that on the afternoon of 22 October 2012 it received the attached formal requests from N. & M. Martin Holdings Pty Limited (a company associated with Mr Martin). These documents request that the Board of Altium convene a general meeting and consider a resolution to remove a majority of the current directors of the Board of Altium (or alternatively for resolutions to that effect to be moved in a general meeting). The Board of Altium will take appropriate steps under the Corporations Act to act in accordance with the formal requests received. Further details will be provided by the Board of Altium in forthcoming days.

Otherwise, Mr Martin, through his lawyers, also notified Altium's Board yesterday that "on no basis could it be fairly said that Mr Martin "stepped down from his positions with the Company" and has alleged other defects in the Announcement. Specifically, Mr Martin's lawyers have alleged that the purported termination of Mr Martin's positions with Altium, and the appointment of a new Chief Executive Officer and director, are invalid.

The majority of the directors of Altium remain of the view that it is in the best interests of Altium to adopt a different style of leadership and change the Chief Executive Officer.
