## **Rision And Mozido To Work Together On Mobile Payments For Employees**

The Directors of Reclaim Industries Limited (“RCM”) are pleased to announce the execution of a Memorandum of Understanding (“MOU”) between Mozido Inc. Successful discussions between the parties will allow Rision to bring forward the incorporation of a mobile wallet into the Rision human resources platform, through an integration with Mozido.

### **Terms of the MOU**

- The parties have until the 15<sup>th</sup> of April 2015 to negotiate and execute a definitive agreement.
  - The definitive agreement shall identify partners to whom both Rision and Mozido can promote and sell product that incorporates Rision’s HR platform and Mozido’s mWallet.
  - The parties shall develop an integration plan to enable beta testing.
  - The parties shall explore opportunities to use data analytics to provide business intelligence product offerings to clients, including leveraging Mozido’s loyalty products and services, Rision’s HR business intelligence functionality.
