NOTICE UNDER SECTION 708A(5)(e)  
CORPORATIONS ACT 2001 (CTH) and APPENDIX 3B**

On 7 May 2015 Byron Energy Limited ("Byron or the Company") (ASX:BYE) announced a share placement including a conditional component subject to shareholder approval. At an EGM held on 19 June 2015 shareholders approved, inter-alia, the issue of up to 20,668,000 shares at \$0.25 per shares for the purpose of Listing Rule 7.1 and all other purposes and the issue of 3,748,000 shares to directors and/or their associates, also at \$0.25 per share.

Byron is pleased to announce the issue of 23,516,000 shares under the approvals obtained at the EGM on 19 June 2015.

In order to permit the on-sale of 23,516,000 placement shares issued on 30 June 2015 without the need for a disclosure document to be prepared under Part 6D.2 of the *Corporations Act 2001* (Cth) ("Corporations Act"), Byron makes the following statements for the purposes of compliance with sections 708A(5)(e) and 708A(6) of the Corporations Act:-

- a) the placement shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- b) this notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
- c) as at the date of this notice, Byron has complied with the provisions of Chapter 2M (as they apply to Byron) and section 674 of the Corporations Act.
- d) as at the date of this notice, there is no excluded information (as defined in sections 708A(7) and 708A(8) of the Corporations Act).
