\* The Group's half year report for the period ended 30 June 2016 showed a purchase of investment of AUD \$324,827, and loans to related parties of AUD \$985,397. On 23 September 2016, ASX determined that the Company breached ASX Listing Rule 10.1 as a result of the purchase of investment and, as a consequence of such breach, the Company is required to take corrective action pursuant to ASX Listing Rule 10.9. In compliance with ASX determination, the purchase of investment was effectively cancelled by a related party (Fintech) acquiring the investment from the Group and the proceeds of that acquisition was deemed to form part of the loan to related parties. As a result, the year to date cash flow statement correctly reflects the Appendix 4C lodged for the June 2016 quarter.
