**ASX ANNOUNCEMENT – DIPLOMA GROUP LIMITED (RECEIVERS AND MANAGERS APPOINTED) (ADMINISTRATORS APPOINTED) ACN 127 462 686 (ASX: DGX) (“the Company”)**

Diploma Group Limited appointed Grant Thornton Australia partners David Mark Hodgson, Matthew James Donnelly and Andrew Stewart Reed Hewitt as Joint and Several Administrators of the Company on 22 December 2016. The appointment was made by the Company’s directors pursuant to section 436A of the Corporations Act 2001 (“the Act”).

On the same day the sole director of Diploma Constructions (WA) Pty Ltd (Receivers and Managers Appointed) (Administrators Appointed) and DGX Construction Pty Ltd (Receivers and Managers Appointed) (Administrators Appointed), wholly owned subsidiaries of Diploma Group Limited, (together the three entities referred to as “the Group”) resolved to appoint ourselves as Voluntary Administrators pursuant to section 436A of the Act.

**It is noted Martin Jones and Andrew Smith of Ferrier Hodgson were appointed as Joint & Several Receivers and Managers of the Group on Wednesday, 21 December 2016. Control of the assets, undertakings and management of the Group is now with the Receivers and Managers.**
