ASX WAIVER IN RELATION TO LISTING RULE 9.7

- **ASX grants ICI waiver in relation to Listing Rule 9.7**
- **FFG to proceed with restructure and downstream Swedish IPO**

The Board of iCandy Interactive Limited (**the Company** or **ICI**) are pleased to announce that ASX has granted the Company a waiver from Listing Rule 9.7 to the extent necessary to allow Fatfish Internet Group Limited (**FFG**) as controller of ICI's majority shareholder Fatfish Internet Pte Ltd (**FIPL**) to transfer its interest in the securities of FIPL to another wholly owned subsidiary, Fatfish Global Ventures AB (**FGV**) as contemplated under FFG's proposed asset restructure and foreign offering announced on 11 September 2017.

Background

FFG is the controller of a substantial interest in ICI, held through its Singaporean subsidiary FIPL which holds 187,500,000 ordinary ICI shares, constituting 73.04% of all voting securities on issue in ICI.

The waiver allows FFG to undertake the internal restructure of its holdings notwithstanding the restrictions which otherwise apply to FFG's interests in FIPL as controller thereof pursuant to the restriction agreement between ICI, FIPL and FFG.

The grant of the waiver of Listing Rule 9.7 is conditional upon

- (a) a new restriction agreement in the form of Listing Rule Appendix 9A being entered into by each of FIPL, FGV and FFG for the balance of the escrow period (ending 4 February 2018);
- (b) a copy of the new restriction agreement being provided to ASX; and
- (c) the Company instructing the share registry to reinstate the holding locks on the Restricted Securities for the balance of the escrow period and not to remove the holding locks without ASX's approval.
