Byron Energy Limited ("Byron or the Company") (ASX:BYE) is pleased to announce the completion of the share placement announced to the market on 14 August 2017, and approved by shareholders at the Company's EGM held on 18 September 2017, raising \$A26.5 million through the issue of 378,970,262 shares ("Placement Shares").

In order to permit the on-sale of the Placement Shares without the need for a disclosure document to be prepared under Part 6D.2 of the *Corporations Act 2001* (Cth) ("Corporations Act"), Byron makes the following statements for the purposes of compliance with sections 708A(5)(e) and 708A(6) of the Corporations Act:
