The Company provides the following information as required under ASX Listing Rule 3.10.5A:

- (a) Dilution to existing shareholders as a result of the issue of 39,063,727 Shares pursuant to ASX Listing Rule 7.1A (**7.1A Shares**) is 8%.
- (b) The 7.1A Shares were issued to various sophisticated and institutional investors that participated in the Company's capital raising placement, the details of which were announced by the Company on 25 January 2018 (**Placement**). The Company considered various alternative capital raising options available to it, and determined to raise funds under the Placement as this was considered to be a more efficient and expedient manner to raise the capital required, rather than through or in addition to a pro rata issue or other type of issue in which existing ordinary shareholders would have been eligible to participate.
- (c) No underwriting arrangements were entered into in relation to the issue of the 7.1A Shares.
- (d) A fee of 6% of the gross amount raised under the Placement is payable to Taylor Collison Limited, which acted as lead manager to the Placement. The fee payable in relation to the placement of the 7.1A Shares is \$140,629 (based on 6% of the total amount of \$2,343,824 raised through the issue of the 7.1A Shares). In addition, as part of the fee payable to Taylor Collinson for the Placement, the Company is required to issue Taylor Collinson with 5,000,000 options, each exercisable at \$0.09, expiring 3 years from date of issue.
