## **iCandy Completes Shares Issue for the Acquisition of Animoca's Game Portfolio**

### **Highlights**

- **iCandy has completed an issue of 25,000,000 ordinary ICI shares to Animoca Brands for the acquisition of their game portfolio**
- **The shares were issued at \$0.16 per share or A\$4m value and this is the share payment portion to Animoca brands**
- **The acquisition will add 325 million gamers to the existing audience of 25 million existing iCandy gamers**

iCandy Interactive Limited ("iCandy", "ICI" or the "Company") is pleased to announce that it has completed a share issue of 25,000,000 ordinary ICI shares to Animoca brands for the acquisition of their game portfolio. The shares were issued at \$0.16 per share.

As announced on the 15<sup>th</sup> of November 2017, the Company acquired Animoca's game portfolio and its audience of 325 million gamers, which will add to the existing audience of 25 million existing ICI gamers. The total consideration to be paid to Animoca under the agreement is A\$5m, with A\$1m payable in cash and \$4m payable in equity. This 25,000,000 shares represents the total A\$4m payable in equity.
