APPENDIX 3B and ISSUE OF PERFORMANCE RIGHTS

Attached is an Appendix 3B in relation to a grant of a total of 45,000,000 Performance Rights under the terms of the Performance Rights Plan, as approved by shareholders at the 1 February 2018 Annual General Meeting (AGM).

27,000,000 of the Performance Rights were granted to the Managing Director pursuant to the approval shareholders at the 2018 AGM. The remaining 18,000,000 Performance Rights were granted to other eligible employees.

The Performance Rights are subject to the satisfaction of performance milestones outlined in the Terms and Conditions of the Performance Rights Plan outlined in Schedules' 1, 2 and 3 of the Explanatory Statement to the 2018 AGM Notice of Meeting. To the extent that the hurdles are satisfied (if at all), the Performance Rights will vest and become fully paid ordinary shares in the Company.


