**Market Update on the Animoca Brands Game Portfolio Acquisition**

**HIGHLIGHTS**

- **Integration of Animoca Brand's Game Portfolio into iCandy is progressing well, with the integration expected to be completed by the the end of 2018.**

Reference is made to the ASX announcement by iCandy Interactive Limited ("**iCandy**", "**ICI**" or the "**Company**") (ASX: ICI) on 28 June 2018, wherein the Company announced the completion of the acquisition of Animoca Brands Limited ("**Animoca**") game portfolio.

Reference is also made to iCandy's announcement dated 25 June 2018, wherein the Company announced that under the amended agreement, a 6-month handover period after the closing the transaction will apply, in which Animoca will continue to publish, operate and maintain the game portfolio until the iCandy team is fully ready to adopt the complete roles and responsibilities pertaining to the game portfolio.

The Company is pleased to announce that despite the enormous size of the game portfolio (consisting of 318 mobile games serving 325 million gamers), the process of taking over of Animoca's game portfolio and integrating it into iCandy's existing platform, is progressing smoothly and well. The take over and integration process is on schedule to be completed by the end of 2018 and will give rise to a combined portfolio of more than **340 mobile games** serving **350 million gamers**, firmly providing a key value proposition to the Company as a global player in the digital entertainment arena.

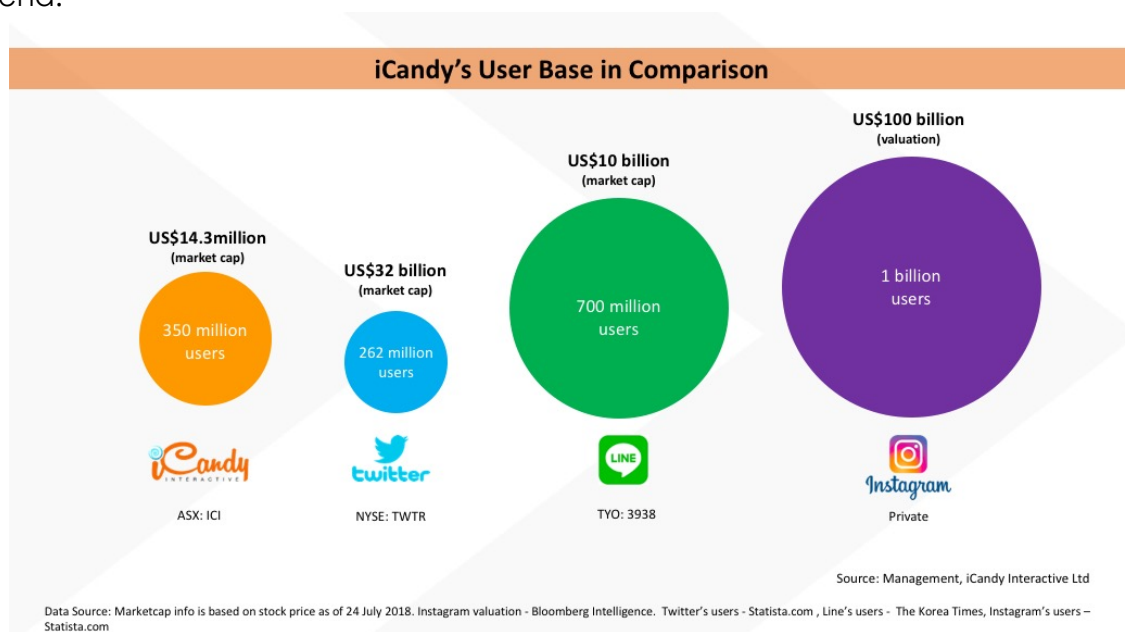


Diagram 1 : iCandy's User Base in Comparison
