## Terezia Adit Re-Entry Reveals Co-Ni Massive Sulphides

- **Field reconnaissance has identified Terezia Adit Portal**
  - *Initial mapping has identified extensive secondary and sulphide hosted cobalt-nickel mineralisation*
  - *Refurbishment planning commenced to facilitate underground drilling*
- **Entire Zemberg-Terezia System confirmed to extend across a strike length of 1,500m with up to three discrete veins identified**
- **Detailed historic data compilation, field reconnaissance of adits, waste dumps and historical pits based on Lidar transforming understanding of the scale of the Dobsina Project**
- **1,457m of accessible development within the Middle Terezia Adit**

European Cobalt Ltd ("EUC" or "the Company", ASX: EUC) is pleased to announce the re-entry of Terezia Adit system has been completed and has revealed cobalt-nickel massive and semi massive sulphide mineralisation and extensive secondary cobalt mineralisation. Terezia Adit represents the eastern extent of the east-west trending Zemberg-Terezia Vein System. The Zemberg-Terezia Vein System extends across a strike length of 1,500m, with up to three discrete veins noted to occur. In total, 1,457m of development is accessible within the Middle Terezia Adit.

Managing Director, Rob Jewson commented "The opening up of the Terezia Adit represents the first modern exploration completed across this vast strike extent of what appears to be a considerable mineralising system.

Our initial focus of exploration activities has been predominantly towards the Zemberg portion of the vein system and through opening up of Terezia we have effectively doubled the strike length across which we are conducting extensive exploration."

MIDDLE TEREZIA ADIT

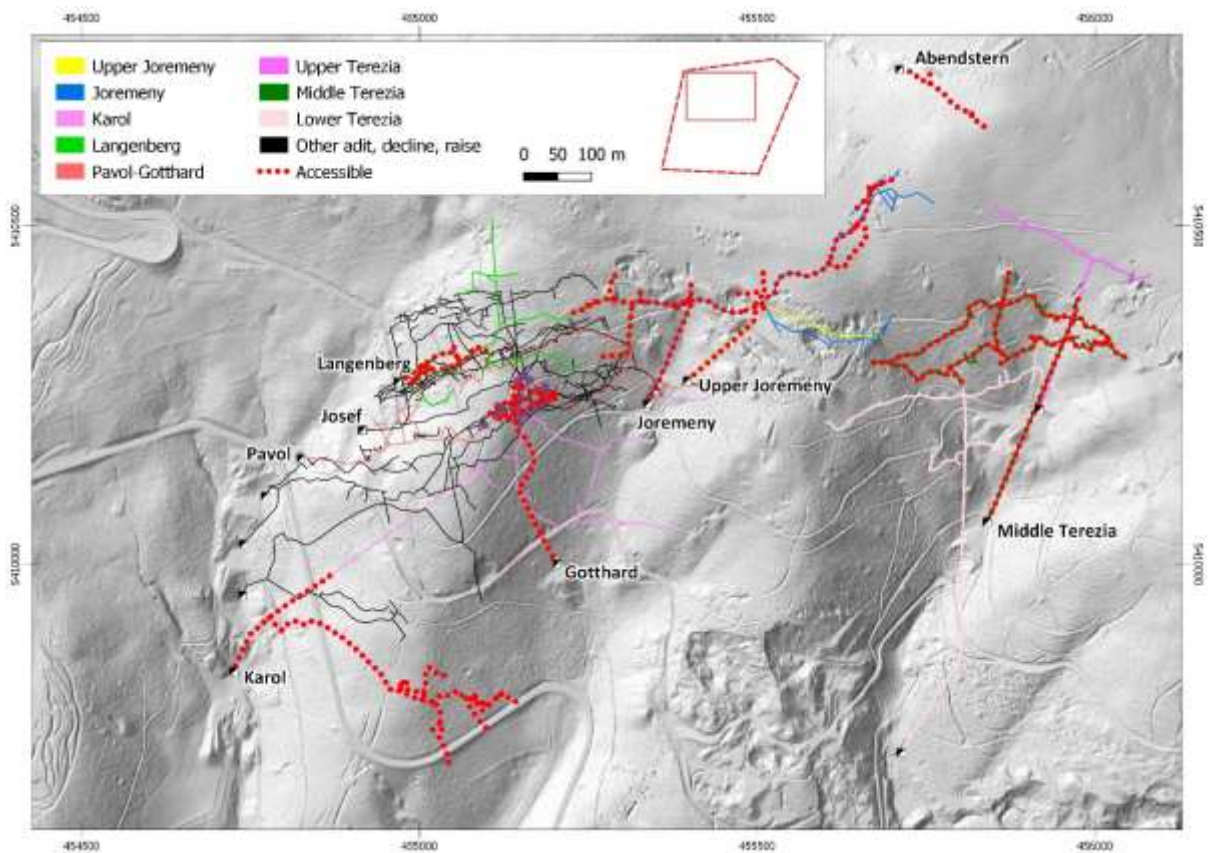


Figure 3: Plan View of Zemberg-Terezia Adits and Areas Accessible

The Middle Terezia adit is situated within the north-eastern quadrant of the Dobsina Licence. Two discrete east-north-east trending veins are mapped within the Middle Terezia Adit. The Middle Terezia Adit was re-opened and refurbished in 1955 as part of a regional exploration program and is connected to Upper Terezia and Lower Terezia via rises and winzes respectively.

Initial exploration activities to be conducted within the Middle Terezia Adit include underground surveying, geological mapping, channel sampling and hand held diamond drilling. Portal installation works have commenced to stabilise the entry prior to detailed geological works being undertaken.

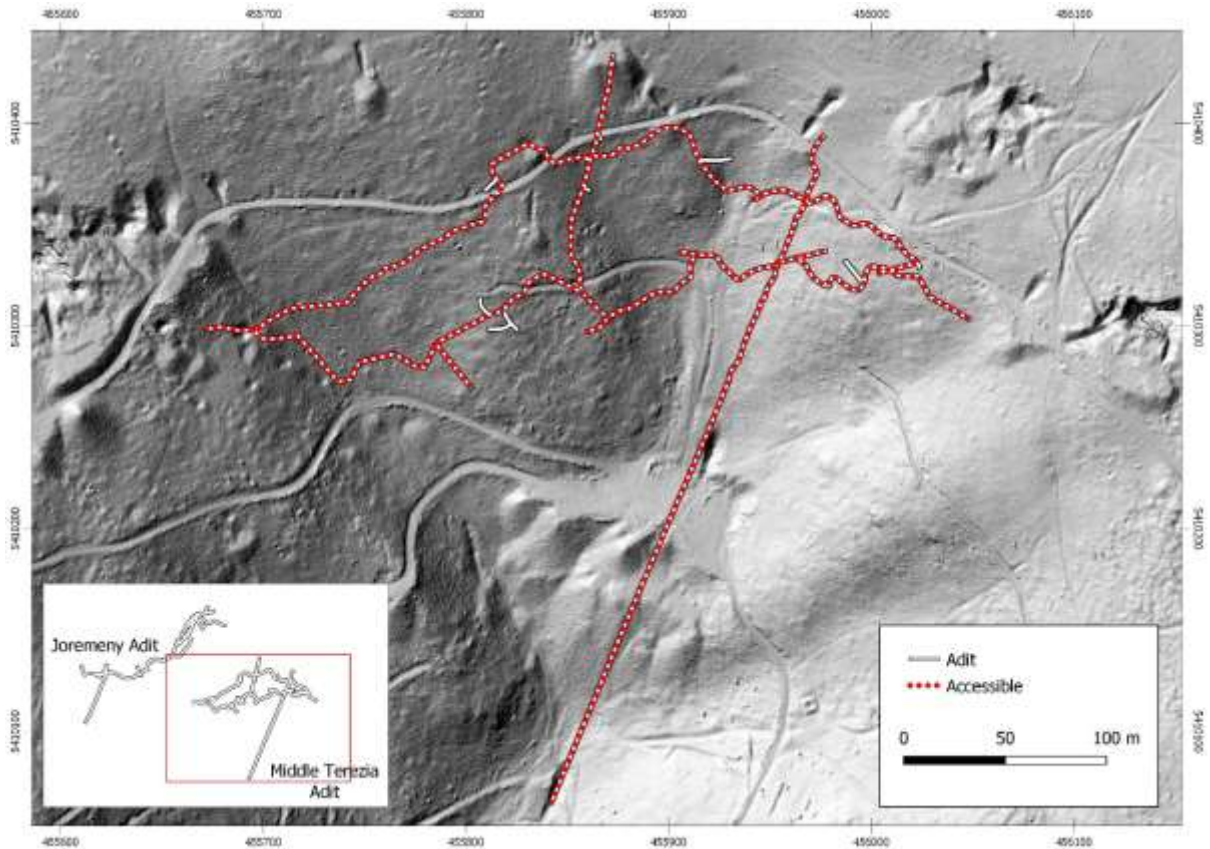


Figure 4: Plan View of Middle Terezia Adit, areas accessible and Lidar DTM Background

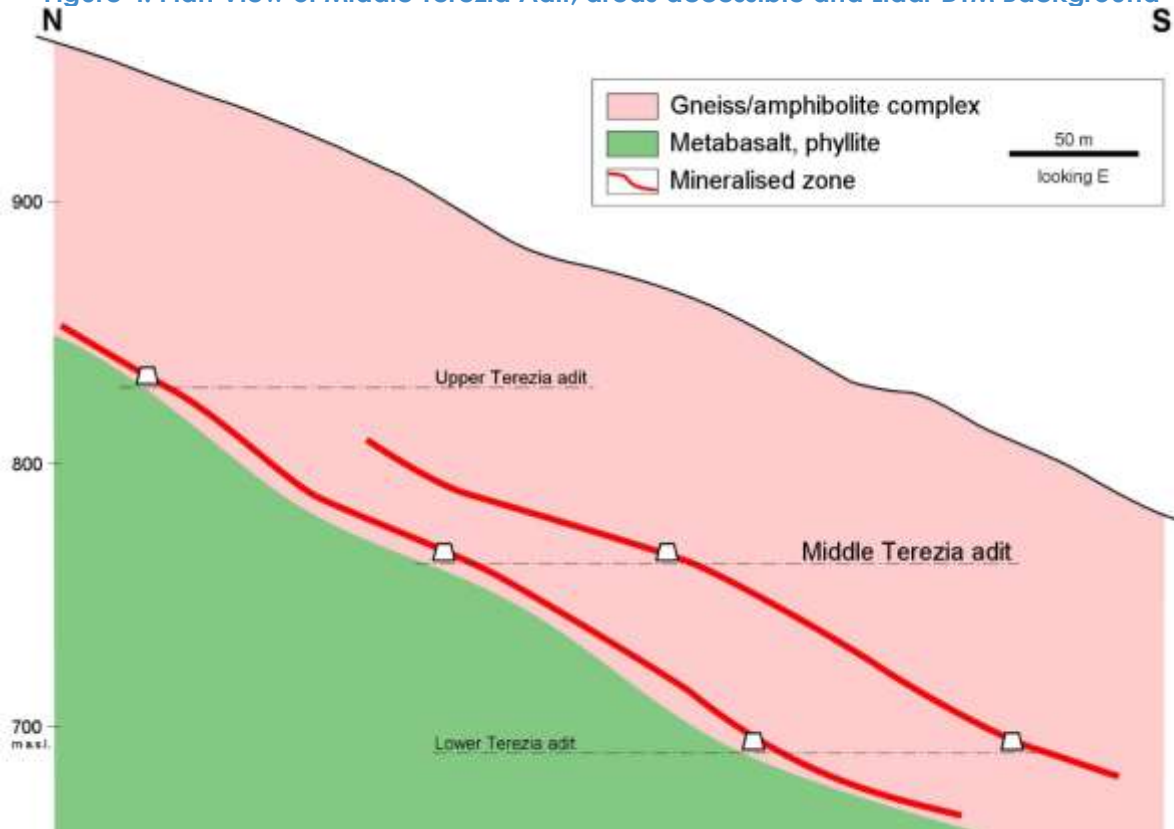


Figure 5: Section View of Middle Terezia Adit
