## **Sentara Healthcare Selects Mach7 for PACS Modernisation**

**Melbourne, Australia; 28 March 2019:** Mach7 Technologies Limited (ASX:M7T, "Mach7"), a company specialising in innovative data management solutions for healthcare providers, today announced it has been contracted by Sentara Healthcare (Sentara) for its Picture Archive Communication System (PACS) modernisation project.

Mach7 announced to market in November 2018 it had been selected as Sentara's vendor of choice to provide Mach7 Diagnostic Studio as part of its PACS modernisation project. This contract has now been executed and includes a subscription license to Mach7 software that will generate an additional guaranteed minimum of \$420k per year of recurring subscription fee revenue to Mach7. Together with existing annual support fees, Mach7 will earn a minimum of \$850K guaranteed annual subscription fees from Sentara. These subscription fees will increase where study volumes exceed the contracted minimums.

There is no cost of goods sold (e.g. licensing of third-party products) associated with this contract, therefore the gross margin is 100%. Mach7 will also earn standard implementation fees.

As part of their ongoing partnership, Mach7 and Sentara have jointly developed an Imaging Innovations Lab at Sentara. This lab will be used to provide prospective Mach7 customers an opportunity to see current Mach7 software in use and in development. They will also have unique access to both technical and clinical resources that will provide transparency to the Mach7 PACS modernization platform to enable their decision-making process.

Mike Lampron, CEO, commented "Mach7 is excited to have the opportunity to be part of Sentara Healthcare's PACS modernisation project. Mach7's PACS modernization product goes beyond a traditional PACS replacement by consolidating several disparate PACS systems into one imaging platform, proving again the power of the deconstructed PACS model. I believe the innovations lab will be of considerable value to Mach7 by providing a live example of our PACS product that our prospective customers can leverage."
