



SYRAH SUCCESSFULLY COMPLETES ENTITLEMENT OFFER

Syrah Resources Limited (**ASX: SYR**) (**Syrah** or the **Company**) is pleased to announce the successful completion of its fully underwritten 1-for-5 pro rata accelerated non-renounceable entitlement offer (**Entitlement Offer**), originally announced by Syrah on Wednesday, 19 June 2019.

The retail component of the Entitlement Offer (**Retail Entitlement Offer**) closed at 5.00pm (AEST) on Monday, 8 July 2019 and represented the final stage of the approximately A\$55.8 million Entitlement Offer. The institutional component of the Entitlement Offer closed on Thursday, 20 June 2019 and raised approximately A\$25.1 million (US\$17.3 million)¹, as announced by Syrah the following day.

The Retail Entitlement Offer raised approximately A\$30.7 million (US\$21.2 million²) and was well-supported by Syrah's eligible retail shareholders.

Approximately 25.4 million new Syrah ordinary shares (**New Shares**) will be allocated to Syrah's eligible retail shareholders as a result of valid applications for entitlements and allocations at Syrah's discretion (including subject to scale back) of additional New Shares applied for in excess of such entitlements under the 'top-up facility', representing a take up rate of approximately 67% (including take up of entitlements and under the 'top-up' facility, but excluding applications to the extent scaled back by Syrah in its discretion).

Approximately 12.5 million New Shares not taken up under the Retail Entitlement Offer will be subscribed for at the offer price of A\$0.81 per New Share by sub-underwriters of the Retail Entitlement Offer in accordance with underwriting and sub-underwriting arrangements.

The issue of New Shares in connection with the Entitlement Offer (including underwriting and sub-underwriting arrangements) will not result in any Syrah shareholder's voting power exceeding 20%. In particular, following allotment of New Shares associated with the Retail Entitlement Offer, AustralianSuper Pty Ltd as trustee for AustralianSuper will have voting power of approximately 16.6% of Syrah's issued capital.

New Shares under the Retail Entitlement Offer are expected to be issued on Tuesday, 16 July 2019 and commence trading on the ASX on Wednesday, 17 July 2019, with holding statements expected to be sent that day. New Shares issued under the Retail Entitlement Offer will rank equally with existing Syrah ordinary shares from the date of issue.

Balama transitioned to operations with sales and shipments to a global customer base including the battery anode producers, from the start of 2018. Syrah produced over 100,000 tonnes of natural graphite in 2018 and is the largest and first major new natural graphite operation developed outside of China. Balama will be the leading global producer of high purity graphite. Balama production is targeted to supply traditional industrial graphite markets and emerging technology markets. Syrah is also progressing its downstream Battery Anode Material strategy with first production of spherical graphite achieved in December 2018 from its plant in Louisiana, USA. Syrah has successfully completed extensive product certification test work with several major battery producers for the use of Balama spherical graphite in the anode of lithium-ion batteries.
