Updates for the Quarter Ended 30 September 2020

Fatfish Group Limited ("FFG" or the "Company") is pleased to provide an update on its activities for the quarter ended 30 September 2020 ("Quarter").

1. Share Buy Back

On 30th June 2020, FFG announced that it will undertake an on-market buy-back of its shares, to buy back up to a maximum of 60,000,000 ordinary fully paid shares. The Company commenced the Share Buy-Back on 14 July 2020 for up to a 12- month period.

2. iCandy's Capital Raise & New Game Launch

During the Quarter, FFG's investee ASX-listed iCandy Interactive Ltd ("iCandy") completed a highly successful early access trial for its new game, Masketeers: Idle Has Fallen ("**Masketeers**"). Masketeers received more than **1 million pre-orders** – the highest number iCandy has ever seen in its game portfolio – before being globally launched on 6 October 2020.

On 15 September 2020, iCandy raised a total of A\$1.25 million via a heavily over-subscribed capital raising. Approximately one week later, iCandy raised a further A\$1.2 million at a 125% premium over the last issue price from strategic investors with track-records in digital marketing in North America,

FFG owns 192,500,000 shares in ICI, via Abelco.

3. Share Price of Abelco Appreciated Significantly

A large part of FFG's assets on its balance sheet are made up of shares held in Swedish listed Abelco Investment Group AB ("**Abelco**") that have strong liquidity in the Swedish market.

At the beginning of the Quarter on 1 July 2020, Abelco's shares were trading around SEK 0.057 and at the close of the quarter at 30 September 2020

Abelco's shares were trading at SEK0.19, representing a sharp increase of share price during the quarter.

At 29 October 2020, Abelco's shares were trading at SEK0.146.

4. Event Subsequent To The Quarter - Capital Raise

On 26 October 2020, FFG successfully completed an A\$1.5 million capital raising (before costs) via a share placement to sophisticated investors. The placement received strong supports with more than A\$7.0 millions in bids.

FFG wishes to highlight that the cash proceeds raised from the Placement is not reflected in the attaching Appendix 4C, as the Placement was completed after the Quarter.

In Item 6 of the Company's Appendix 4C of the cash flow report for the quarter, it has been reported that there were payments to Related Parties of approximately \$9,000. This was payment for directors' fees.

The Company entered into a definitive legally binding agreement with US based Arena Investors, LP for the issuance of up to \$10 million convertible notes. Salient terms of the Notes are as follows:

(i) To be drawn over 10 tranches;

(ii) Investor may elect to convert the Notes at any time up to the Maturity Date, at the lower of 125% of the average of the closing prices of Fatfish's shares for the 25 trading days immediately prior to the issue date of the Notes which is being converted and 90% of the average of the closing price of Fatfish's shares for any 5 consecutive trading days (specified by the Investor) during the period of 25 trading days immediately preceding the last trading day before the conversion date, provided always that in any event, the conversion price shall not be lower than A\$0.013);

(iii) Maturity date is 12 months from date of issue of each tranche, after which the Company shall redeem the relevant Notes in cash, provided that they have not been converted into shares by the Investor;

(iv) Coupon rate of 1.0% per annum; and

(v) A Termination Payment of A\$500,000 less an amount equivalent of the number of tranches drawn down (up to a maximum of 5 tranches) multiplied by A\$100,000 at the relevant time the Termination Payment Obligation arises. The Termination Payment obligation arises if:

(a) the Company does not satisfy the conditions precedent for the follow on tranches prior to the proposed date of issue of the relevant follow on tranche;

(b) the Company terminates the Subscription Agreement prior to the 3 year anniversary of the issuance of the first tranche or before all of the follow on tranches have been drawn;

(c) the Company has not issued follow on tranches, that the Investor has consented to subscribe for, by the date 12 months from the date of the Subscription Agreement having an aggregate face value not less than A\$5,000,000, unless the Company's failure to do so is solely due to the Investor not having agreed to subscribe for a follow on tranche; or

(d) an event of default or early redemption event occurs.
