BURRACOPPIN HALLOYSITE PROJECT ADDITIONAL TENEMENT GRANTED

HIGHLIGHTS

- **Tenement E77/2774 recently granted**
- **Significant milestone with both Burracoppin Project tenements now granted**

Ragusa Minerals Limited (ASX: **RAS**) ("**Ragusa**" or "**Company**") is pleased to advise that it has received notification from Western Australia's Department of Mining, Industry Regulation and Safety that tenement E77/2774 has been granted – part of the Company's 100% owned Burracoppin Halloysite Project ("**Project**"), located ~300 kilometres east of Perth in Western Australia.

E77/2774 comprises 20 blocks and is prospective for halloysite and kaolinite. The Burracoppin Project is located near Merredin, with port access easily accessible via the Great Eastern Highway. All services required for a low-cost operation are in close proximity.

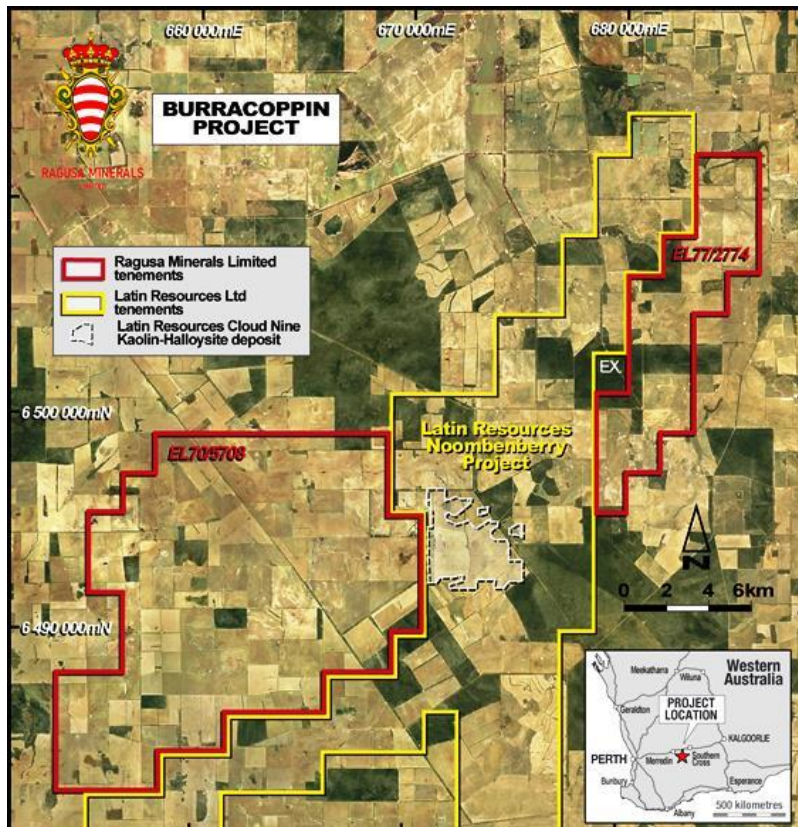


Figure 1. Burracoppin Halloysite Project Location

Ragusa Chairperson, Jerko Zuvella said **"This is a positive next step for the potential development of our Burracoppin Halloysite Project – with both tenements now granted. We will prepare for our maiden drilling campaign and target the open strike extensions of the adjacent mineralisation. We look forward to determining the development potential for a fast-track DSO operation at Burracoppin."**

The Company is preparing and will lodge a "Program of Work" to DMIRS – outlining an initial drilling plan and associated works, and once regulatory approval is confirmed for such, the Company will progress toward conducting the maiden drilling program within E70/5708.
