NOTICE IS HEREBY GIVEN that the 2022 Annual Meeting of Stockholders (**Annual Meeting**) of GQG Partners Inc., a Delaware USA corporation (**Company**) (**ASX:GQG**), will be held at 9:00 am (Australian Eastern Standard Time) on Wednesday 27 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Tuesday 26 April 2022.

Items of Business

Re-election of Class I Director – Mr. Paul Greenwood

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

“That Mr. Paul Greenwood, being a Director whose appointment expires at the conclusion of the 2022 Annual Meeting of Stockholders of the Company and being eligible, offers himself for re-election, be re-elected as a Class I Director of the Company.”

The Company, being a company incorporated in the State of Delaware, United States, is not required to meet the Corporations Act 2001 (Cth) requirements to lay before the Annual Meeting the annual financial report and other related reports. However, there will be an opportunity to raise questions on the management and performance of the Company. In addition, the Company will make available the Company’s auditors during the Annual Meeting to answer any questions regarding the audit of the Company’s financial report, a copy of which is available on the Company’s website.

Status of CDIs

The Board of Directors (**Board**) of GQG Partners Inc. (**Company**) is soliciting proxies for use at the 2022 Annual Meeting of Stockholders (**Annual Meeting**) to be held at 9:00 am (Australian Eastern Standard Time) on Wednesday 27 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Tuesday 26 April 2022 and at any adjournment or postponement of the Annual Meeting.

The Annual Meeting will be held as a virtual event, which will be conducted online. Owners of shares of Common Stock of the Company (**Shares**) and record holders of CHESS Depositary Interests (**CDIs**) will be able to watch and participate in the Annual Meeting virtually via the online platform by using a desktop or laptop computer (or other device with a compatible browser connected to the internet) – online at <https://meetings.linkgroup.com/GQG22>.

QUESTIONS AND ANSWERS ABOUT THE ANNUAL MEETING AND VOTING

What is the purpose of the Annual Meeting?

At the Annual Meeting, record holders of Shares (**Stockholders**) and holders of CDIs are invited to act upon the matters outlined in the Notice of Annual Meeting of Stockholders (**Notice of Meeting**) being:

- Item 1: Election of Class I Director – Mr. Paul Greenwood
- Item 2: Any other business as may be properly presented at the Annual Meeting

Who is entitled to vote at the Annual Meeting?

Only those Stockholders of record or holders of CDIs at 7:00 pm (Australian Eastern Daylight Time) on Tuesday 8 March 2022/3:00 am (U.S. Eastern Standard Time) on Tuesday 8 March 2022 (**Record Date**) will be entitled to receive notice of and to vote at the meeting and any adjournment or postponement thereof. CDI holders as of the Record Date are entitled to receive notice of and attend the meeting and may instruct CHESS Depositary Nominees Pty Ltd (**CDN**) to vote at the meeting by following the instructions on the CDI Voting Instruction Form or by voting online at www.linkmarketservices.com.au.

As of the Record Date, there were 2,952,805,434 Shares outstanding and 593,568,707 CDIs outstanding. Each CDI represents an interest in one Share. Record holders of Shares are entitled to one vote for each Share held as at the Record Date, and holders of CDIs are entitled to direct CDN to vote one vote for every CDI held by such holder as at the Record Date, as further set out below.

Will any investors be excluded from voting on any of the proposals at the Annual Meeting?

No.

How do I use the online platform in connection with the Annual Meeting?

To facilitate Stockholder and CDI holder participation in the Annual Meeting, Stockholders and CDI holders will have the opportunity to participate in the Annual Meeting through Link Group's online platform at <https://meetings.linkgroup.com/GQG22>. If you use the online platform, you will be able to post questions for consideration in advance of the Annual Meeting, view the Annual Meeting live, and ask questions online during the Annual Meeting.

More information about how to use the online platform (including how to vote and ask questions online during the Annual Meeting) is available in the Online Platform Guide, which has been lodged with the ASX and is available at <https://investors.gqgpartners.com/investor-centre/?page=asx-announcements>. If you intend to use the online platform, then before the Annual Meeting we recommend that you ensure the online platform works on your device. Further instructions are provided in the Online Platform Guide.

What are my voting rights?

Record holders of Shares are entitled to one vote for each Share held as at the Record Date. Holders of CDIs are entitled to direct CDN to vote one vote for every CDI held by such holder as at the Record Date. Therefore, as of the Record Date, a total of 2,952,805,434 votes are entitled to be cast at the meeting.

How many Shares and CDIs must be present to hold the Annual Meeting?

In accordance with Section 2.4 of the Company's Amended and Restated Bylaws, the presence in person or by proxy holders of at least half of the capital stock issued and outstanding and entitled to vote thereat, as of the Record date, must be present in person or by proxy at the Annual Meeting in order to hold the meeting and conduct business.

This is called a quorum.

What is a proxy?

It is your designation of another person to vote stock you own. That other person is called a proxy. If you designate someone as your proxy in a written document, that document also is called a proxy or a proxy card. When you designate a proxy, you also may direct the proxy how to vote your Shares. We refer to this as your "proxy vote".

What is the difference between a Stockholder of record and a record holder of CDIs?

If you own Shares registered directly in your name with our U.S. transfer agent, American Stock Transfer & Trust Company, LLC (**AST**), you are considered the Stockholder of record with respect to those Shares. As a Stockholder of record, you have the right to designate a proxy to vote your shares or to vote virtually at the Annual Meeting.

CDN is the Stockholder of record for all Shares beneficially owned by holders of CDIs. Each CDI holder as at the Record Date is entitled to direct CDN to vote one vote for every CDI held by such holder. Such CDI holders are entitled to receive notice of and to attend the Annual Meeting and any adjournment or postponement of the Annual Meeting and may instruct the Company's CDI depositary, CDN, to vote the

Shares underlying their CDIs.

How do I vote my Shares or CDIs of GQG Partners Inc.?

If you are a Stockholder of record or a record holder of CDIs, you may vote in advance pursuant to the instructions below. Stockholders of record will also have the ability to vote during the Annual Meeting by attending and voting online using Link Group's online platform.

Valid proxy cards for Shares must be received by Link Group no later than 9:00 am (Australian Eastern Standard Time) on Monday 25 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Sunday 24 April 2022.

Valid CDI Voting Instruction Forms must be received by Link Market Services (the Company's CDI registry) no later than 9:00 am (Australian Eastern Standard Time) on Sunday 24 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Saturday 23 April 2022.

After this time, Stockholders of record will still be able to vote by voting during the Annual Meeting by using the online platform.

What does it mean if I receive more than one printed set of proxy materials?

If you receive more than one printed set of proxy materials, it means that you hold Shares or CDIs registered in more than one account. To ensure that all of your Shares and CDIs are voted, please submit proxies or voting instructions for all of your Shares and CDIs.

How can I attend the Annual Meeting using the online platform?

Stockholders and CDI holders may watch and participate in the Annual Meeting virtually via the online platform by using:

- a desktop or laptop computer (or other device with a compatible browser connected to the internet) – online at <https://meetings.linkgroup.com/GQG22>.

To participate in the Annual Meeting online as a Stockholder or CDI holder, please log in to the Annual Meeting by:

1. Opening your web browser and going to <https://meetings.linkgroup.com/GQG22>. Login to the portal using your full name, email address, mobile number and company name (if applicable).
2. Reading and accepting the terms and conditions before proceeding to click the **‘Register and Watch Annual Meeting’** button.

Once logged in, you will see two screens. The left screen will display a live webcast of the Annual Meeting proceedings and the right screen will display the presentation slides from the meeting.

Can I vote my Shares or CDIs at the Annual Meeting?

If you are a Stockholder of record, you may vote your Shares online during the Annual Meeting by following the instructions available on Link Group’s online platform.

If you are a record holder of CDIs, you must vote your CDIs in advance of the Annual Meeting. Please refer to **“How do I vote my Shares or CDIs of GQG Partners Inc.?”** above for more information.

To participate in the Annual Meeting online, please follow the instructions outlined above in **“How do I use the online platform in connection with the Annual Meeting?”**

We recommend that you submit your vote before the Annual Meeting as described above. If you are a Stockholder of record, submit your vote before the Annual Meeting and later decide to vote online at the Annual Meeting, the vote you submit at the Annual Meeting will override your previous vote.

What is the voting requirement to approve each of the proposals included in the Notice of Meeting?

Item 1 – Election of Class I Director – Mr. Paul Greenwood

You may vote “FOR” or “WITHHOLD” on Item 1.

The vote required to approve the proposal is a “FOR” vote of the holders of a plurality of the voting power of the Shares and CDIs that are present in person or represented by proxy at the Annual Meeting and entitled to vote on such proposal.

Under ASX Listing Rule 14.2.1, a proxy card must allow stockholders to vote for a resolution, against a resolution or to abstain from voting on a resolution. In accordance with the provisions of the General Corporation Law of the State of Delaware, the Amended and Restated Bylaws of the Company provide that directors shall be elected to the Board of Directors by a plurality of the votes cast (i.e., the person(s) elected will be those with the most affirmative votes received among votes properly cast at the Annual Meeting or by proxy). To enable this, ASX has granted the Company a waiver from ASX Listing Rule 14.2.1 to permit the Company not to provide an option for holders of CDIs to vote against a resolution to elect a director in a CDI voting instruction form. The terms of the waiver are that:

- the Company complies with the relevant Delaware laws as to the content of the proxy cards applicable to resolutions for the elections of directors,
- the notice given by the Company to CDI holders under ASX Settlement Operating Rule 13.8.9 makes it clear that holders are only able to vote for resolutions or abstain from voting, and the reasons why this is the case,
- the Company releases details of this waiver to the market as part of the pre-quotation disclosure, and the terms of the waiver are set out in the management proxy circular provided to all holders of CDIs, and
- without limiting ASX’s right to vary to its decision under ASX Listing Rule 18.3, the waiver from Listing Rule 14.2.1 only applies for so long as the relevant Delaware laws prevent the Company from permitting stockholders to vote against a resolution to elect a director.

Can I change my vote or revoke my proxy?

Yes. If you are a Stockholder of record, you may change your vote or revoke your proxy:

- by voting (or voting again) online, by no later than 9:00am (Australian Eastern Standard Time) on Monday 25 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Sunday 24 April 2022;
- by submitting a later-dated proxy card to the Company’s Share Registry at c/o Link Market Services Pty Ltd, Locked Bag A14, Sydney South, NSW 1235, Australia, which must be received by the Company before the time of the Annual Meeting;
- by sending a written notice of the revocation of your proxy to the Company’s Share Registry at c/o Link Market Services Pty Ltd, Locked Bag A14, Sydney South, NSW 1235, Australia, which must be received by the Company before the time of the Annual Meeting; or
- by voting via the online platform during the Annual Meeting.

If you are a holder of CDIs and you direct CDN to vote by completing the CDI Voting Instruction Form, you may revoke those instructions by delivering to Link Market Services, no later than 9:00 am (Australian Eastern Standard Time) on Sunday 24 April 2022/7:00 pm (U.S. Eastern Daylight Time) on Saturday 23 April 2022, a written notice of revocation bearing a later date than the CDI Voting

Instruction Form previously sent.

Is information available regarding the Stockholders list?

Beginning 30 minutes prior to, and during, the Annual Meeting, the list of the Company's Stockholders of record will be available for viewing via Link Group's online platform.

Who pays for the cost of proxy preparation and solicitation?

The Company pays for the cost of proxy preparation and solicitation. We are soliciting proxies by mail. In addition, our directors, officers and regular employees may solicit proxies personally, telephonically, electronically or by other means of communication. The Company's directors, officers and regular employees will receive no compensation for their services in this regard, other than their regular compensation.

EXPLANATORY MEMORANDUM

Item 1: Election of Class I Director – Mr. Paul Greenwood

The Company's Amended and Restated Certificate of Incorporation provides that the Board of Directors shall be divided into three classes, designated Class I, Class II and Class III, as nearly equal in number as possible.

The Board proposes that Mr. Paul Greenwood, a current Class I Director whose term expires at the conclusion of the Annual Meeting, be re-elected by stockholders at the Annual Meeting as a Class I director.

If elected, the term of office of the Class I director will next expire at the annual meeting of stockholders to be held in 2025.

Mr. Greenwood was appointed as a director of the Company on 4 October 2021 and is a member of the Board's Audit, Risk, and Remuneration and Nomination Committees.

Since his appointment as director, Mr. Greenwood has attended all meetings of the Board and the Committees of which he is a member.

Mr. Greenwood is the Chief Executive Officer of Pacific Current Group and was a co-founder of Northern Lights Capital Group (now Pacific Current Group). Prior to Northern Lights, Paul served as director of US Equity for Russell Investment Group. Paul graduated with a BA in Finance from Washington State University and is a CFA charter holder.

Having had regard to the ASX Corporate Governance Principles and Recommendations (4th edition), the Board (with Mr. Greenwood abstaining) considers Mr. Greenwood to be an independent director.

Directors' recommendation for Item 1

The Directors unanimously (other than Mr. Paul Greenwood, who abstained from voting) support the re-election of Mr. Greenwood and recommend that Stockholders vote in favour of this resolution.

Chair's voting intention for Item 1

The Chair of the Annual Meeting intends to vote all available undirected proxies in favour of this resolution.
