### Share Purchase Plan (SPP) now open

As announced to the ASX on 8 April 2022, Navigator Global Investments Limited (**Navigator** or the **Company**) successfully completed a fully underwritten A\$47million institutional placement for 30.4 million new fully paid ordinary shares at a price of \$1.55 per share (the **Placement**).

Shareholders who were on the Company register at 7.00pm (AEST) on Wednesday, 6 April 2022 are being given the opportunity to subscribe for up to A\$30,000 worth of new shares (subject to the terms and conditions of the SPP) in Navigator at an issue price equal to the lesser of:

- A\$1.55 per share, which is the same price at which shares were issued under the Placement; and
- a 2.0% discount to the 5-day VWAP of Navigator shares up to and including the closing date of the SPP (currently scheduled for Wednesday, 11 May 2022), rounded to the nearest cent.

Navigator is seeking to raise approximately A\$10 million under the SPP. The SPP is not underwritten and Navigator may decide to increase this cap and accept oversubscriptions and/or scale back applications under the SPP at its absolute discretion.

The SPP opens today and will close 5.00pm on Wednesday, 11 May 2022. ## LETTER FROM THE CHAIRMAN

Dear fellow Shareholder,

On behalf of the Directors of Navigator Global Investments Limited (ASX: NGI) (**Company**, or **Navigator**), I am pleased to offer you the opportunity to participate in the share purchase plan (**SPP**) which was announced on 7 April 2022. The SPP allows Eligible Shareholders (as defined below) the opportunity to each subscribe for up to \$30,000 worth of new, fully paid ordinary shares in the Company (subject to discretionary scale-back) (**SPP Shares**), without incurring brokerage or other transaction costs, on the terms set out in this Booklet (**SPP Offer**).

The SPP is part of a wider capital raising being undertaken by Navigator. The Company received strong support from both existing and new institutional investors, to raise \$47 million (before costs) in a placement to eligible institutional, sophisticated and professional investors (**Placement**). The Placement completed on 8 April 2022.

Proceeds of the Placement and the SPP will be used to fund the proposed acquisition by Navigator of a 19.8% ownership interest in Marble Capital, L.P. ('Marble Capital'), as announced on 7 April 2022. Further information in relation to Marble Capital and the acquisition is set out in an investor presentation released to ASX on 7 April 2022 (and as may be updated by any further announcements released to ASX).

### SPP Offer Details

The SPP provides you with the opportunity to increase your holding of fully paid ordinary shares in the Company at the lower of:

- the issue price paid by investors under the Placement, of \$1.55 per share; and
- the 2% discount to the 5-day VWAP of Navigator shares up to and including the closing date of the SPP (currently scheduled for 11 May 2022), rounded to the nearest cent,

### (Issue Price).

You may apply for a parcel of SPP Shares valued at \$2,500, \$5,000, \$7,500, \$10,000 and thereafter in \$5,000 increments up to maximum of \$30,000 (in aggregate) (subject to discretionary scale-back by the Company). Participation in the SPP is optional and open to Eligible Shareholders, being holders of fully paid ordinary shares in the Company at 7:00pm (AEST) on Wednesday, 6 April 2022 (**Record Date**) and whose address on the Register is in Australia or New Zealand. The SPP is also being extended to Eligible Shareholders who are Custodians to participate in the SPP on behalf of certain Eligible Beneficiaries on the terms and conditions set out in this Booklet. Your right to participate in the SPP is not transferable. All SPP Shares will rank equally with existing Shares in the Company.

The terms and conditions of the SPP and your personalised Application Form are provided in this Booklet.

The SPP is not underwritten and aims to raise approximately \$10 million.

If applications for more than this amount are received, the Company may in its discretion accept oversubscriptions above this amount, subject to compliance with the ASX Listing Rules and *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*. The Company may also in its discretion undertake a scale-back of applications for SPP Shares. Therefore, you may receive less than the parcel of SPP Shares for which you have applied. Should this happen, the balance of any application money that is not applied to acquire SPP Shares will be refunded to you, without interest.

#### 2 Is participation in the SPP compulsory?

No. Participation in the SPP is entirely voluntary.

Before you decide whether to participate in the SPP, the Company recommends you seek independent financial advice from your stockbroker, accountant or other professional adviser.

If you do not wish to participate in the SPP, do nothing.

#### 3 What is the Issue Price of the SPP Shares?

The issue price paid by investors under the Placement (\$1.55) represents a:

- 11.4% discount to the last traded closing price of Navigator shares on ASX on 6 April 2022, being the last closing price of Shares prior to the date the SPP was announced (i.e. of \$1.75); and
- 11.4% discount to the VWAP of Shares on ASX during the 5 trading days on which sales in Shares were recorded immediately prior to the announcement date of the SPP Offer.

The Issue Price for New Shares under the SPP is also the same price per Share (or lower) that investors will pay for their Shares under the Placement.

## 4 Terms and conditions of the SPP

**Important Notice:** If you participate in the SPP by making a payment via BPAY, you are accepting the risk that the market price of Shares may change between the Record Date, the date on which you make a payment by BPAY and the Issue Date. This means that, up to and/or after the Issue Date, you may be able to buy Shares on the ASX at a lower price or higher price (depending on the market price of Shares on the relevant day) than the Issue Price.

Please read these terms and conditions carefully, as you will be bound by them in participating in the SPP. Shareholders accepting the SPP Offer will also be bound by the Constitution.

The key dates set out in section 2, above, and the key SPP information set out in section 3, above, form part of these terms and conditions. Capitalised terms have the meaning provided in the glossary set out in section 5 below, unless the context requires otherwise.

### 4.1 SPP Offer

- (a) The Company offers each Eligible Shareholder the opportunity to purchase a parcel of SPP Shares valued at \$2,500, \$5,000, \$7,500, \$10,000 and thereafter in \$5,000 increments up to maximum of \$30,000 (in aggregate) under the SPP subject to and in accordance with these terms and conditions.
- (b) The SPP Offer will open on the Opening Date and close on the Closing Date.
- (c) If you choose not to participate in the SPP, your right to participate lapses on the Closing Date (or such other date as the Company determines).
- (d) The SPP Offer to each Eligible Shareholder (whether as a Custodian or on its own account) is made on the same terms and conditions.
- (e) The SPP Offer is non-renounceable and non-transferable and, therefore, Eligible Shareholders cannot transfer their right to purchase SPP Shares to a third party.
- (f) All references to "\$" or "dollars" in these terms and conditions are references to Australian dollars unless otherwise indicated.

### 4.2 Eligible Shareholders

- (a) You are eligible to participate in the SPP Offer if you:
  - (i) were registered on the Register as a Shareholder on the Record Date;
  - (ii) have a registered address in either Australia or New Zealand at that time; and
  - (iii) are not in the United States, and are not acting for the account or benefit of a person in the United States.

### 4.3 Joint holders/Custodians

- (a) If two or more persons are registered on the Register as jointly holding Shares, they are taken to be a single registered holder of Shares for the purposes of determining whether they are an Eligible Shareholder and a certification given by any of them is taken to be a certification given by all of them.
- (b) Subject to these terms and conditions, Eligible Shareholders who are Custodians may participate in the SPP on behalf of each Eligible Beneficiary on whose behalf the Custodian is holding Shares.

#### 4.4 Applications for SPP Shares

- (d) Eligible Shareholders who receive more than one offer under the SPP (for example, because they hold Shares in more than one capacity or in different registered holdings) may apply on different Application Forms for SPP Shares but may not apply for SPP Shares with an aggregate value of more than \$30,000.

- (f) The Company, its officers and agents, may accept or reject your Application at its discretion in whole or in part including, without limitation, if:
- (i) your Application does not comply with these terms and conditions;
  - (ii) it appears you are not an Eligible Shareholder;
  - (iii) your BPAY payment is not received by the Registry by the Closing Date;
  - (iv) if you apply on behalf of an Eligible Beneficiary but do not provide a signed Custodian Certificate;
  - (v) if you apply on behalf of an Eligible Beneficiary but provide an incomplete or incorrectly completed Custodian Certificate;
  - (vi) it appears that you are applying to purchase more than \$30,000 worth of SPP Shares and Shares in aggregate (including as a result of Shares you hold directly, jointly or through a custodian or nominee arrangement) in the 12 months period prior to making the Application; or

**4.5 Issue Price**

- (a) The Issue Price will be the lower of:
- (i) \$1.55 per SPP Share being the same price paid by investors under the Placement announced on 7 April 2022; and
  - (ii) the 2.0% discount to the 5-day VWAP of Navigator shares up to and including the closing date of the SPP (currently scheduled for 11 May 2022), rounded to the nearest cent.
- (b) The issue price paid by investors under the Placement (\$1.55) represents a:
- (i) 11.4% discount to the last traded closing price of Navigator shares on ASX on 6 April 2022, being the last closing price of Shares prior to the date the SPP was announced (i.e. of \$1.75); and
  - (ii) 11.4% discount to the VWAP of Shares on ASX during the 5 trading days on which sales in Shares were recorded immediately prior to the announcement date of the SPP Offer.
- (c) The Issue Price for New Shares under the SPP is also the same price per Share (or lower) that investors will pay for their Shares under the Placement.
- (d) In accordance with the requirements of *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*, the Company confirms that the Issue Price will be lower than the market price of the Company's Shares during a "specified period" (being the 5 trading days immediately prior to the announcement date of the SPP Offer). The market price of the Shares in the Company may rise and fall between the date of the SPP Offer and the date that any Shares are allotted to you as a result of your acceptance of the SPP Offer.
- (e) The current Share price can be obtained from the ASX and is listed in the financial and business section of major daily newspapers circulating in Australia.
- (f) You agree to pay the Issue Price per SPP Share for the number of SPP Shares you have applied for or, if there is a scale-back, the number of SPP Shares calculated under clause 4.9 of this section 4.

**4.6 Number of SPP Shares to be issued**

- (a) If you apply for SPP Shares, you will apply for a certain value, rather than a certain number, of SPP Shares. If your Application is accepted, the Company will divide the value of your Application Monies by the Issue Price in order to determine the number of SPP Shares that, subject to scale-back, will be issued to you.
- (b) If this calculation produces a fractional number, the number of SPP Shares issued will be rounded down to the nearest whole SPP Share (refer to clause 4.9 of this section 4 for more information on rounding).

**4.7 Issue**

- (a) SPP Shares will be issued on the Issue Date.
- (b) SPP Shares will rank equally with existing Shares as at the Issue Date.
- (c) The Company will apply to ASX for the quotation of SPP Shares. It is anticipated that SPP Shares will be quoted on or shortly after the Issue Date.
- (d) The Registry will send you a holding statement, confirming the number of SPP Shares issued to you.

#### 4.8 Acknowledgements

- (a) By making a payment via BPAY you:
- (i) irrevocably and unconditionally agree to the terms and conditions of the SPP and the terms and conditions of the Application Form (if applicable) and agree not to do any act or thing that would be contrary to the spirit, intention or purpose of the SPP;
  - (ii) warrant that all details and statements in your Application are true and complete and not misleading;

#### 4.9 Scale-back and oversubscriptions

- (a) The SPP will be conducted in compliance with ASX Listing Rule 7.2 (exception 5). As the SPP is not underwritten, the SPP may raise more or less than targeted amount (\$10 million). In the event that subscriptions for more than \$10 million are received for the SPP, the Company may decide in its absolute discretion to either: (i) conduct a scale-back of applications; or (ii) accept oversubscriptions above this amount, subject to compliance with the ASX Listing Rules and *ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547*.
- (b) The scale-back of applications may be applied to the extent and in the manner the Company sees fit, which may include taking into account a number of factors, such as the size of an applicant's shareholding at the Record Date, the extent to which the applicant has sold or purchased Shares since the Record Date, whether the applicant has multiple registered holdings, the date on which the Application was made and the total applications received from Eligible Shareholders.
- (c) If there is a scale-back you may receive less than the parcel of SPP Shares for which you have applied.
