### EXTENSION OF CLOSING DATE FOR ENTITLEMENT OFFER

We have been contacted by a number of shareholders over the past two days advising that they had been unable to access the portal to accept and pay for their entitlement under the 1 for 1 pro rata non-renounceable Entitlement Offer announced on 19 October 2022. The problem is a result of technical issues at the Company's share registry, Link Market Services Limited, which occurred over a period of 48 hours.

The problem has now been rectified and shareholders are advised that the Link Market Services portal can now again be accessed to log into the links to take up and pay for their rights under the Entitlement Offer.

While we were unaware of the problem at Link Market Services until being contacted by shareholders, we apologise for any inconvenience caused to shareholders. In view of the problem, the Board has resolved to extend the Entitlement Offer by 48 hours to enable eligible shareholders additional time to complete their applications.

Accordingly, the closing date for applications under the Entitlement Offer will now be 5.00pm (ACDT) on Thursday 24 November 2022.
