Trading – Cash Markets (including equities, interest rate and warrant trades)

- In April 2023, the average daily number of trades was down 20% on the pcp. The average daily value traded onmarket of \$5.171 billion was down 16% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.3% in April, down 0.3% on the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in April was an average of 13.0, down 3% on pcp.
