Liontown awards Open Pit Mining Services Contract

Liontown Resources Limited (ASX: LTR) (Liontown or the Company) is pleased to announce that it has finalised the award of the full Open Pit Mining Services contract for the Kathleen's Corner and Mt Mann open pits at the Kathleen Valley Lithium Project to mining services provider, Iron Mine Contracting Pty Ltd (Iron Mine Contracting).

Iron Mine Contracting are performing drilling and blasting, loading and hauling of ore and waste from open pit excavations, haul road construction and maintenance, and dewatering of open pit excavations services at Kathleen's Corner and Mt Mann open pits located at the Kathleen Valley Lithium Project. Iron Mine Contracting mobilised in December 2022 and commenced open pit operations in early January under a Preliminary Works Agreement and have rapidly ramped up to the Total Material Movement rates required.

The Open Pit Mining Services contract is valued at approximately A\$240 million over a three-year contract term. The award of the full contract follows a competitive tender process in late 2022.

Importantly for Liontown, Iron Mine Contracting has committed to working with the Tjiwarl Traditional Owners with numerous opportunities identified.

Liontown's Managing Director and CEO, Tony Ottaviano, said:

"We have been impressed with the commitment and rapid ramp up by Iron Mine Contracting since they commenced work for us at Kathleen Valley and are therefore very pleased to be awarding them the full Open Pit Mining Services contract.

"The contract formalises the relationship we established late last year and allows us to safely and seamlessly continue on with our open pit mining operations to the high standards and volumes we expect."
