## **CHAIR SUCCESSION**

Ramsay Health Care (Ramsay) (ASX: RHC) Board Chairman, Mr Michael Siddle, today announced that, after nine years in the role, he is intending to step down as Chairman following the Company's Annual General Meeting on November 28<sup>th</sup>. Mr Siddle intends to remain on the Board as a Non-Executive Director and will seek re-election at the upcoming Annual General Meeting.

Mr Siddle said he was pleased to announce that Lead Independent Director, Mr David Thodey AO, will be appointed to the role of Chairman of the Ramsay Board.

"David has made an invaluable contribution to the Ramsay Board since his appointment in November 2017. His extensive experience in the technology and telecommunications industries and his involvement in innovation across a wide range of sectors, has provided important insights and learnings for the Board and the Ramsay executive team. Ramsay is currently making significant investments in digital and data projects designed to improve efficiency and productivity and drive better outcomes for our staff, doctors and patients. David's understanding of technology combined with his experience transforming businesses make him the ideal person to lead the Board through what will be a period of significant change."

Mr Thodey said he looked forward to taking on the role of Chairman as Ramsay makes the necessary investment in transformation to ensure it retains and leverages its strong market positions to become a leading digitally enabled healthcare provider of the future.

"On behalf of shareholders and the Non-Executive Directors of Ramsay I would like to thank Michael for his significant contribution to the Ramsay Board as Chairman since his appointment in 2014. I am pleased that we will be retaining Michael's extensive corporate knowledge and industry insight and expertise garnered over the many years since he started with Ramsay in 1968. Michael has been instrumental in preserving Ramsay's strong culture centred around our purpose of "People caring for people" which was brought to life by our founder Paul Ramsay."

David Thodey is a business leader focused on innovation, technology, digital transformation and telecommunications with more than 40 years of experience.

In addition to being a Non-Executive Director and Lead Independent Director of Ramsay, David is currently Chair of Xero Limited (a global cloud-based accounting solution for small and medium businesses). He is also a member of the Finance Committee at the University of Sydney, Chair of the Great Barrier Reef Foundation (an Australian non-profit organisation established to help protect and preserve the Great Barrier Reef) and co-chair of the Climate Leaders Coalition.

David was previously CEO of Telstra (Australia's leading telecommunications and information services company), Chair of CSIRO (Australia's national scientific research agency) and prior to that he was CEO of IBM Australia and New Zealand.

David is active in public policy and has led an Independent Review of the Australian Public Service (APS) in 2019, chaired a Panel appointed by the NSW Government to lead an independent review of Federal Financial Relations between the Commonwealth and the States in 2020, and led a user audit of the myGov government services digital portal in 2023. From March to December 2020, Mr Thodey was also Deputy Chair of the Federal Government's National COVID-19 Coordination Commission (NCC) Advisory Board.
