29Metals Limited ('**29Metals**' or the '**Company**') today released its Appendix 4D and Half-Year Financial Report for the half year ended 30 June 2023 (the '**HY23 Financial Results**') for 29Metals and its controlled entities (the '**Group**').

This release presents a summary of information reported in the HY23 Financial Results and should be read in conjunction with the full HY23 Financial Results, released separately today.

Unless otherwise stated, results in this release are in Australian dollars and reported on a statutory basis.

Key Results

- Copper and zinc production of 10.0kt (HY22: 20.5kt) and 22.1kt (HY22: 23.0kt), respectively. Production for the period
 impacted by the Extreme Weather Event¹ at Capricorn Copper in March and subsequent suspension of operations.
- Financial results heavily impacted by the Extreme Weather Event with:
 - Revenue of \$235 million (HY22: \$356 million);
 - EBITDA² loss of \$27 million (HY22: \$94 million EBITDA);
 - Operating cash outflow of \$25 million (HY22: \$109 million inflow); and
 - Net loss after tax ('NLAT') of \$307 million (HY22: \$0.4 million net profit after tax ('NPAT')).
- The HY23 NLAT is after non-cash impairment charges of \$206 million relating to the Capricorn Copper cash generating unit ('CGU'), asset damage or loss at Capricorn Copper, and write-down of inventories.
- Cash and equivalents of \$127 million (31 December 2022: \$172 million) and Net Drawn Debt² of \$120 million (31 December 2022: \$26 million), after fully drawing the Group's working capital facility.
- No interim dividend declared for the six months ended 30 June 2023.

2023 | Half-Year Financial Results

Commenting on the financial results Managing Director & Chief Executive Officer, Peter Albert, said:

"29Metals' first half 2023 financial result was significantly impacted by the Extreme Weather Event that resulted in Capricorn Copper's operations being suspended. This includes loss of revenues, increased costs associated with recovery efforts and non-cash accounting impairment charges at Capricorn Copper.

Looking ahead, we remain focussed on executing our plans to deliver positive improvements for both operations in the second half. We continue to progress the Capricorn Copper phased restart of operations, improving development rates at the high-grade Xantho Extended ore body at Golden Grove, completing ventilation upgrades, progressing regulatory approvals, whilst maintaining cost management and capital discipline.

Whilst today's result is not what we hoped for, we are confident that the progress made in the first half, under extremely challenging circumstances, sets the Company on the path to delivering its potential."

Important information regarding non-IFRS financial information

Non-IFRS financial information metrics used in this release

This release contains certain information, such as C1 Costs, AISC, EBITDA, Drawn Debt, Net Drawn Debt, Recovery Costs, Site Operating Costs, and Royalty and Other Selling Costs, that is not recognised under Australian Accounting Standards and is classified as 'non-IFRS financial information' under ASIC Regulatory Guide 230 (Disclosing non-IFRS financial information).

Non-IFRS financial information should be considered in addition to, and not as a substitute for, financial information prepared in accordance with Australian Accounting Standards. Readers are cautioned not to place undue reliance on non-IFRS financial information cited in this release.

Summary of HY23 Financial Results

Revenue

Revenue of \$235 million (HY22: \$356 million) was \$121 million, or 34% lower than the prior corresponding period, reflecting lower sales volumes (including impact of Extreme Weather Event) and lower commodity prices, with:

- a 45% reduction (\$133 million) in copper concentrates revenue, on lower sales volumes and lower copper prices;
- a 46% reduction (\$38 million) in revenue from zinc concentrates, on lower sales volumes and lower payable precious metals content and materially lower zinc prices; and
- lower copper and zinc concentrate revenues partially offset by lead concentrates sales of \$28 million (HY22: nil).

Costs

Cost of sales in HY23 decreased 15% against the prior period reflecting the impacts of lower activity levels as well as an enhanced focus on cost management at both operations, against a backdrop of continuing industry-wide inflation.

Site Operating Costs for HY23 were \$176 million, 21% lower than the prior period (HY22: \$223 million), with:

- lower activity levels from the suspension of Capricorn Copper operations and throughput restrictions in the first four months
 of the year at Golden Grove; and
- higher unit rates under contract mining agreements at both operations.

Stockpile movement charges of \$13 million in HY23 were materially higher (HY22: \$10 million credit) as ROM ore and concentrate stocks were depleted during HY23 reflecting lower mining and milling activity. Royalties and Other Selling Costs were 39% lower reflecting the impact of lower sales volumes and lower commodity prices.

Depreciation and amortisation ('D&A') was 23% lower in HY23 reflecting the impact of lower activity levels on depreciation rates during the period.

EBITDA

EBITDA ³ for HY23 was a loss of \$27 million, approximately \$122 million lower than the prior corresponding period (HY22: \$94 million EBITDA), reflecting decreased sales volumes and realised prices, and the impact of the Extreme Weather Event.

HY23 EBITDA includes costs associated with the phased recovery of Capricorn Copper of \$31 million (HY22: nil) as well as inventory write-down expenses of approximately \$2 million at Capricorn Copper (HY22: nil) and \$7 million at Golden Grove (HY22: nil).

Impairment Expenses

In the context of a sustained decline in 29Metals' market capitalisation following the Extreme Weather Event and the announcement of the suspension of operations at Capricorn Copper, 29Metals undertook a formal assessment of carrying values as at 30 June 2023.

As a result of the analysis performed, a non-cash impairment of \$170 million was recorded in the HY23 results relating to the Capricorn Copper CGU. The impairment reflects the deferral of revenues and increased costs associated with the Capricorn Copper phased recovery. A full summary of the key assumptions and sensitivities in relation to the carrying value test are included in Note 14 of the HY Financial Report.

In addition to the CGU impairment, Capricorn Copper recorded further non-cash impairment charges of \$27 million as a result of damage or loss to assets and \$2 million for the NRV write-down of ROM inventories following an assessment of the direct and indirect impacts of the Extreme Weather Event.


In HY23, Golden Grove Cost of sales included \$7 million of inventory writedown expense (HY2022: nil) on zinc ROM ore and concentrate stockpiles, being the difference between the value attributed to these inventories in the Group's accounts and the assessed NRV, as a result of lower zinc prices in HY23. There was no impairment recorded for the Golden Grove CGU.

NPAT

29Metals recorded an NLAT for HY23 of \$307 million (HY22: \$0.4 million NPAT) including the impact of the Extreme Weather Event and non-cash impairment charges totalling \$206 million.


The term loan facility of \$186 million⁶ at 30 June 2023 decreased by \$12 million from 31 December 2022, reflecting repayments of the term loan facility. At 30 June 2023, the US\$40 million working capital facility was fully drawn.

The \$45 million decrease in cash and cash equivalents to \$127 million (31-Dec-22: \$172 million) reflects lower sales volumes and commodity prices during the period, together with operating outflows in relation to recovery efforts following the Extreme Weather Event, partly offset by drawing down on the Group's working capital facility.

The decrease in cash and cash equivalents is after \$5 million in outflows related to the settlement of derivative financial instruments.

Final settlement of stamp duty in relation to the acquisition of Golden Grove remained outstanding at the end of the period. 29Metals has maintained a \$26 million accrual for stamp duty at 30 June 2023.

Interim Dividend

The Board has determined not to pay an interim dividend in connection with the HY23 Financial Results.

Events Subsequent to 30 June 2023

Events subsequent to 30 June 2023, are as follows:

- Phase 1 of the Capricorn Copper recovery plan was successfully achieved with the recommencement of mining operations at Mammoth and Greenstone, and mineral processing operations, on 1 August 2023⁷; and
- 29Metals received an update from its insurers in relation to the Capricorn Copper Insurance Claim regarding the loss and damage suffered as a result of the extreme weather event, with insurers: ⁸
 - confirming indemnity for damage to property on the surface and associated business interruption, and agreement to
 make an initial unallocated progress payment of \$24 million. The claim process for the balance of the surface property
 damage and associated business interruption is ongoing; and
 - advising that, based on 29Metals' preliminary claim submission and information provided to date, insurers' position is that the policy does not respond to losses relating to underground flooding. Further information has been requested by 29Metals' insurers.
 - 29Metals does not agree with insurers' position regarding coverage of underground loss and will continue to work with
 insurers in relation to further information requirements to advance this claim.

2023 Guidance

In light of the impact of the Extreme Weather Event, including lower activity levels and the Capricorn Copper CGU impairment, 29Metals has revised its D&A guidance for FY23.

AISC	is all-in sustaining costs, and is calculated as C1 Costs plus royalties cost, corporate costs, sustaining capital and capitalised development costs, but excludes growth capital and exploration. AISC is cited is US\$ per pound of payable copper sold. AISC excludes recovery costs in relation to the Extreme Weather Event.
C1 Costs	is mining costs, processing costs, maintenance costs, site general & administrative costs, realisation costs (including shipping and logistics costs), and treatment and refining charges, adjusted for stockpile movements and net of by- product credits (proceeds from non-copper metal sales). C1 Costs is cited in US\$ per pound of payable copper sold. C1 Costs exclude recovery costs in relation to the Extreme Weather Event.
Drawn Debt	is amounts drawn under Group debt facilities as reported in accordance with Australian Accounting Standards, excluding bank guarantees issued under the Group bank guarantee facility.
EBITDA	is earnings before finance income, finance costs, any unrealised foreign exchange gains or losses, any realised and unrealised gains or losses on derivative financial instruments, asset impairment as a result of damage or loss from the Extreme Weather Event at Capricorn Copper, impairment expense relating to the Capricorn Copper cash-generating unit, income tax expense/(benefit) and depreciation and amortisation. Because it eliminates all gains and losses on forward commodity contracts (copper) and swaps (gold), impairment expenses, the non-cash charges for D&A, and unrealised foreign exchange gain or losses, 29Metals considers that EBITDA is useful to help evaluate the operating performance of the business without the impact of those items, and before finance income and finance costs and tax charges, which are significantly affected by the capital structure and historical tax position of 29Metals. A reconciliation of EBITDA to (NLAT)/NPAT is set out on page 10 of this report.
Net Drawn Debt	is Drawn Debt less cash and cash equivalents (excluding cash held as rental security deposit and EMR Capital IPO proceeds retained by 29Metals under cash backed indemnity arrangements described in section 10.6.12.3 of the 29Metals Prospectus). 29Metals uses this measure to understand its overall credit position. Investors should be aware that cash and cash equivalents may be required for purposes other than debt reduction.
Recovery Costs	is costs incurred in relation to the Extreme Weather Event at Capricorn Copper. Recovery Costs include physical remediation works, allocation of Site Operating Costs to support these activities, and are shown net of revenue from gas sales. Recovery Costs are excluded from C1 Costs and AISC.
Royalties and Other Selling Costs	is the sum of government royalties and other production and selling costs, including freight.
Site Operating Costs	is the sum of mining costs, processing costs and site services costs as shown in 29Metals Cost of Sales. Site Operating Costs are shown net of AASB16 leasing adjustments. Mining costs exclude capitalised mine development costs. Site Operating Costs exclude recovery costs in relation to the Extreme Weather Event.
