Dear shareholders,

I was first made aware of Fiji Kava as the naming sponsor of the Kaiviti Silktails RLFC, with whom I am actively engaged and am the #1 ticket holder. I saw that the company has a simple value proposition in endeavouring to provide a suite of high-quality products underpinned by a network of Fijian farmers for whom we can make a big difference with reliable demand for kava at fair prices.

Since taking on the Chairmanship of the company, we have been joined by Griffon Emose and Jim Tonkin on the board as non-executive directors. Jim has brought a wealth of experience and a deep network in the USA market, that now represents most of our sales. Griffon has a long relationship with the business and his financial and Fijian institutional experience has been invaluable to supporting this new and very effective Board of Directors.

In recent years, the regulations for our products in Australia and across various global markets including the USA, New Zealand, and more recently, South East Asia have become more favourable. These regulatory changes pertain particularly to kava and CBD based products and we anticipate this trend to persist globally. These favourable shifts have provided our company with structural tailwinds.

I believe that kava and CBD can become the leading natural health remedies to calm nerves and support mind and muscle relaxation. They boast both safety and broad consumer appeal. Calmer Co is well positioned in both categories with premium-quality offerings and a track record in cultivating demand for new functional health products.

We have needed to make some hard decisions to stay in business this year and to refocus on what is most commercially viable. We can now begin to see the green shoots of those decisions emerging in the second half of the financial year and in particular in the most recent quarter.

Message from the CEO

Dear shareholders,

FY2023 marked a pivotal period of evolution for our company. Under the new banner of The Calmer Co International, we initiated a comprehensive transformation strategy. This involved a strategic shift towards higher-margin distribution channels for our products, supported by an increasingly cost effective supply chain.

This strategy is evident through our recent distribution partnerships with industry leaders such as CJ Patel, Roolife Group, Naturally Elevated, Coles and the continued development of our online sales channels, in particular Amazon.com USA where we are seeing remarkable results for our instant kava range.

The new strategy is a work in progress, but it has begun to yield good results. Our half year sales grew by an impressive 34% in comparison to the preceding half-year, concurrently elevating our gross profit margin to an impressive 46% during the latter half of FY23.

Our supply chain has also been fortified during the year. We have now established 12 farm offtake agreements, strengthening the foundation of our production and we have relocated our processing hub to Navua in Viti Levu, demonstrating our commitment to cost-effective production.

Our corporate rebranding to The Calmer Co. reflects our broadening ambitions and the diversification of our product portfolio. Fiji Kava®, continues to exhibit strong performance, particularly in US ecommerce channels and our USA division has now traded profitably for the past 4 months with an average daily sales turnover exceeding \$3000/day. We will expand on this success and launch into the Kava Bar market in the USA this coming year.

Danodan® has begun to rebuild from a slow 2022 and an increasingly challenging market for cannabis products in the USA, and is tapping into new retail channels in Washington state, Hawaii, and their home market of Oregon. The introduction of a range of innovative topical products further underscores its strategic evolution.

Taki Mai®, in the capable hands of the CJ Patel Group, has found a natural and prosperous niche in the Fiji Islands, the broader Pacific region, and most recently, in New Zealand. This expansion is grounded in solid trade-based strategies with a highly experienced partner.

The revitalisation of our partnership with Leilo® also ushers in exciting new prospect. We have already initiated sales to resorts and higher margin tourism channels in Fiji, with the intention to replicate this distribution model in

multiple new markets and to manufacture locally where possible to increase profitability and reduce complexity and costs associated with beverage logistics.

Despite the past challenges we have faced in the Chinese market, our collaboration with RooLife presents a paradigm shift for China. RooLife boasts a proven track record in driving sales for nutraceuticals, health foods, and functional beverages in China, building our belief in the potential of this vast sales territory; Initially, through ecommerce and with ambitions for launching into general trade. Our supply chain has been comprehensively redesigned for both efficiency and growth. Our manufacturing operations have been strategically relocated to Navua on Fiji's primary island, Viti Levu. This new processing facility enables us to access a skilled workforce and scale production up to 5 times from our current levels with minimal additional capital expenditure.

Our geographic proximity to Kai Ming Agro Processing also plays a pivotal role in our operations, enabling seamless collaboration and co-manufacturing of novel product lines alongside an experienced manufacturing partner.

Our executive leadership team and the Board of Directors, now possess a diverse and comprehensive skill set to drive our global expansion efforts and foster enhanced relationships with government and investors.

James Dack joined the Board in October, amid our turnaround and has lent his steady hand to keeping the team laser-focussed on the drive towards positive cashflow and profitability. James was awarded the Order of Australia Medal this year and the passion and leadership he has shown in services for youth shines through in his engagement with our team and with our Fijian collaborators.

Our CFO, Pravinesh Lala who joined us in May 2022 has been an indispensable part of the senior leadership team, leading the implementation of our new ERP system and Cin7 which has allowed us to take a data driven approach to cost reduction, implement rationalisation of the product range and to ensure all new projects show profit at the SKU level. These projects have underpinned our recent trading improvements and cost savings and hard decisions this year will flow through to the results over the full year FY24.

Finally, the genesis and heart of our business lies with Zane Yoshida. Zane's relentless dedication has been instrumental in elevating our prominence not only within the Fiji Islands but also in global spheres. His efforts are unceasing and his passion for natural health remedies is unwavering. It is my pleasure each day to work with a true gentleman. On behalf of the Board of Directors I am pleased to present to you the Annual Report for the year ended 30 June 2023.

US ecommerce Growth

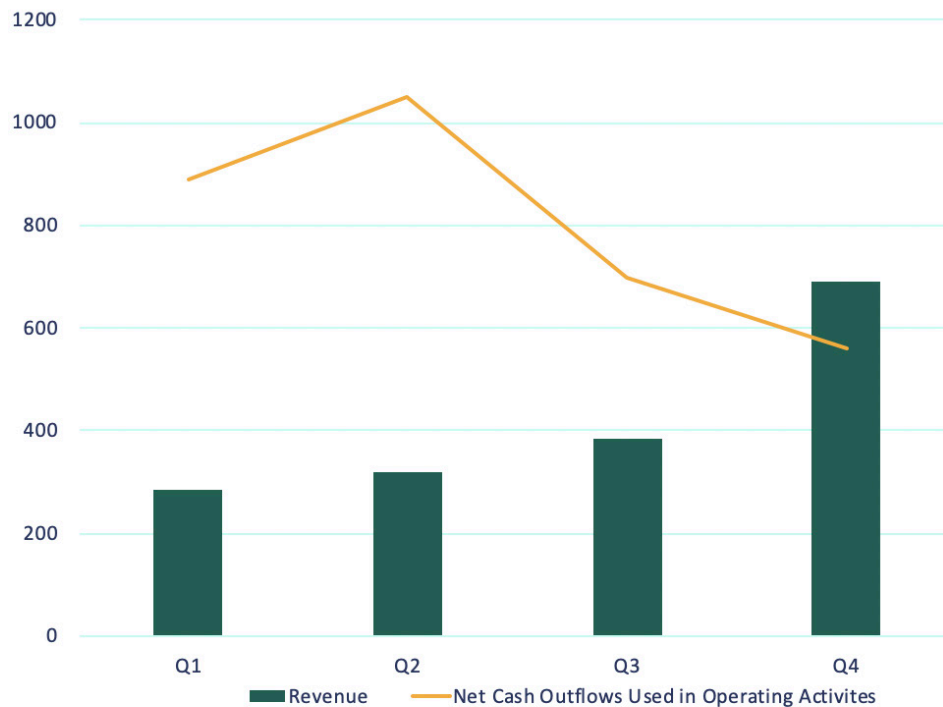

Commentary

- **79% increase in sales revenue in Q4** (vs Q3, 2023) largely due to strong sales growth in ecommerce sales in the USA.
- Fiji Kava is now the number 1 instant kava brand sold on Amazon.com. Daily sale \$2,500 by year end 2023.
- **Daily sales exceeded \$3,000/day** on Amazon.com at the end of August.
- Initial orders from CJ Patel (\$210k) and Roolife (\$150k) have been received and included in Q4 results.
- Cost optimisation program saw **net cash outflows used in operations fall to a low of \$561k** in Q4, which was a 20% reduction on the previous quarter.
- The new processing hub in Navua can continue to **scale manufacturing volumes up to 5X** with little further capital expenditure.

4. Nature of Operations and Principal Activity

The Calmer Co. International Limited (formerly Fiji Kava Limited), (The Calmer Co or The Company) is a health and wellness company with operations in Australia, Fiji, and the USA, which produces nutraceuticals and functional beverage products to reduce anxiety, promote relaxation, improve sleep, and support sports recovery and performance.

The company works with farmers to source high quality kava and hemp that is processed into active extracts for B2B sales or into finished products across a house of brands.

Our Taki Mai® and Fiji Kava® brands are focussed on expanding the distribution of kava throughout global markets to provide a natural alternative to alcohol and to small molecule sleep and anti-anxiety prescription medicines.

Noble kava extracts are backed by a significant body of peer reviewed clinical research into the safe and effective use of kava products, and thousands of years of traditional use in the Pacific Islands. Our Danodan® brand offers a unique patented range of USDA certified organic tinctures, and soon topicals, sold throughout the USA and online for relaxation, sleep and recovery.

The Company's products are Therapeutic Goods Administration (TGA), Food Standards Australia and New Zealand (FSANZ) and Food and Drug Administration (USA) compliant and are sold online and through retailers in Australia, Fiji, New Zealand, across the Pacific and in the United States. The Company is taking steps towards expansion into key Asian markets, including China.



5. Review of Operations

The Company has focussed on investing in building a supply chain that can support expansion into key markets; The Pacific, USA and Asia. We have sought and delivered high quality and well-aligned distribution partnerships for our ingredients, for our Fiji Kava® brand and for our Taki Mai® brand. With innovative new products in the pipeline, the operational milestones achieved in FY23 have set the stage for profitable growth in future years and removed key high-cost impediments to growth and achieving profitability.

Modernisation of Supply chain

The company has undertaken a comprehensive modernisation of our kava supply chain model which now spans across geographic regions and encompasses both community based and commercial farming operations. This allowed us to terminate the lease agreement by our wholly owned Fijian subsidiary South Pacific Elixirs Pte Ltd (SPE) for the Cawatara Estate and to close the manufacturing site in Levuka. Fijian kava processing operations are now in Viti Levu, the main island of Fiji and the company formalised a long-term partnership with KaiMing Agricultural Processing (KAP) as part of the move to new premises and expanded operational footprint in the 40,000ft² Navua site.

The Company has signed a Memorandum of Understanding (MOU) with KAP, which defines collaboration on the manufacture and production of drinking kava products as well as ginger, turmeric and kava juices, and in developing a framework to consolidate key business activities over time. KAP is a family-owned business that has been in operation since 2005, with its factory located on the bank of the

Navua River near Fiji's capital city, Suva. KAP employs over 100 people predominantly from the surrounding areas and prides itself on providing a modern employee focussed work environment.

As part of the Company's strategy to modernise a vertically integrated supply chain, we have entered an agreement for a commercial farming and collection hub with Fiji's most successful agricultural program, the Tutu Rural Training Centre. Established by the Society of Mary on Taveuni in 1969, the Tutu Rural Training Centre traces its origins to a Sydney monastery that ran a Marist Brothers training course for Pacific islanders and aims to equip young men and women with the skills required to excel as self-employed farmers and craftspeople in Cakaudrove, Fiji, and is seen as the most successful training program in Fiji, if not the Pacific. The farming and collection hub is based on Taveuni Island in Cakaudrove Province. The Company has identified key locations for establishing further regional collection hubs, including Koro Island, Kadavu and Vanu Levu.

The collaboration with Tutu is a tripartite project,

which forms part of a broader partnership with iTaukei Trust Fund Board (TTFB). iTaukei Trust Fund Board is an institution established under the iTaukei Trust Fund Act, for the purposes of fostering the advancement of the iTaukei (native Fijians) and Rotumans by promoting initiatives that will better their standard of living and enhance appropriate cultural traditions and values. This collaboration strengthens the Company's position in the Fijian community and underpins a commitment to support Fijian farmers.

The establishment of these collections hubs, results in streamlined logistics for the transportation and processing of Noble Fijian Kava, thereby improving efficiency and reducing costs through economies of scale.

The Company has now continued to increase its commercial farming network to include 12 key commercial farm supply agreements across Fiji. These now include commercial farming relationships in most provinces that grow kava in Fiji, which include Lomaiviti, Cakaudrove, Bua, Serua, Namosi, Kadavu, Ra and Naitasiri. In addition to this, the Company also continues to support supply relationships with subsistence farmers across the country and is currently working with the United Nations Capital Development Fund (UNCDF) and TTFB to establish rural collection and training centres in Nabouwalu, Bua and Koro island in the Lomaiviti group.

The digitisation of the Calmer Co's supply chain is an important differentiator as the Company continues

to expand its supply chain across Fiji and provide traceability and transparency of its products to its customers. The Company is working with Traceable Solutions in Fiji to complete the Supply Chain Digitisation project in FY24.

Expansion of Network Nutrition Partnership

The Company expanded our Strategic Partnership with Network Nutrition, part of Dutch multinational IMCD, which was appointed as the exclusive sales agent for B2B sales of our proprietary water extract of Noble Kava for the US ingredient market from October 2021. Our proprietary water extract of Noble Fijian kava is marketed under the brand Kavaton™ by Network Nutrition. Strong sales performance in the USA saw all available Kavaton™ Extract made available by Fiji Kava purchased over Q2 and Q3 of FY22 and saw the onboarding of major multinational nutraceutical clients. The exclusive marketing territories for Kavaton™ extract were expanded this year to now include Canada, Australia, New Zealand and the ASEAN regions.

The companies have continued to work together over the year on a number of R&D projects which have progressed significantly under IMCD's stewardship, and several beverage specific new projects have been outlined for the coming years, that will support the local manufacturing of The Calmer Co and Leilo drinks in key markets in the future. A new Fine Particle grade water extract and bulk Drinking Kava were added to the distribution contract in FY23 based on customer demand.

CJ Patel Distribution Partnership

The Calmer Co.'s wholly owned Fijian subsidiary, South Pacific Elixirs Pte Ltd entered into an exclusive agreement with CJ Patel (Pacific) Pte Ltd (CJ Patel) as its authorised distributor in seventeen countries. The agreement set out targets minimum sales of A\$11 million for over the initial three-year term of the agreement to maintain exclusivity. This represented an important step forward for professionalisation of the Company's kava marketing to the local Fiji market. This partnership complements the existing dominant position held by our FijiKava® brand in the tourist and resort channels through partnerships with Jacks of Fiji, Tappoo's and Motibhai.

As the largest FMCG distribution company in the South Pacific, CJ Patel is ideally suited to deliver comprehensive distribution, sales and marketing support to the Taki Mai brand and is now the exclusive and authorised distributor for the Taki Mai® range of products across seventeen countries. The CJ Patel Group is a diverse group of organisations across a variety of industries, all with the common goal of delivering world-class products and services. With their head office in Fiji, CJ Patel controls the operations of over 20 different companies across 10 countries, using a variety of business ownership models from joint ventures to wholly owned subsidiaries. They are an adaptable group, capable of changing models to best suit the needs of the business sector, industry regulations and environment in which they are operating.

CJ Patel has the distribution rights for world renowned

international brands in Fiji, and most of the Pacific.

The Company has its main warehouse in Wailekutu, Lami and sub-warehouses in Lautoka and Labasa ensuring comprehensive National Coverage. CJ Patel distributes its products to modern trade as well as utilising its extensive distribution network of retailers around Fiji. CJ Patel distributes renowned brands such as Sanitarium, Weet Bix, Panadol, Glaxo Smith Kline and household names such as Nescafe, Milo and Colgate throughout Fiji and around the South Pacific.

Taki Mai® is the brand in our portfolio with the most history and was the original brand brought to market in Fiji and in the USA by Zane Yoshida and the SPE team in 2015. The products including drinking kava and dietary shots had great uptake both in the USA and in Fiji, including into Wholefoods Market. The Taki Mai® instant kava products in Fiji have been continuously sold since 2015, and the range has recently been expanded to include a Traditional Grind and a new Low Key® product.

RooLife China Distribution Partnership

RooLife was appointed as exclusive distributor of the Fiji Kava® range of capsules and drinking kava products in China in an important step back into the Asia market for the Company. The contract also extended to future new products including dietary shots and new RTD products that are developed for the China market through eCommerce. Initially, RooLife's wholly owned subsidiary Choose Digital has taken over management of the Fiji Kava® product range online via www.fjikava.com in Australia as part

of preparation to enter the Chinese market to ensure price and positioning alignment.

The size of the opportunity is reflected in the performance rights granted to RooLife which vest on Sales of \$1m & \$2m AUD by 30 June 2026, \$5m & \$10m AUD by 30 June 2027 and \$15m AUD by 30 June 2028. Indeed, the execution on a China market entry strategy, supported by the appropriate restoration of global price architecture for the Fiji Kava® product range is a critical step to realising the potential of the Fiji Kava® brand globally. This approach will also ensure we have full alignment in marketing and positioning of our products in Australia and China to ensure success through cross-border eCommerce. RooLife has extensive experience in functional beverage sales and marketing in the China market, most recently achieving a retail trade launch for Australian brand Remedy Kombucha, after growing online sales since 2020.

Targeting the sports medicine market in China will be central to the strategy, with RooLife to co-market the Fiji Kava powdered drinking kava range alongside their VORA protein range in the lucrative online sports nutrition channel in China. The size of the opportunity compared to the local markets is immense with sports nutrition in China valued at over \$300m USD and dominated by eCommerce which accounts for more than 80% of sales.

The RooLife Group (ASX: RLG) provides fully integrated digital marketing and customer acquisition services, focusing on driving online sales of products and

services for its clients. RooLife provides personalised, real-time, targeted marketing. With a key focus on driving sales in Australia and China the Company's online e-Commerce marketplaces assist businesses to sell directly to Chinese consumers and accept payment via the WeChat and Alipay mobile payments platforms. RooLife's key positioning is about knowing and remaining connected with Chinese consumers, allowing brands to effectively sell products to Chinese Consumers based on their profiles and purchasing behaviours.

Global Distribution Partnership with Leilo Inc.

The Calmer Co. has entered into an agreement with Leilo Inc. for the rights to manufacture, market and distribute Leilo branded beverages in several international markets. In China & India, The Company has the rights to manufacture, distribute and market Leilo beverages. Across the Asia Pacific the Company will distribute and market Leilo beverages in the resort and tourist channels in Fiji Islands, in partnership with Jacks of Fiji. The Company also plans to distribute and market Leilo beverages in the Gulf States and believes that with import and marketing approvals in place that Leilo's range of Halal certified ready to drink (RTD) beverages will fill a recognised unmet need for truly functional relaxing beverages. In addition, we will have the rights to distribute Leilo beverages in Australia and New Zealand when regulatory approval for Kava based RTD products is granted in these markets.

Cost Saving Initiatives

The Company has undertaken a program of continuous and ongoing cost savings initiatives over the course of the full year, with operational savings for the year exceeding (\$1.12m) vs FY22. This has included the termination of several non-performing consultancy contracts, the removal of a middle management layer that included the Fiji General Manager and Managing Director USA. The Company also consolidated key subsidiary board roles with the appointment of two new Non-Executive Directors, Mr Tonkin in the USA and Mr Emose in Fiji. The Company has also come to the end of the two-year partnership agreement with Chemist Warehouse which included significant commitments to fund marketing activities. The Company may continue to distribute it's new products with Chemist Warehouse but will not continue with our capsule range or any new marketing commitments at the previous scale. The Company continues to focus on profitable sales channels.



6. Operating Results

The Company has shown a continuous improvement sales performance and a continuous reduction in operating expenses and net cash used in operations over the year. Importantly, Operating Loss (EBITDA net of adjustments and provisions) improved by 23% vs FY22 to \$4.2m vs \$5.5m in FY22 and the trend towards profitability was also demonstrated across the year where Operating Loss (EBITDA net of adjustments and provisions) improved by over 25% in H2 (\$1.8m) compared to H1 (\$2.4m) while the period saw sales rising by 33% (\$1.02m in H2 vs \$766k in H1). Gross Profit Margin for H2 was 45% vs 31% in H1 and improved for the full year from 30% in FY22 to 39% in FY23.

Total operating expenses were reduced by over \$1.12m vs FY22, representing a 18% reduction and again the trend in cost control also showed improvement in the second half of the year where operating expenses were reduced by 14% to \$2.31m vs \$2.69m in H1. The trend is demonstrated even more clearly via reduction of cash used in operating activities. This metric also fell sharply in the second half of the year with a reduction of 39% from \$2.05m in H1 to \$1.26m in H2. The difference between the operating cash flow and Operating Loss (EBITA net of adjustments and provisions) is mainly due to prepaid costs associated with the partnership agreement with Chemist Warehouse, and these costs will not recur.

Building on the strong commitment to profitable sales and cost control the Company delivered record quarterly revenue for the final quarter of year of \$690k, an 71% increase on the prior quarter. This result reflects annualised revenue of \$2.76m, as we move into the coming year. Cash receipts from customers also rose in the final quarter to \$630k, while the continued focus on cost reductions saw net cashflow used in operations fall by 20% to \$561k, the lowest level since listing on the ASX. The Q4 results reflect an operating business that has healthier margins and with lower operating costs than ever before, and which is now growing sales strongly following a year of transformational change.

The Board determines the proportion of fixed and variable compensation for each KMP.

Director's fees are reviewed annually by the Board. No termination payments are payable to Non-Executive Directors.

In accordance with best practice corporate governance, the structure of Non-Executive Director and senior management remuneration is separate and distinct.

a. Fixed Remuneration

Fixed remuneration for the Group's executive officers consists of base cash remuneration and statutory superannuation entitlements. Longer term discretionary remuneration consists of share option grants. Remuneration levels are based on an overall assessment of both individual and Group performance.

The Group believes that encouraging its executives and employees to become shareholders is the best way of aligning their interest to those of its shareholders. In addition, equity participation is a cost effective and efficient incentive as compared to cash bonuses or increased remuneration, particularly given the Group's pre-production status. Accordingly, all executives and employees are entitled to participate in the Group's equity incentive scheme. Generally, the ability to exercise an option is conditional upon the holder remaining in the Group's employment. There are presently no other non-cash benefits available to Directors or employees. There is no separate profit-sharing or bonus plan.

b. Performance Based Remuneration – Short-Term and Long-Term Incentive Structure

The Board will review executive packages annually by reference to the Group's performance and executive performance and comparable information from industry sectors using independent external advice where appropriate.

c. Service Contracts

The contracts for service between the Group and Directors and executives are on a continuing basis, the terms of which are not expected to change in the immediate future. Upon retirement, Directors and executives are paid employee benefit entitlements accrued to date of retirement. The Group may terminate the contracts without cause by providing one month's written notice. Termination payments (if applicable) are generally not payable on resignation or dismissal for serious misconduct. In the instance of serious misconduct, the Group can terminate employment at any time.

d. Non-executive Directors

The Board seeks to set aggregate remuneration at a level which provides the Group with the ability to attract and retain Directors of the highest calibre, whilst incurring a cost which is acceptable to shareholders.

The Constitution and the ASX Listing Rules specify that the aggregate remuneration of Non-Executive Directors shall be determined from time to time by a general meeting. An amount not exceeding the amount determined is then divided between the Directors as agreed.

The amount of aggregate remuneration sought to be approved by shareholders and the manner in which it is apportioned amongst Directors is reviewed annually. The Board considers advice from external consultants as well as the fees paid to Non-Executive Directors of comparable companies when undertaking the annual review process.

Each Non-Executive Director receives a fee for being a Director of the Group. No additional fees are paid for participation on subcommittees, such as the Audit Committee. Non-Executive Directors are encouraged by the Board to hold shares in the Group. Accordingly, they are entitled to participate in equity incentive schemes if offered by the Group.

Total fees for the non-executive Directors for the financial year were \$53,916 (FY22: \$129,436).

NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

FOR THE YEAR ENDED 30 JUNE 2023

GENERAL INFORMATION

The Calmer Co. International Limited (**Calmer Co.** or the “**Company**”) is a for-profit company limited by shares, domiciled and incorporated in Australia whose shares are publicly traded on the Australian Securities Exchange (ASX). The financial statements are presented in the Australian currency.

The nature of operations and principal activities of the Company are described in the Directors’ Report.

1. Basis of Preparation

The consolidated financial statements of The Calmer Co. International Limited (the “Company”) and its controlled entities (“Calmer Co.” or the “Group”) for the year ended 30 June 2023, represent a general purpose financial report prepared in accordance the Corporations Act 2001, Australian Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board. The financial report has also been prepared on the historical cost basis. The financial report complies with Australian Accounting Standards and International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board.

2. Functional and Presentation Currency

These consolidated financial statements are presented in Australian dollars which is the Company’s functional currency. The Group is of a kind referred to in **ASIC Corporations (Rounding in Financial/Directors’ Reports) Instrument 2016/191** and in accordance with that instrument, amounts in the consolidated financial statements and Directors’ report have been rounded off to the nearest dollar, unless otherwise stated.

3. Use of Judgements and Estimates

In preparing these consolidated financial statements, management has made judgements and estimates that affect the application of the Group’s accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to estimates are recognised prospectively.

Assumptions and estimation uncertainties

Information about assumptions and estimation uncertainties at 30 June 2023 that have a significant risk of resulting in a material adjustment to the carrying amounts of assets and liabilities in the next financial year is outlined below:

Calculation of loss allowance

When measuring expected credit losses (“ECL”) the Group uses reasonable and supportable forward-looking information, which is based on assumptions for the future movement of different economic drivers and how these drivers will affect each other. Loss given default is an estimate of the loss arising on default. It is based on the difference between the contractual cash flows due and those that the lender would expect to receive, taking into account cash flows from collateral and integral credit enhancements. Probability of default constitutes a key input in measuring ECL. Probability of default is an estimate of the likelihood of default over a given time horizon, the calculation of which includes historical data, assumptions and expectations of future conditions.

Inventory Costing

Inventories mainly consist of Kava products (capsules and powder) and are measured at standard cost. A standard cost system determines inventory unit cost based on certain reasonable historical or expected cost, which are based on management’s industry experience and expertise. Costs are assigned to individual items

of stock on the basis of the direct materials, direct labour and direct overhead. Adequate provision has been made for slow moving and obsolete inventories.

Measurement at Fair Values

A number of the Group's accounting policies and disclosures require the measurement of fair values, for both financial and non-financial assets and liabilities.

The Group has an established control framework with respect to the measurement of fair values. This includes a valuation team that has overall responsibility for overseeing all significant fair value measurements, including Level 3 fair values, and reports directly to the chief financial officer.

The valuation team regularly reviews significant unobservable inputs and valuation adjustments. If third party information, such as broker quotes or pricing services, is used to measure fair values, then the valuation team assesses the evidence obtained from the third parties to support the conclusion that these valuations meet the requirements of the Standards, including the level in the fair value hierarchy in which the valuations should be classified.

Significant valuation issues are reported to the Group's audit committee.

When measuring the fair value of an asset or a liability, the Group uses observable market data as far as possible. Fair values are categorised into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows:

- Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).
- Level 3: inputs for the asset or liability that are not based on observable market data (unobservable inputs).

If the inputs used to measure the fair value of an asset or a liability fall into different levels of the fair value hierarchy, then the fair value measurement is categorised in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement.

The Group recognises transfers between levels of the fair value hierarchy at the end of the reporting period during which the change has occurred.

Further information about the assumptions made in measuring fair values is included in the following notes:

- Note 14 – share-based payment arrangements;
- Note 31 – financial instruments; and
- Note 33 – acquisition of subsidiary.

4. Changes in Significant Accounting Policies

The Group has not adopted any significant new accounting policies.

5. Significant Accounting Policies

The Group has consistently applied the following accounting policies to all periods presented in these consolidated financial statements, except if mentioned otherwise.

5.1. Consolidation

5.1.1. Business combination under common control (BCUCC)

BCUCCs are outside the scope of AASB 3 – Business Combinations when the same group of individuals has, as a result of contractual arrangements, ultimate collective power to govern the financial and operating policies of each of the combining entities so as to obtain benefits from their activities, and that ultimate collective power is not transitory.

The Group accounts for BCUCC transactions as follows:

- The assets and liabilities of the acquire are recognised at their previous carrying amounts;
- No adjustments are made to reflect the fair values and no new assets and liabilities of the acquire are recognised at the date of the business combination;
- No new goodwill is recognised; and
- Any difference between the acquired net assets and the consideration is recognised directly in equity in the business combination reserve.

5.1.2. Subsidiaries

Subsidiaries are entities controlled by the Company. The Company controls an entity when the Company is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. In assessing control, potential voting rights that presently are exercisable or convertible are taken into account. The financial statements of subsidiaries are included in the consolidated financial statements from the date that control commences until the date that control ceases.

5.1.3. Interests in equity-accounted investees

The Group's interests in equity-accounted investees comprise interests in associates. Associates are those entities in which the Group has significant influence, but not control or joint control, over the financial and operating policies.

Interests in associates and the joint venture are accounted for using the equity method. They are initially recognised at cost, which includes transaction costs. Subsequent to initial recognition, the consolidated financial statements include the Group's share of the profit or loss and OCI of equity-accounted investees, until the date on which significant influence or joint control ceases.

5.1.4. Transactions eliminated on consolidation

Intra-group balances and transactions, and any unrealised income and expenses (except for foreign currency transaction gains or losses) arising from intra-group transactions, are eliminated. Unrealised gains arising from transactions with equity-accounted investees are eliminated against the investment to the extent of the Group's interest in the investee. Unrealised losses are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

5.2. Foreign Currency

5.2.1. Foreign currency transactions

Transactions in foreign currencies are translated into the respective functional currencies of Group companies at the exchange rates at the end of the month of the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the exchange rate at the reporting date. Non-monetary assets and liabilities that are measured at fair value in a foreign currency are translated into the functional currency at the exchange rate when the fair value was determined. Non-monetary items that are measured based on historical cost in a foreign currency are translated at the exchange rate at the date of the transaction. Foreign currency differences arising on translation are generally recognised in profit or loss and presented within finance costs.

5.2.2. Foreign operations

The assets and liabilities of foreign operations are translated into Australian dollars at the exchange rates at the reporting date. The income and expenses of foreign operations are translated into Australian dollars at the exchange rates at the dates of the transactions. Foreign exchange differences on translation are recognised as a separate component of equity.

Exchange differences arising from the translation of the net investment in foreign operations are taken to translation reserve. They are recognised in the Statement of Profit or Loss and Other Comprehensive Income upon disposal.

5.3. Employee Benefits

5.3.1. Short-term employee benefits

Short-term employee benefits are expensed as the related service is provided. A liability is recognised for the amount expected to be paid if the Group has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

5.3.2. Share-based payment arrangements

The grant-date fair value of equity-settled share-based payment arrangements granted to employees is generally recognised as an expense, with a corresponding increase in equity, over the vesting period of the awards. The amount recognised as an expense is adjusted to reflect the number of awards for which the related service and non-market performance conditions are expected to be met, such that the amount ultimately recognised is based on the number of awards that meet the related service and non-market performance conditions at the vesting date. For share-based payment awards with non-vesting conditions, the grant-date fair value of the share-based payment is measured to reflect such conditions and there is no true-up for differences between expected and actual outcomes.

5.3.3. Defined contribution plans

Obligations for contributions to defined contribution plans are expensed as the related service is provided.

5.3.4. Other long-term employee benefits

The Group's net obligation in respect of long-term employee benefits is the amount of future benefit that employees have earned in return for their service in the current and prior periods.

5.4. Government Grants

The Group recognises an unconditional government grant related to a biological asset in profit or loss as other income when the grant becomes receivable. Other government grants are initially recognised as deferred income at fair value if there is reasonable assurance that they will be received, and the Group will comply with the conditions associated with the grant; they are then recognised in profit or loss.

Grants that compensate the Group for expenses incurred are recognised in profit or loss on a systematic basis in the periods in which the expenses are recognised, unless the conditions for receiving the grant are met after the related expenses have been recognised. In this case, the grant is recognised when it becomes receivable.

5.5. Finance Income and Finance Costs

The Group's finance income and finance costs include:

- interest income;
- interest expense;
- the net gain or loss on financial assets at FVTPL; and
- the foreign currency gain or loss on financial assets and financial liabilities;

Interest income or expense is recognised using the effective interest method. The 'effective interest rate' is the rate that exactly discounts estimated future cash payments or receipts through the expected life of the financial instrument to:

- the gross carrying amount of the financial asset; or
- the amortised cost of the financial liability.

In calculating interest income and expense, the effective interest rate is applied to the gross carrying amount of the asset (when the asset is not credit-impaired) or to the amortised cost of the liability. However, for financial assets that have become credit-impaired subsequent to initial recognition, interest income is calculated by applying the effective interest rate to the amortised cost of the financial asset. If the asset is no longer credit-impaired, then the calculation of interest income reverts to the gross basis.

5.6. Revenue

5.6.1. Sale of goods

Revenue is measured based on the consideration specified in a contract with a customer and excluded any amounts collected on behalf of third parties. The Group recognises revenue when it satisfies a performance obligation by transferring control over a product to a customer. Revenue from the sale of investments property is recognised at a point in time when control of the asset is transferred which is on delivery of the goods.

5.6.2. Interest revenue

Interest revenue is recognised as it accrues, taking into account the effective yield on the financial asset.

5.7. Borrowing Costs

Borrowing costs comprise interest payable on borrowings calculated using the effective interest method, interest receivable on funds invested, dividend income and foreign exchange gains and losses. Borrowing costs are expenses as incurred and included in financing costs.

5.8. Income Tax

Income tax on the Statement of Profit or Loss and Other Comprehensive Income for the period comprises current and deferred tax. Income tax is recognised in the Statement of Profit or Loss and Other Comprehensive Income except to the extent that it relates to items recognised directly in equity, in which case it is recognised in equity.

Current tax is the expected tax payable on the taxable income for the period, using tax rates enacted or substantively enacted at the reporting date, and any adjustment to tax payable in respect of previous periods.

Deferred tax is provided using the liability method, providing for temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Temporary differences arising from the initial recognition of goodwill, the initial recognition of assets or liabilities that affect neither accounting nor taxable profit, and differences relating to investments in subsidiaries to the extent that they will probably not reverse in the foreseeable future, are not provided for.

The amount of deferred tax provided is based on the expected manner of realisation or settlement of the carrying amount of assets and liabilities, using tax rates enacted or substantively enacted at the reporting date. A deferred tax asset is recognised only to the extent that it is probable that future taxable profits will be available against which the asset can be utilised. Deferred tax assets are reduced to the extent that it is no longer probable that the related tax benefit will be realised.

5.9. Goods and Services Tax and Value added Tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the local legislative taxation office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense. The same treatment is applied to equivalent taxes in other jurisdictions including VAT. Receivables and payables are stated with the amount of GST/VAT included. The net amount of GST/VAT recoverable from, or payable to the local legislative taxation office is included as a current asset or liability in the Statement of Financial Position.

Cash flows are included in the statement of cash flows on a gross basis. The GST/VAT components of cash flows arising from investing and financing activities which are recoverable from, or payable to the local legislative taxation office are classified as operating cash flows.

5.10. Inventories

Inventories consist mainly of kava products (capsules and powder) and are measured at the lower of cost and net realisable value. Costs are assigned to individual items of stock on the basis of the landed Director cost, insurance, freight, and an allocation of overhead expenditure, the latter being allocated on the basis of labour incurred. Adequate provision has been made for slow moving and obsolete inventories.

5.11. Property, Plant and Equipment

5.11.1. Recognition and measurement

Items of property, plant and equipment are measured at cost less accumulated depreciation and any accumulated impairment losses.

If significant parts of an item of property, plant and equipment have different useful lives, then they are accounted for as separate items (major components) of property, plant and equipment.

Any gain or loss on disposal of an item of property, plant and equipment is recognised in profit or loss.

5.11.2. Depreciation

Depreciation is calculated to write off the cost of items of property, plant and equipment using the straight-line method over their estimated useful lives and is generally recognised in profit or loss. Land is not depreciated.

The depreciation rates used for each class of asset are as follows:

— Buildings	1.25%
— Greenhouse	1.25%
— Plant and equipment	10.0%
— Motor vehicles	12.0%
— Furniture and fittings	15.0%

Assets are depreciated or amortised from the date of acquisition or, in respect of internally generated assets, from the time an asset is completed and held ready for use. Depreciation and amortisation rates and methods are reviewed annually for appropriateness. When changes are made, adjustments are reflected prospectively in current and future periods only.

5.12. Intangible Assets

5.12.1. Recognition and measurement

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation and any accumulated impairment losses. Expenditure on internally generated intangibles and brands is recognised in the Statement of Profit or Loss and Other Comprehensive income as an expense as incurred. Subsequent expenditure is capitalised only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure is recognised in profit or loss as incurred. Intangible assets are deemed to have an indefinite useful life are systematically tested for impairment at each reporting date.

Website costs are charged as expenses when they are incurred unless they relate to the acquisition or development of an asset when they may be capitalised or amortised. Generally, costs in relation to feasibility studies during the planning phase of a website, and ongoing costs of maintenance during the operating phase are expensed. Costs incurred in building or enhancing a website, to the extent that they represent probable future economic benefits that can be reliably measured, are capitalised.

The Group has capitalised a portion of directly attributable development costs of new products. The costs are capitalised only when technical feasibility of new product is demonstrated, and the Group has an intention and ability to complete and use the products and the costs can be measured reliably. Such costs include purchase of materials and services and payroll related costs of employees directly involved in the product development. Research costs are recognised as an expense when incurred.

5.12.2. Amortisation

Amortisation is calculated to write off the cost of intangible assets less their estimated residual values using the straight-line method and is generally recognised in profit or loss.

The estimated useful lives for current and comparative periods are as follows:

— Trademark costs 10 years (2022: 10 years)

5.13. Financial Instruments

Financial Instruments – Assets

a. Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through OCI or through profit or loss), and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income (FVOCI).

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

b. Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

c. Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss (FVTPL), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVTPL are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

i. Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

- **Amortised cost:** Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of profit or loss.
- **FVOCI:** Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest income and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest rate method. Foreign exchange gains and losses are presented in other

gains/(losses) and impairment expenses are presented as separate line item in the statement of profit or loss.

- FVTPL: Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVTPL. A gain or loss on a debt investment that is subsequently measured at FVTPL is recognised in profit or loss and presented net within other gains/(losses) in the period in which it arises.

ii. Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in OCI, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at FVTPL are recognised in other gains/(losses) in the statement of profit or loss as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

d. Impairment

The Group assesses on a forward-looking basis, the expected credit losses associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by AASB 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

Financial Instruments – Liabilities

a. Classification

The Group classifies its financial liabilities in the following measurement categories:

- those to be measured subsequently at FVTPL, and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial liabilities and the contractual terms of the cash flows.

For financial liabilities measured at FVTPL, gains and losses, including any interest expenses will be recorded in profit or loss. Other financial liabilities are subsequently measured at amortised cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognised in profit or loss. Any gain or loss on derecognition is also recognised in profit or loss.

For financial liabilities measured at amortised cost, the effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the amortised cost of a financial liability.

b. Recognition and derecognition

Regular way purchases of financial liabilities are recognised on trade-date, the date on which the Group commits to purchase the financial liability. Financial liabilities are derecognised when the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liabilities derecognised and the consideration paid and payable is recognised in profit or loss.

c. Measurement

At initial recognition, the Group measures financial liabilities at its fair value plus, in the case of financial liabilities not at fair value through profit or loss (FVTPL), transaction costs that are directly attributable to the acquisition of the financial liabilities. Transaction costs of financial liabilities carried at FVTPL are expensed in profit or loss.

5.14. Share Capital

Ordinary shares

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds. Incremental costs directly attributable to the issue of new shares or options for the acquisition of a business are not included in the cost of the acquisition as part of the purchase consideration.

Reacquisition of ordinary shares

If the entity reacquires its own equity instruments, there is no gain or loss recognised in the Statement of Profit or Loss and Other Comprehensive Income, the instruments are cancelled and deducted from equity, and the consideration paid (net of income tax) is recognised directly in equity.

5.15. Compound Financial Instruments

Compound financial instruments issued by the Group comprise convertible notes denominated in Australian dollars that can be converted to ordinary shares at the option of the holder, when the number of shares to be issued is fixed and does not vary with changes in fair value.

The liability component of compound financial instruments is initially recognised at the fair value of a similar liability that does not have an equity conversion option. The equity component is initially recognised at the difference between the fair value of the compound financial instrument as a whole and the fair value of the liability component. Any directly attributable transaction costs are allocated to the liability and equity components in proportion to their initial carrying amounts.

Subsequent to initial recognition, the liability component of a compound financial instrument is measured at amortised cost using the effective interest method. The equity component of a compound financial instrument is not remeasured.

Interest related to the financial liability is recognised in profit or loss. On conversion at maturity, the financial liability is reclassified to equity and no gain or loss is recognised.

5.16. Impairment

Non-derivative financial assets

Financial instruments and contract assets

The Group recognises loss allowances for expected credit losses ("ECLs") on:

- financial assets measured at amortised cost;
- debt investments measured at FVOCI; and
- contract assets.

The Group measures loss allowances at an amount equal to lifetime ECLs.

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECLs.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the Group's historical experience and informed credit assessment, that includes forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when:

- the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to actions such as realising security (if any is held); or

- the financial asset is more than 90 days past due.

Lifetime ECLs are the ECLs that result from all possible default events over the expected life of a financial instrument. 12-month ECLs are the portion of ECLs that result from default events that are possible within the 12 months after the reporting date (or a shorter period if the expected life of the instrument is less than 12 months).

The maximum period considered when estimating ECLs is the maximum contractual period over which the Group is exposed to credit risk.

Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all cash shortfalls (i.e. the difference between the cash flows due to the entity in accordance with the contract and the cash flows that the Group expects to receive).

ECLs are discounted at the effective interest rate of the financial asset.

Credit-impaired financial assets

At each reporting date, the Group assesses whether financial assets carried at amortised cost and debt securities at FVOCI are credit impaired. A financial asset is 'credit-impaired' when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Evidence that a financial asset is credit-impaired includes the following observable data:

- significant financial difficulty of the debtor;
- a breach of contract such as a default or being more than 90 days past due;
- the restructuring of a loan or advance by the Group on terms that the Group would not consider otherwise;
- it is probable that the debtor will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for a security because of financial difficulties.

Presentation of allowance for ECL in the statement of financial position

Loss allowances for financial assets measured at amortised cost are deducted from the gross carrying amount of the assets.

For debt securities at FVOCI, the loss allowance is charged to profit or loss and is recognised in OCI.

Write-off

The gross carrying amount of a financial asset is written off when the Group has no reasonable expectations of recovering a financial asset in its entirety or a portion thereof. For individual customers, the Group has a policy of writing off the gross carrying amount when the financial asset is 180 days past due based on historical experience of recoveries of similar assets. For corporate customers, the Group individually makes an assessment with respect to the timing and amount of write-off based on whether there is a reasonable expectation of recovery. The Group expects no significant recovery from the amount written off. However, financial assets that are written off could still be subject to enforcement activities in order to comply with the Group's procedures for recovery of amounts due.

Non-financial assets

The Group assesses, at each reporting date, whether there is an indication that an asset may be impaired. If any indication exists, or when annual impairment testing for an asset is required, the Group estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or cash-generating unit's (CGU's) fair value less costs of disposal and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. When the carrying amount of an asset or CGU exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transactions are taken into account. If no such transactions can be identified, an appropriate valuation model is used. These calculations are corroborated by valuation multiples, quoted share prices for publicly traded companies or other available fair value indicators.

Impairment losses of continuing operations, including impairment on inventories, are recognised in the statement of profit or loss in expense categories consistent with the function of the impaired asset, except for properties

previously revalued with the revaluation taken to OCI. For such properties, the impairment is recognised in OCI up to the amount of any previous revaluation.

For assets excluding goodwill, an assessment is made at each reporting date to determine whether there is an indication that previously recognised impairment losses no longer exist or have decreased. If such indication exists, the Group estimates the asset's or CGU's recoverable amount. A previously recognised impairment loss is reversed only if there has been a change in the assumptions used to determine the asset's recoverable amount since the last impairment loss was recognised. The reversal is limited so that the carrying amount of the asset does not exceed its recoverable amount, nor exceed the carrying amount that would have been determined, net of depreciation, had no impairment loss been recognised for the asset in prior years. Such reversal is recognised in the statement of profit or loss unless the asset is carried at a revalued amount, in which case, the reversal is treated as a revaluation increase.

5.17. Provisions

A provision is recognised in the Statement of Financial Position when the Group has a present legal or constructive obligation as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and, where appropriate, the risks specific to the liability.

5.18. Leases

As a lessee

At inception of a contract, the Group assesses whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

The Group recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred.

Right-of-use assets are depreciated over the lease term or useful life of the underlying asset whichever is the shortest. Where a lease transfers ownership of the underlying asset or the cost of the right-of-use asset reflects that the Group anticipates to exercise a purchase option, the specific asset is depreciated over the useful life of the underlying asset.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate. Generally, the Group uses the incremental borrowing rate as the discount rate.

The Group determines its incremental borrowing rate by obtaining interest rates from various external financing sources and makes certain adjustments to reflect the terms of the lease and type of the asset leased.

Lease payments included in the measurement of the lease liability comprise the following:

- fixed payments less lease incentives;
- variable lease payments that depend on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable under a residual value guarantee; and
- the exercise price under a purchase option that the Group is reasonably certain to exercise, lease payments in an optional renewal period if the Group is reasonably certain to exercise an extension option, and penalties for early termination of a lease unless the Group is reasonably certain not to terminate early.

The lease liability is measured at amortised cost using the effective interest method. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, if there is a change in the Group's

estimate of the amount expected to be payable under a residual value guarantee, if the Group changes its assessment of whether it will exercise a purchase, extension or termination option or if there is a revised in-substance fixed lease payment.

When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

Short-term leases and leases of low-value assets

The Group has elected not to recognise right-of-use assets and lease liabilities for leases of low-value assets and short-term leases, including IT equipment. The Group recognises the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

As a lessor

At inception or on modification of a contract that contains a lease component, the Group allocates the consideration in the contract to each lease component on the basis of their relative stand-alone prices.

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease.

To classify each lease, the Group makes an overall assessment of whether the lease transfers substantially all of the risks and rewards incidental to ownership of the underlying asset. If this is the case, then the lease is a finance lease; if not, then it is an operating lease. As part of this assessment, the Group considers certain indicators such as whether the lease is for the major part of the economic life of the asset.

When the Group is an intermediate lessor, it accounts for its interests in the head lease and the sub-lease separately. It assesses the lease classification of a sub-lease with reference to the right-of-use asset arising from the head lease, not with reference to the underlying asset. If a head lease is a short-term lease to which the Group applies the exemption described above, then it classifies the sub-lease as an operating lease.

If an arrangement contains lease and non-lease components, then the Group applies IFRS 15 to allocate the consideration in the contract.

The Group applies the derecognition and impairment requirements in IFRS 9 to the net investment in the lease. The Group further regularly reviews estimated unguaranteed residual values used in calculating the gross investment in the lease.

The Group recognises lease payments received under operating leases as income on a straight-line basis over the lease term as part of 'other revenue'.

5.19. Fair Value Measurement

'Fair value' is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date in the principal or, in its absence, the most advantageous market to which the Group has access at that date. The fair value of a liability reflects its non-performance risk.

A number of the Group's accounting policies and disclosures require the measurement of fair values, for both financial and non-financial assets and liabilities.

When one is available, the Group measures the fair value of an instrument using the quoted price in an active market for that instrument. A market is regarded as 'active' if transactions for the asset or liability take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

If there is no quoted price in an active market, then the Group uses valuation techniques that maximise the use of relevant observable inputs and minimise the use of unobservable inputs. The chosen valuation technique incorporates all the factors that market participants would take into account in pricing a transaction.

If an asset or a liability measured at fair value has a bid price and an ask price, then the Group measures assets and long positions at a bid price and liabilities and short positions at an ask price.

The best evidence of the fair value of a financial instrument on initial recognition is normally the transaction price – i.e. the fair value of the consideration given or received. If the Group determines that the fair value on initial recognition differs from the transaction price and the fair value is evidenced neither by a quoted price in an active market for an identical asset or liability nor based on a valuation technique for which any unobservable inputs are judged to be insignificant in relation to the measurement, then the financial instrument is initially measured at fair value, adjusted to defer the difference between the fair value on initial recognition and the transaction price. Subsequently, that difference is recognised in profit or loss on an appropriate basis over the life of the instrument but no later than when the valuation is wholly supported by observable market data or the transaction is closed out.

6. New accounting standards and interpretations

Certain new accounting standards and interpretations have been published that are not mandatory for 30 June 2023 reporting periods and have not been early adopted by the group. These standards are not expected to have a material impact on the entity in the current or future reporting periods and on foreseeable future transactions.

7. Segment Reporting

Basis for operating segments

The Group has adopted AASB 8 Operating Segments whereby segment information is presented using a 'management approach', i.e. segment information is provided on the same basis as information used for internal reporting purposes by the Board of Directors. At regular intervals, the board is provided with management information at a group level for the Group's cash position and a Group cash forecast for the next twelve months of operation.

The Group has the following four reportable segments namely South Pacific Elixirs Pty Limited ("SPE Fiji"), Fiji Kava Inc (USA), Danodan Hempworks LLC (USA) and Fiji Kava Australia Trading Pty Ltd ("Fiji Kava Australia Trading"). These reportable segments operate in three different geographical areas.

The following summary describes the operations of each reportable segment.

These reporting segments have not changed from the 2022 financial year.

There are varying levels of integration between the reporting segments. This integration includes transfers of raw materials and shared distribution services, respectively. Inter-segment pricing is determined on an arm's length basis.

Information related to each reportable segment and all other segments is set out below. Segment profit (loss) before tax is used to measure performance because management believes that this information is the most

relevant in evaluating the results of the respective segments relative to other entities that operate in the same industries.

8. Disposal Group Held for Sale

The Group does not currently have any disposal group held for sale.

9. Going Concern

The Financial Report has been prepared on the going concern basis that contemplates the continuity of normal business activities and the realisation of assets and extinguishment of liabilities in the ordinary course of business. During the financial year, the Group made a loss before tax of \$5,241,884 (2022: loss of \$5,916,235) and has

accumulated losses of \$25,555,646. As at 30 June 2023, the Group held a net current liability position of (\$622,672) including a cash position of \$462,151. Based on the Group's cash flow forecast, management expects the net current asset position will provide approximately 4 months of funding, without including the benefit of continued revenue improvement which is expected to increase during FY 2024.

The Group's cash flow forecast shows that despite the projected growth in sales, it is likely that the Group will need to access additional working capital in the next few months to support and implement the Group's goals and objectives. The directors are confident that the Group will be successful in raising additional funds through the issue of new equity and/or debt as they have been successful in raising equity in previous periods.

Based on these facts, the directors consider the going concern basis of preparation to be appropriate for this financial report. Should the Group be unsuccessful in raising additional funds through the issue of new equity, there is a material uncertainty which may cast significant doubt whether the Group will be able to continue as a going concern and therefore, whether it will realise its assets and extinguish its liabilities in the normal course of business and at the amounts stated in the financial report.

The financial statements do not include any adjustments relative to the recoverability and classification of recorded asset amounts or to the amounts and classification of liabilities that might be necessary should the Group not continue as a Going Concern.

10. Revenue

10.1. Revenue streams

The Group generates revenue primarily from the sale of Kava products to its customers. Other sources of revenue include rental income from an owned investment property (for a further split see note 11 below).

Specific Financial Risk Exposures and Management

The main risk the Group is exposed to through its financial instruments are credit risk, liquidity risk and market risk consisting of interest rate, foreign currency risk and equity price risk.

The Board of Directors has overall responsibility for the establishment and oversight of the risk management framework. The Board adopts practices designed to identify significant areas of business risk and to effectively manage those risks in accordance with the Group's risk profile. This includes assessing, monitoring and managing risks for the Group and setting appropriate risk limits and controls. The Group is not of a size nor is its affairs of such complexity to justify the establishment of a formal system for risk management and associated controls. Instead, the Board approves all expenditure, is intimately acquainted with all operations and discuss all relevant issues at the Board meetings. The operational and other compliance risk management have also been assessed and found to be operating efficiently and effectively.

Credit Risk

Credit risk is the risk of financial loss to the Group if a customer or counterparty to a financial instrument fails to meet its contractual obligations and arises principally from the Group's receivables from customers and investments in debt securities.

Credit risk exposures

The Group does not have any material credit risk exposure to any single receivable or group of receivables under financial instruments entered into by the Group.

The maximum exposure to credit risk is that to its alliance partners and that is limited to the carrying amount, net of any provisions for impairment of those assets, as disclosed in the statement of financial position and notes to the financial statements.

Credit risk related to balances with banks and other financial institutions is managed by the Group in accordance with approved Board policy. Such policy requires that surplus funds are only invested with financial institutions residing in Australia, where-ever possible.

Impairment losses

The Group has recognised \$26,203 (2022: \$nil) impairment expense in relation to trade receivables in the current year.

Liquidity Risk

Liquidity risk arises from the possibility that the Group might encounter difficulty in settling its debts or otherwise meeting its obligations related to financial liabilities. The Group's objective when managing liquidity is to ensure, as far as possible, that it will have sufficient liquidity to meet its liabilities when they are due, under both normal and stressed conditions, without incurring unacceptable losses or risking damage to the Group's reputation.

The Board of Directors constantly monitor the state of equity markets in conjunction with the Group's current and future funding requirements, with a view to initiating appropriate capital raisings as required. Any surplus funds are invested with major financial institutions.

Report on the Audit of the Financial Report

Opinion

We have audited the accompanying financial report of Calmer Co. International Limited and controlled entities (the Group), which comprises the consolidated statement of financial position as at 30 June 2023, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity, and the consolidated statement of cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies, and the directors' declaration.

In our opinion the accompanying financial report of the Group is in accordance with the *Corporations Act 2001*, including:

Basis for Opinion

Material Uncertainty Related to Going Concern

We draw attention to Note 9 of the financial statements which indicates that the Group incurred a loss before tax of \$5,241,884, has accumulated losses of \$25,555,646 and held a net current liability position of \$622,672. As stated in Note 9, these events or conditions, along with other matters set forth in Note 9, indicate that a material uncertainty exists that may cast significant doubt on the Company's ability to continue as a going concern. Our opinion is not modified in respect of this matter.

Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the financial report for the year ended 30 June 2023. These matters were addressed in the context of our audit of the financial report as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

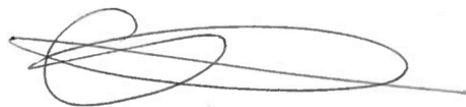
