Letter from the Managing Director

Dear shareholders,

It is my pleasure to present to you the Australasian Metals Limited (Australasian or the Company) Annual Report for the financial year ended 30 June 2023 (FY2023). This year has been one of steady progress, with a focus on adding value to our extensive portfolio of highly prospective projects in the Northern Territory and Queensland. While it has been a challenging year for many junior mining explorers, we have remained focused on adding value for shareholders and delivering meaningful exploration results.

Within our gold portfolio, we are very pleased to have delivered a maiden Inferred Mineral Resource estimate (2012 JORC Code & Guidelines) for the Ayres Rock and the Retro Extended deposits situated within Capella and Mt Clermont Gold Projects in the Anakie Province of the Drummond Basin, Queensland. The combined Mineral Resource estimate amounts to 63,600 ounces of gold at a grade of 1.13 g/t. We are confident that with further exploration activity in the coming year, we will be able to add more ounces to grow this resource into a more meaningful scale.

We continue to advance our lithium exploration assets within the booming global lithium sector. Our Mt Peake project (100%) and Barrow Creek project (90%) are located in the Anningie Tin-Tantalum pegmatite fields in the north Arunta Region of the Northern Territory, approximately 250km north of Alice Springs. Together, the projects amount to one of the largest lithium-focused exploration packages in Australia, covering approximately 1500 km². During the year, we have significantly advanced our geological understanding of the two projects, and in the coming months, we will conduct our first drilling campaign at the Mt Peake lithium project. We are looking forward to testing various targets in a region that has never been systematically explored for lithium mineralisation.

In May 2023, we also expanded our portfolio by entering into an agreement to acquire 100% of the May Queen South Bauxite project. The project is located in central Queensland, within a short trucking distance of a rail system leading north to the Port of Bundaberg. It is also located within close proximity to the main Queensland Rail network heading south towards the Port of Brisbane. The Project has a JORC 2012 Inferred Mineral Resource estimate of 54.9Mt at 37.5% total Al₂O₃% and 5.2% TiO₂ and 7.9% Rx SiO₂%. Field investigation and surface rock chip sampling have already identified high-grade potential with samples of up to 17.55% TiO₂. The high-grade titanium zone will be further evaluated with shallow drilling.

Innovation remains a priority for the Australasian team, and we are especially proud of our founding participation in a joint research program with the Centre for Exploration Targeting (CET) of the University of Western Australia (UWA), covering the Northern Arunta pegmatite province in the Northern Territory. The program is co-funded by Core Lithium Limited, Oceana Lithium Limited, Askari Minerals Limited, and Lithium Spring Limited, all of which have been actively exploring for lithium-related minerals in the North Arunta Pegmatite district. Detailed mineralogical and mineral chemistry investigations on Li-bearing and pathfinder minerals will be undertaken, allowing for robust and cost-effective exploration targeting for fertile (in terms of lithium, tantalum, and potentially rare earth elements) granites.

With close to \$4.0 million in cash and no debt, the Company is well positioned to develop and expand its highly prospective lithium, gold, and base metals portfolio in the financial year 2024 and beyond.

Directors' Report

The directors present their report on the consolidated entity (referred to herein as the “the Group”, or “consolidated entity”) consisting of Australasian Metals Limited (“the Company” or “Australasian Metals”) and its controlled entity for the year ended 30 June 2023.

Directors

The following persons were directors of Australasian Metals Limited during the whole of the financial year and up to the date of this report, unless otherwise stated:

Particulars of each Director’s experience and qualifications are set out later in this report.

Operating and Financial Review

Review of Operations and Principal Activities

The principal activities of the Group during the financial period were gold and lithium exploration at the Group’s tenements situated in Queensland, Western Australia and Northern Territory.

Corporate

500,000 ordinary shares were released from voluntary escrow on 6 September 2022.

The Company’s Annual General Meeting was held on 25 November 2022, with all resolutions passing by way of a poll.

Financial Performance

The Group’s loss after tax for the year ended 30 June 2023 was \$250,153 (2022: loss of \$997,902).

Financial Position

An analysis of the significant movements in Statement of Financial Position line items is provided below:

Cash and Cash Equivalents

As at 30 June 2023 the Group had cash reserves of \$4,028,274, a decrease of \$1,120,221 from 30 June 2022.

Reserves

Reserves have decreased by \$587,140 since 1 July 2022 as a result of the expiry of options and performance rights in the year (notes 14) of the attached financial statements.

Review of Operations

Mt Peake Lithium project, Northern Territory (100%)

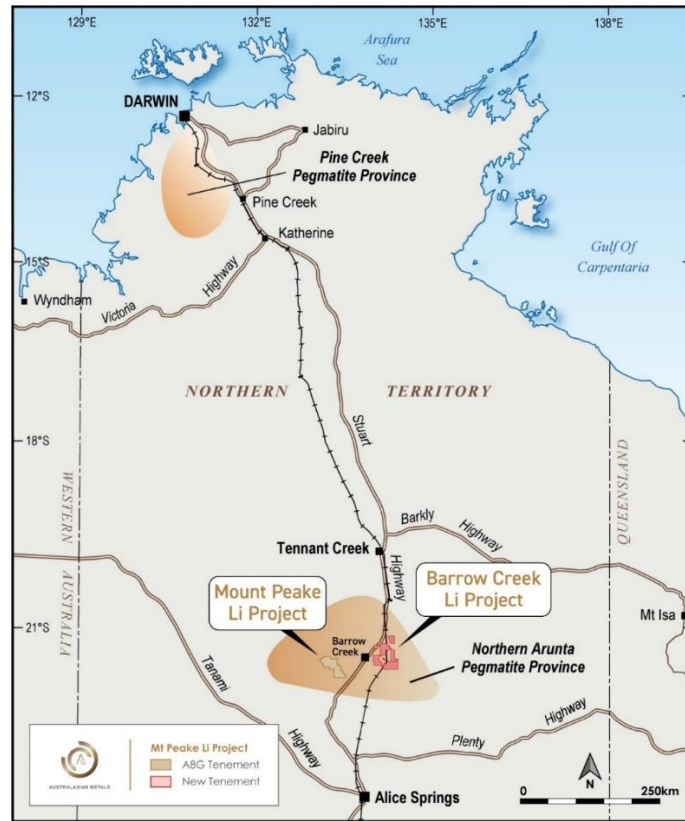


Figure 1: Mt Peake and Barrow Creek lithium project location in the Northern Arunta Pegmatite provinces of the Northern Territory (KM Frater, 2005)

ELA32830 is located in Mt Peake area of the Anningie Tin-Tantalum-Pegmatite fields in the north Arunta Region of the Northern Territory, approximately 200km north of Alice Springs and 250km south of Tennant Creek along the Stuart Highway in the Northern Territory. The area is considered highly prospective for hard rock lithium mineralization. ELA32830 covers over 640km² and shares a boundary with Core Lithium Limited's (ASX:CXO) Anningie lithium project (**Figure 1**).

The Company partnered with the CSIRO under the CSIRO Kick-Start Program to research "Lithium (Li) Exploration in the Mt Peake Pegmatite Field" at Mt Peake. Through CSIRO, the Company gained access to state-of-the-art optical, thermal and geophysical remote sensing data analysis and interpretation workflows, as well as instrumental equipment to identify potential key features of Li-bearing pegmatites.

Fieldwork commenced at Mt Peake with Australasian and the CSIRO initially embarking on a detailed mapping and targeting exercise using a combination of ground-based surveying techniques and detailed satellite imagery to highlight potential lithium bearing zones. A total of 27 rock and soil samples were collected with assay results announced to ASX on 16 November 2021. Rock chip sample JC001 returned high-grade lithium mineralisation of up to 1.61% Li₂O and 223ppm Ta within outcropping pegmatites. Sample JC001 was sampled from a pegmatite unit within a micaceous schist. There are greenish coarse-grained spodumene crystals with mica and feldspar identified in sample JC001.

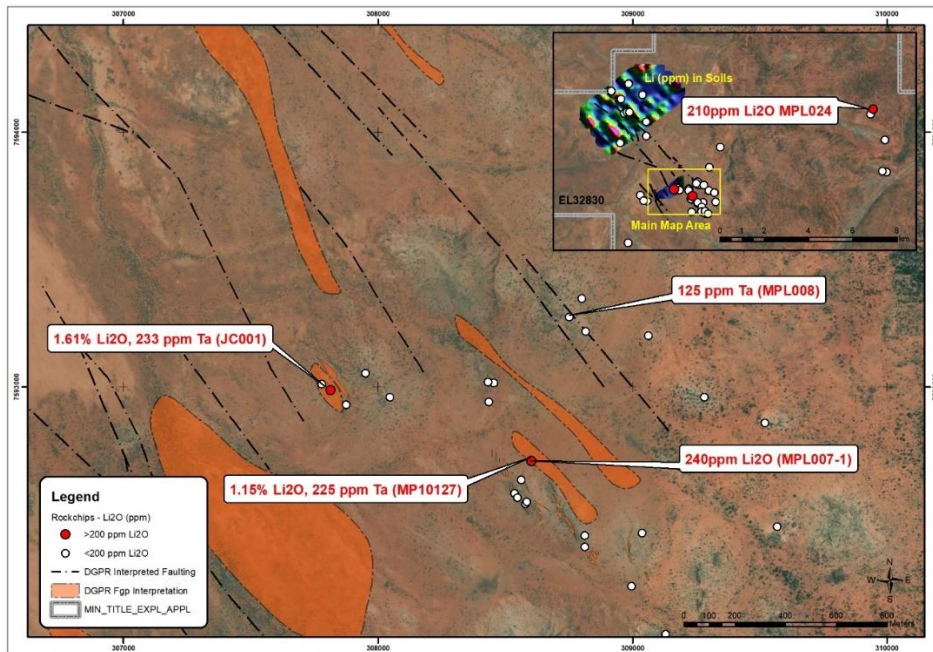


Figure 2: Location of Sample MP10127 at the northwest corner of EL32830. The interpreted pegmatite bodies in shallow depth by DGPR was coloured in orange. The Inserted map shows the soil sampling program area and rock chip locations.

A follow-up rock chip sampling program at Mt Peake returned further high-grade lithium and tantalum results, with sample MP10127 returning 1.15% Li₂O and 226 ppm Ta (refer ASX announcement 8 April 2022) (**Figure 2**).

Soil Sampling Program

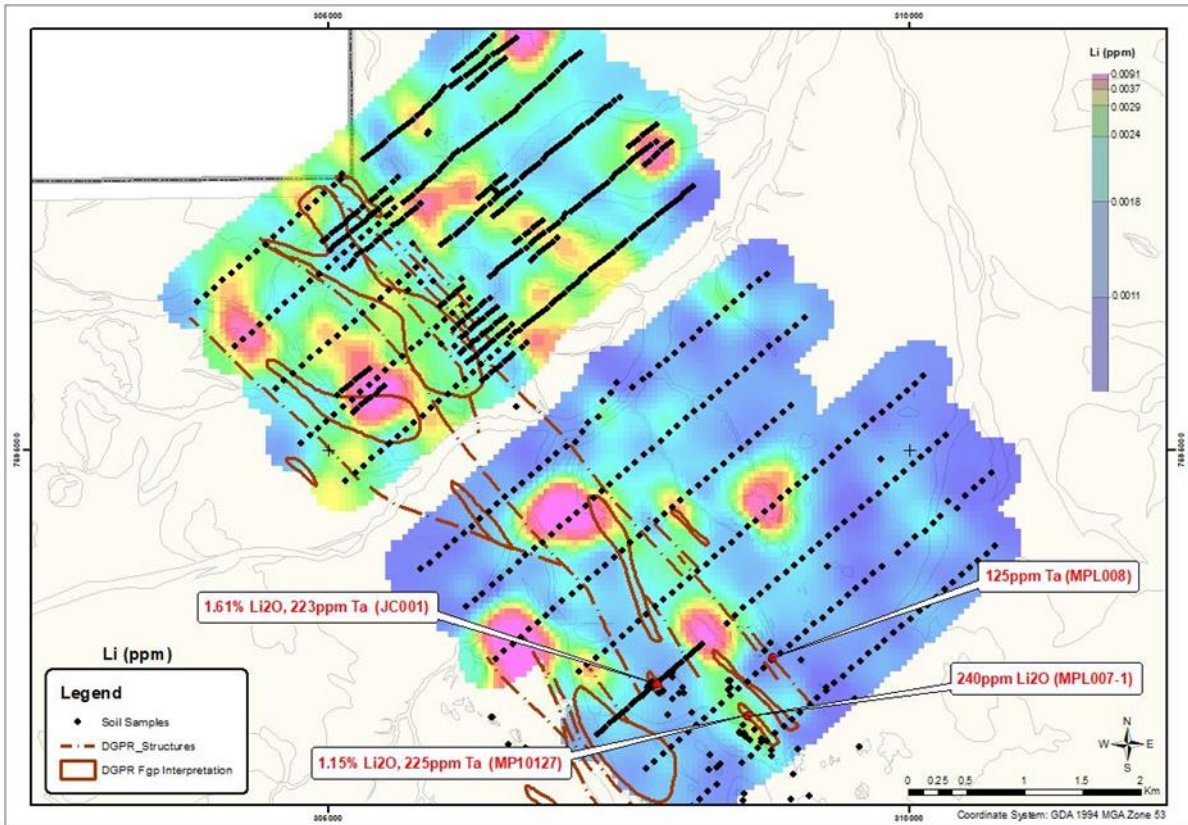


Figure 3: Lithium geochemical contours generated from data in the attached appendix. Location of Samples JC001 and MP10127 in the northwest corner of EL32830. The orange polylines represent interpreted pegmatite bodies at shallow depth from a previous deep ground-penetrating radar (DGPR) survey. The gap between the two sections of soil sampling is due to the presence of a major drainage system.

The Company conducted a soil geochemical sampling program using Ionic Leach™ geochemical technique with ALS Perth. The results are presented in Figures 3, and 4, for Li and Cs respectively.

The areas of Li geochemical anomalism that are evident with the recent geochemistry program tend to be quite consistent along the sampling lines but generally do not extend along the direction of the dominant strike (NW-SE) in the area. There are many possible reasons for this including a different strike direction for the mineralisation event or the remobilization of lithium under weathering processes.

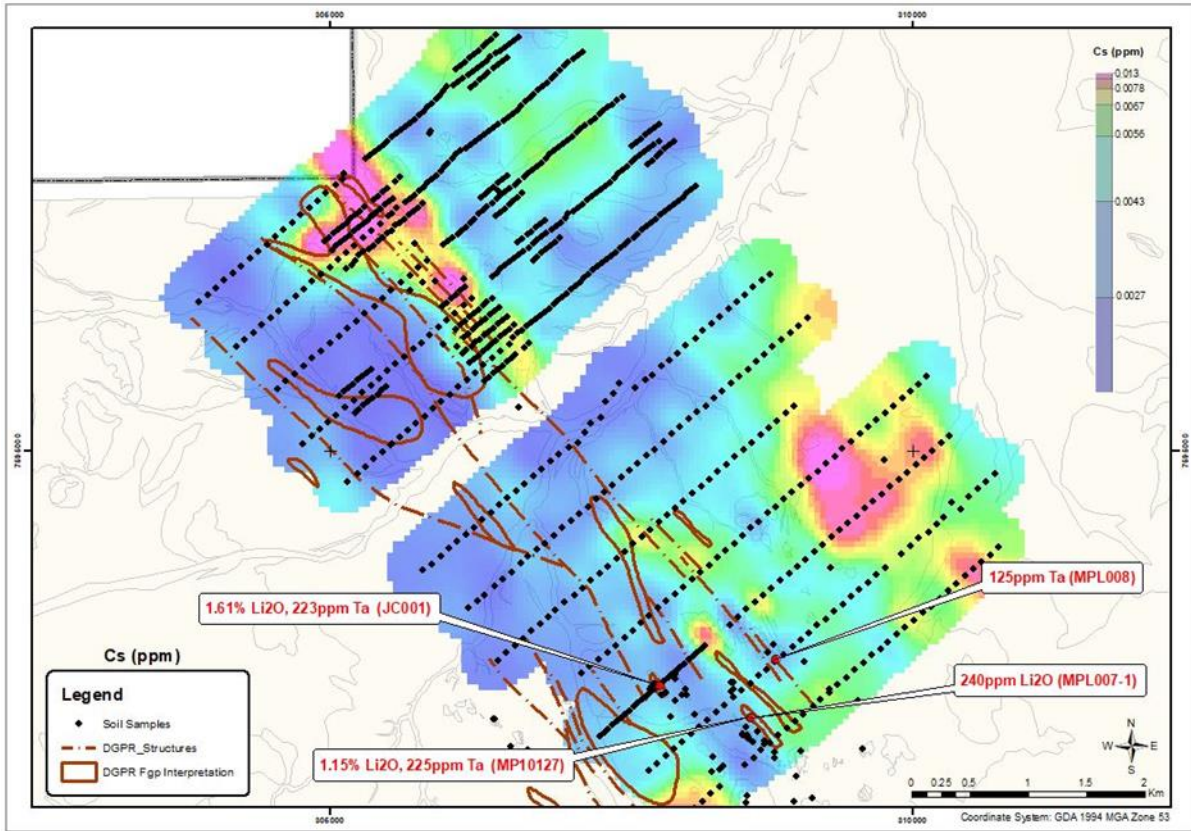


Figure 4: Caesium geochemical contour map.

Research Consortium in North Arunta district

On 28 November 2022, the Company advised that it had initiated a joint research program with Centre for Exploration Targeting (CET) of the University of Western Australia (UWA) covering the Northern Arunta pegmatite province in the Northern Territory. The program will be co-funded by Core Lithium Limited, Oceana Lithium Limited, Askari Minerals Limited, and Lithium Spring Limited, all of which have been actively exploring for lithium-related minerals in the North Arunta Pegmatite district.

Various rare metal pegmatite fields are known in the highly prospective Northern Arunta Pegmatite Province. Many of these are interpreted to be Lithium-Caesium-Tantalum (LCT) pegmatites, a type of rare-element pegmatite that hosts world-class lithium and tantalum deposits in Western Australia, such as Greenbushes, Pilgangoora, and Wodgina. Other pegmatites, such as those associated with rare earth elements, may also be present.

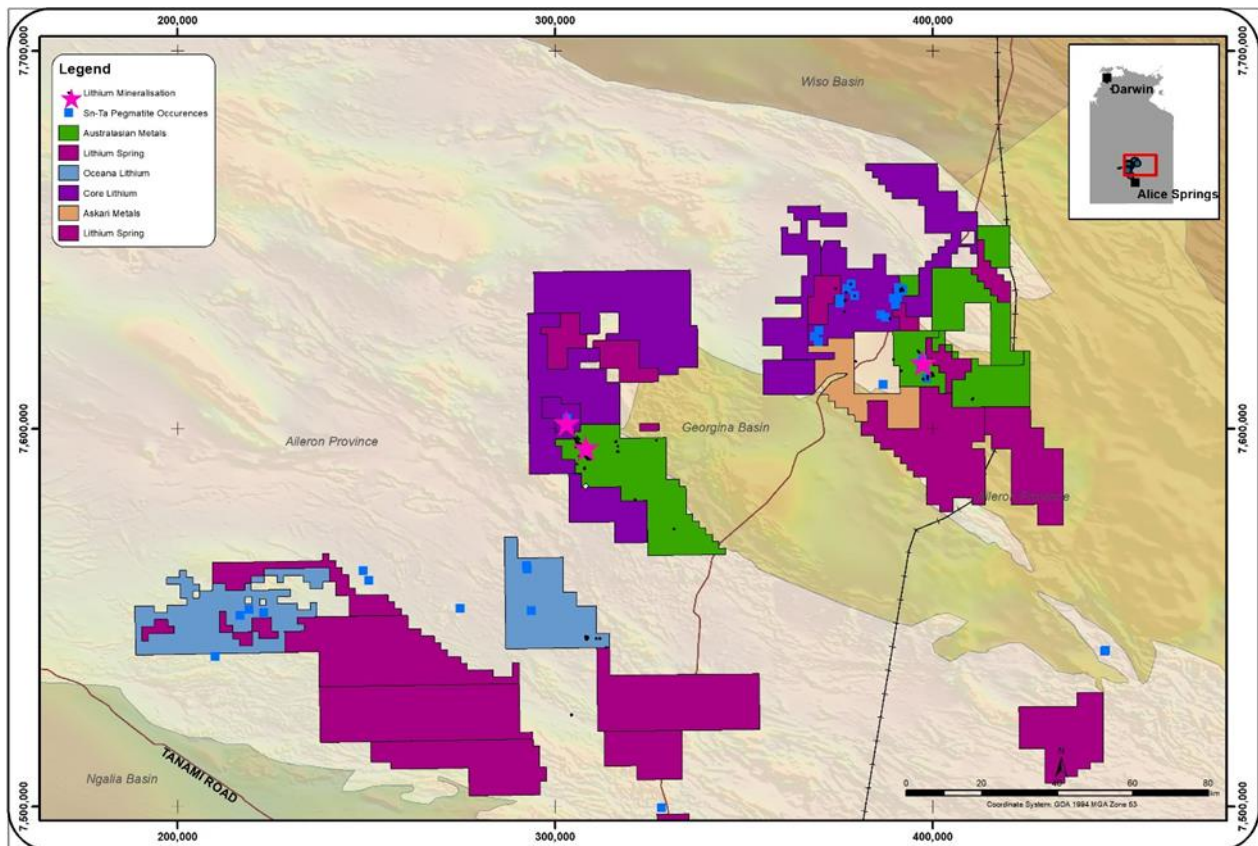


Figure 5: Land holding of lithium explorers in the North Arunta Pegmatite district in Northern Territory. Red stars are the location of lithium mineralisation identified so far.

There are several active explorers in this region; their landing holding is presented in **Figure 5**.

Until now there has been a dearth of systematic structural and petrogenetic constraints on the Arunta rare metal pegmatite province, which, as a consequence, has hindered systematic, cost-effective exploration targeting using modern geochemical, hyperspectral and mineralogical tools.

This joint research program will address this issue by first defining a robust litho-chemical-mineralisation framework for rare metal pegmatites in the Arunta Province and situating it within the context of available structural constraints. Following the establishment of this framework, detailed mineralogical and mineral chemistry investigations on Li-bearing and pathfinder minerals will be undertaken, allowing for robust and cost-effective exploration targeting for fertile (in terms of lithium, tantalum and potentially rare earth element) granites.

Next Steps

- The lithium high areas within the soil geochemistry maps will be re-sampled in the field and the soil program may be extended towards the south-east with large spacing to increase the coverage.
- Access and compensation agreement has been executed with the pastoralists in order to proceed with a planned diamond drilling program. The Company is working with Aboriginal Areas Protection Authority (AAPA) office of the Northern Territory government to get clearance on the drilling site.
- The geochemical data will be re-interpreted with the CSIRO team to further extract value from the current dataset.

Barrow Creek Lithium project, Northern Territory (90%)

On 12 January 2022, the Company announced that it had acquired a 90% joint-venture interest in 5 tenements covering ~880 km² in the northern Arunta pegmatite province, Northern Territory (“Barrow Creek Lithium project”) (refer ASX announcement 12 January 2022 and 22 February 2022).

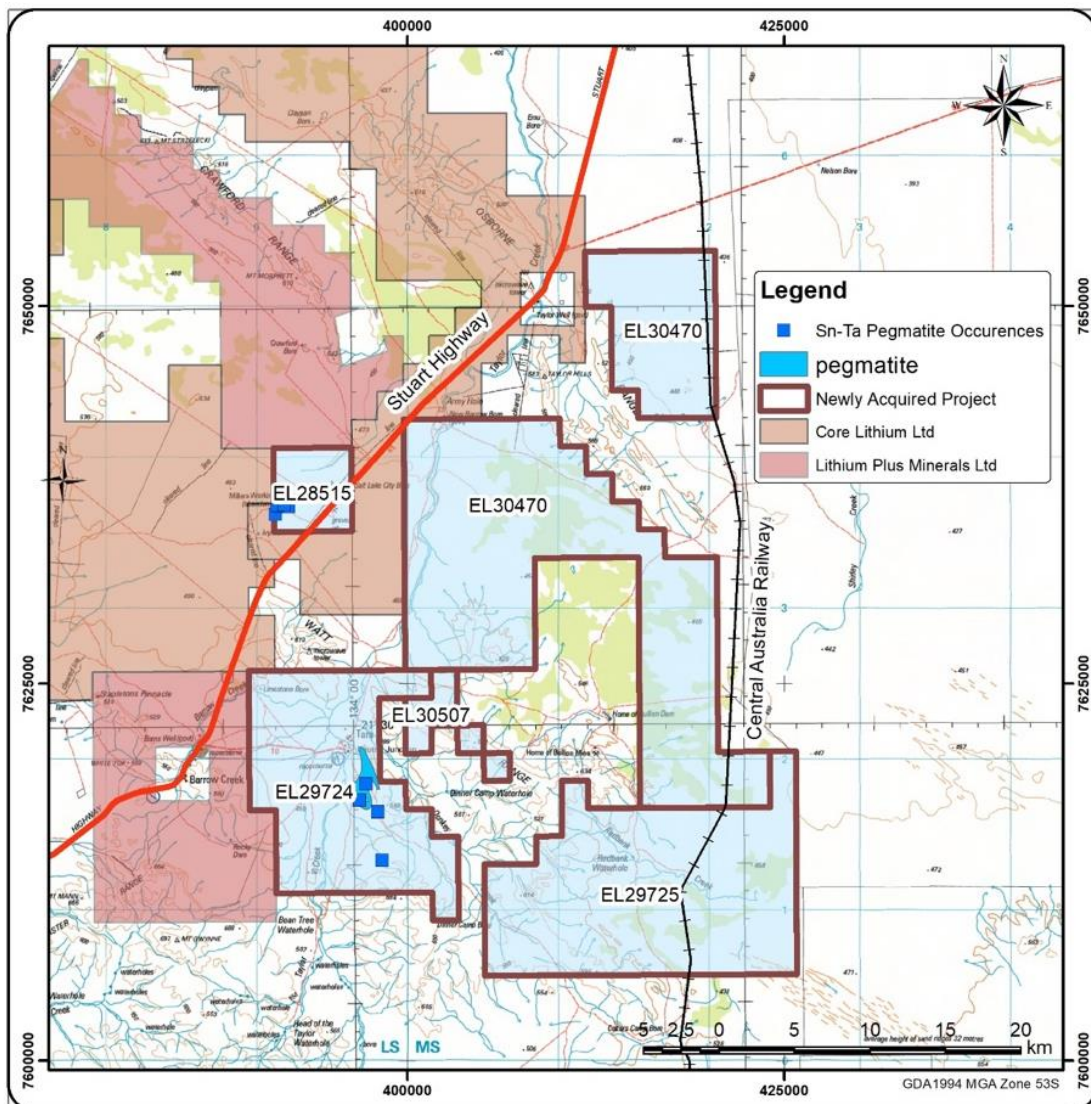


Figure 6: Location of Barrow Creek Lithium Project. The package shares a boundary with Core Lithium Limited and another lithium explorer (Lithium Plus Minerals Ltd). Pegmatite is mapped with 1:250K geological map, and Sn-Ta pegmatite occurrences have been reported.

Barrow Creek is located roughly 100 kms to the northeast of the Company’s Mt Peake Lithium project (**Figure 1**). There are historical Ta-Sn mineral occurrence records across several tenements, and pegmatite rocks have been mapped, with regional geological mapping by previous explorers and government geologists (**Figure 6**). Importantly, the tenements are situated on privately-owned land, with good road and railway access.

Access to the majority of the project area from Barrow Creek is via the Stuart Highway to the north and then using the Ali Curung to Jarra Jarra track. Newmont constructed an access track from the Jarra Jarra to the Waldron's Hill prospect in 2007. In 2008 Newmont constructed a series of north-south access tracks off the Waldron's Hill track to allow better access to the region. Reliable fair-weather access to most individual sites is via a series of established pastoral and historical exploration gravel tracks.

On 28 June 2022, the Company announced that it is continuing its partnership with CSIRO through the Kick-Start research program, with \$50K co-funding to research "Li exploration in the Mt Peake and Barrow Creek Pegmatite Field". Australasian Metals and CSIRO agreed to continue their successful collaboration to further narrow down the search for Li-(Ta-Sn) bearing pegmatites. The research is especially focused on better understanding the occurrence of mafic rocks hosting LCT-pegmatites and possible genetic relationships between the maficity of the igneous country rocks and the Li-content and/or Li-host minerals. CSIRO proposes to improve the mapping of mafic country rocks in the Mt Peake and Barrow Creek area by further developing the PRISMA-derived mineral maps targeting mafic minerals and comparing this with aeromagnetic and gravity data.

During the period the Company announced that it had identified high-grade tantalum plus tin mineralisation at Barrow Creek. The highest grade was 1018ppm Ta in sample BC10124, which was taken from a highly weathered, almost ground level outcrop of what appears in hand specimen to be almost pure mica. Due to the dearth of outcropping rock, the Company completed a close spaced MMI soil sampling geochemistry program centred on the tantalum occurrence.

May Queen Gold project, Queensland (100%)

The May Queen gold project comprises granted tenement Exploration Permits for Minerals EPM 19419 and adjacent EPM 27746, located within the Brovinia goldfield in Queensland, approximately 225 km by road south-west of the nearest regional port at Bundaberg and 375 km by road from Brisbane (**Figure 7**). It covers free-hold land with no Native Title claim.

May Queen South Bauxite

On 30 May 2023, the Company announced it had entered into an agreement to acquire the May Queen South Bauxite project from Atlantic Lithium Limited.

The May Queen South Bauxite project is located in central Queensland, within a short trucking distance of a rail system leading north to the Port of Bundaberg. It is also located within close proximity of the main Queensland Rail network heading south towards the Port of Brisbane.

Bauxite mineralised plateaus and zones defined to date are shown in Figure 2 below, along with RC drilling locations. Mapping, sampling and initial laboratory assay results have defined significant high-grade bauxite mineralisation at average 42% alumina over a combined surface area of 16km². There is currently strong customer demand for this ore type.

The Company, via its fully owned subsidiary Pure Mining Pty Ltd, has signed a Sale and Purchase agreement with Eastern Exploration Pty Ltd, a subsidiary of Atlantic Lithium Limited, to acquire EL 16260 and EPM 16261 for \$10,000 cash, once the two licenses are renewed. The renewal applications for both tenements have been submitted to the Queensland Mines Department and are expected to be renewed in coming months. As part of the transaction, the Company also will replace the \$2,500 in environment bonds once the licenses are transferred to Pure Mining Pty Ltd.

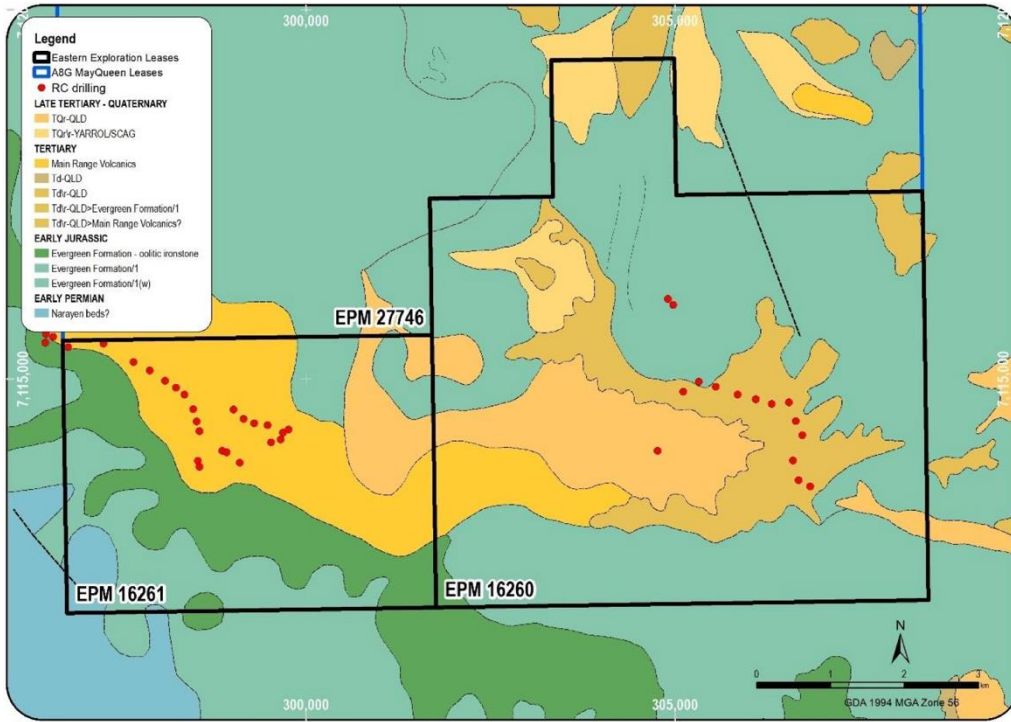


Figure 8: Basic geology of the EPM16260 and EPM 16261 with RC hole's locations marked

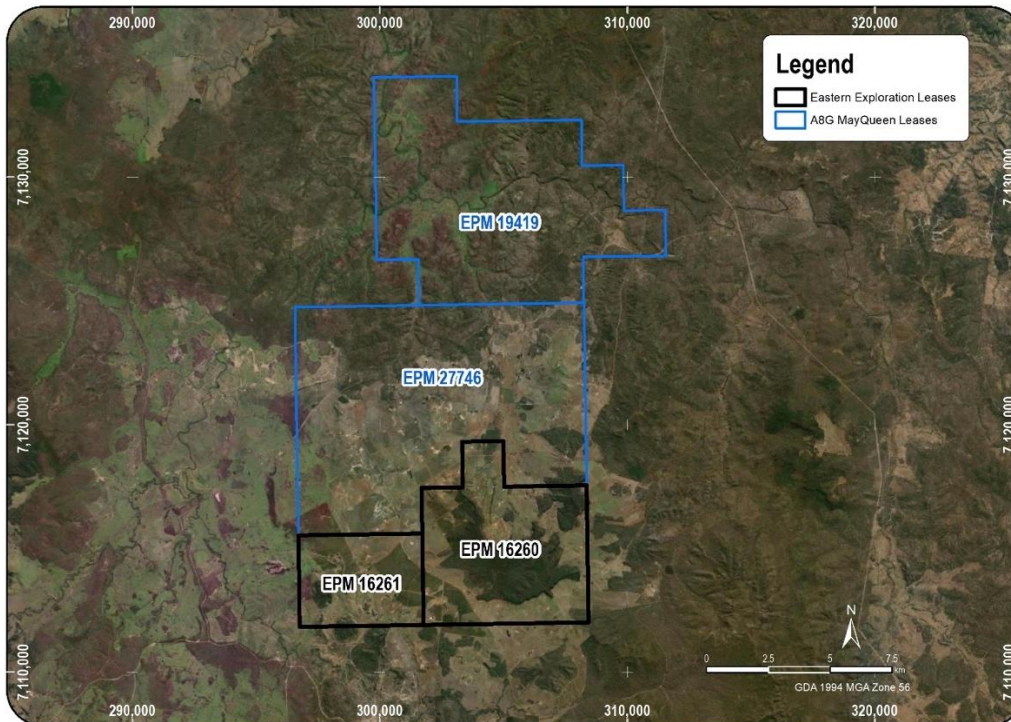


Figure 9: Location of Tenements 16260 and 16261, A8G existing tenements in May Queen gold project

Preliminary scoping metallurgical test-work including size reduction, scrubbing and sizing was completed at Core Resources laboratory in Brisbane, Australia on representative 25 to 50kg bulk samples of the surface duricrust and bauxite resource. This work was carried out, to test whether a 'premium quality' DSO product could be easily beneficiated through simple crushing, scrubbing and screening.

On 10 July 2023 the Company announced that it had completed its initial field program at the May Queen South Bauxite project. The program consisted primarily of mapping and surface rock chip sampling. The geological fertility of the Project was confirmed by the identification of several high grade surface samples of between 6.0% to 17.6% TiO₂.

Mt Clermont project, Queensland (100%)

The Mt Clermont gold project lies within the Anakie Province of the Drummond Basin which is composed of a sequence of Devonian to Carboniferous volcanics and sediments in Central Queensland, approximately 60 km by road north-west of the town of Emerald. Over 6,700m of historical drilling has been completed, showing potential for a high-grade polymetallic epithermal system. Future exploration will focus on exploring for further sulphide lenses along the major Retro fault system.

The Company has engaged Mr Ian Cooper to conduct a targeting exercise on the Mt Clermont polymetallic project and Capella gold project. A field trip focused on investigating the potential northeast mineralising structure was undertaken during the December quarter. Auger drilling was completed covering the area between Retro South and Nanya prospects with the assistance of local landowner and the results didn't highlight further anomalism but helped us prioritise further targets.

The Group is continuing with the re-processing of all the available historical data relating to the Mt Clermont polymetallic project as part of the prioritisation of targets for a maiden drilling program.

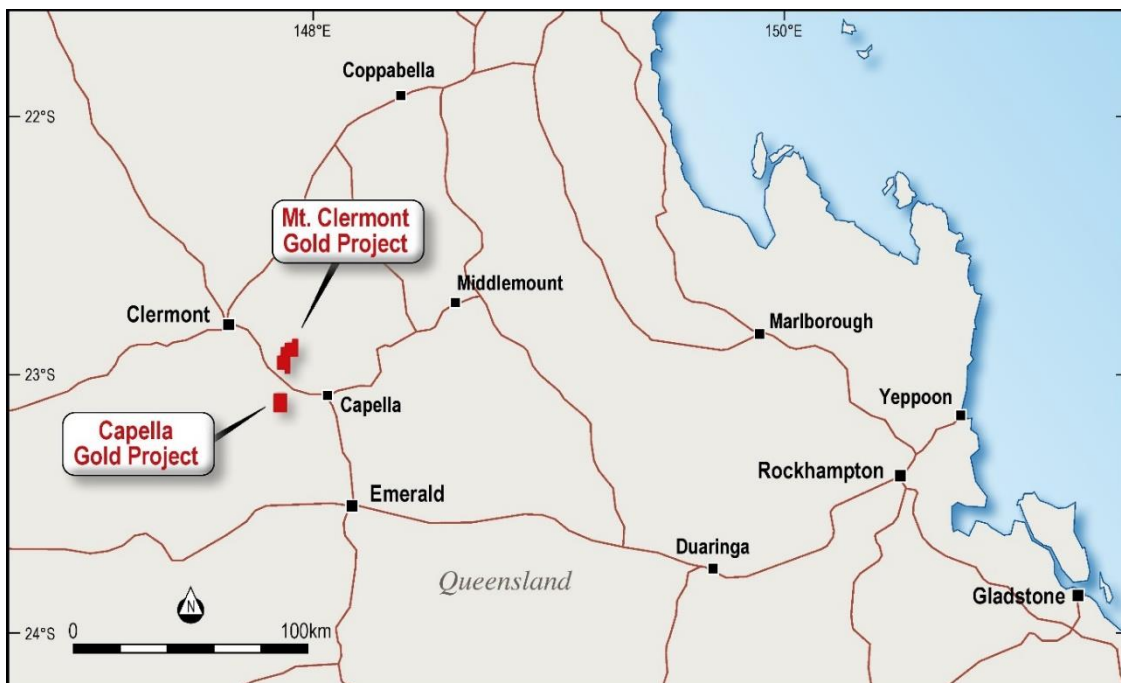


Figure 10: Mt Clermont project tenement holding and location.

Capella Gold Project, Queensland (100%)

The Capella gold project is strategically located around 10km south from the Group's Mt Clermont polymetallic project (**Figure 10**). The Capella gold project is situated on 100% exclusive land with no Native Title.

Fairview Project, Western Australia (100%)

The Fairview gold project lies within the Pilbara Granite-Greenstone Complex in the northwest of Western Australia. The exploration target is structurally similar to the Mt Clement deposit (less than 5 km to the south-east) and the Paulsens Gold Mine, operated by Northern Star Limited (ASX:NST) (around 30 km to the northwest).

On 17 July 2023, the Company announced that it entered into a sale agreement with Marquee Resources Limited (ASX:MQR) regarding the sale of the Company's 100% interest in the Fairview Gold Project.

Events Subsequent to the End of the Financial Period

Fairview Gold Project

In July 2023, the Group executed a Tenement Sale Agreement with Marquee Resources Limited (a listed corporation with ASX code: MQR) for the sale of the Fairview Gold Project, Western Australia with consideration of 6.5 million fully paid ordinary shares in MQR (with market value of \$250,000) plus 6 million options in MQR expiring 3 years from the date of issue with an exercise price of \$0.05. The shares and options will be subject to 6-months voluntary escrow from date of issue. The sale of Fairview Gold Project allows the Group to focus on its lithium, gold and bauxite/titanium projects in the Northern Territory and Queensland.

Mt Peake Lithium Project

In July 2023, the Group was awarded a grant of \$95,185 (inclusive of GST) under the Resourcing the Territory initiative, which is administered by the Northern Territory Geological Survey. The funds from the grant will be applied towards the Group's maiden diamond drilling program at the highly prospective Mt Peake Lithium Project in the Northern Arunta province, which is expected to start in the third quarter of year 2023. This additional funding has allowed the Group to test the well-defined targets with less financial risk and the Group has the capacity to design an expanded drilling program if needed which will encompass a greater area than would otherwise be possible.

Additionally, the Group has obtained its Aboriginal Area Protection Authority certificate, which allows the Group to conduct diamond drilling in Mt Peake high priority targets. The Group has an approved mining management plan (MMP) in place, which means the Group now has all permits in place to conduct the very first diamond drilling program for Lithium mineralization in this under-explored region.

Other than the above, no matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the Group, the results of those operations, or the state of affairs of the Group in future financial years.

Likely Developments and Expected Results of Operations

Likely developments, future prospects and business strategies of the operations of the Group and the expected results of those operations, not otherwise disclosed in this report, have not been included as the Directors believe that the inclusion of such information would be likely to result in unreasonable prejudice to the Group.

Environmental Regulations

The Group is not subject to any significant environmental regulation under Australian Commonwealth or State Law as it is still in exploration stage.

Remuneration Report (audited)

The remuneration report details the key management personnel remuneration arrangements for the consolidated entity, in accordance with the requirements of *the Corporations Act 2001* and its Regulations. Key management personnel are those persons having authority and responsibility for planning, directing and controlling the activities of the entity, directly or indirectly, including all directors.

Remuneration Policy

The remuneration policy of the Group has been designed to align key management personnel (KMP) objectives with shareholder and business objectives by providing a fixed remuneration component and offering specific long-term incentives based on key performance areas affecting the Group's financial results. The Board of the Group believes the remuneration policy to be appropriate and effective in its ability to attract and retain high-quality KMP to run and manage the Group, as well as create goal congruence between Directors, executives and shareholders.

For the purposes of this report, KMP comprises executive and non-executive Directors of the Group, as follows:

Rory McGoldrick – Non-Executive Chairman
Graeme Fraser – Non-Executive Director
Dr Qingtao Zeng – Managing Director

The Board's policy for determining the nature and amount of remuneration for KMP of the Group is based on the following:

- The remuneration policy is to be developed and approved by the Board after professional advice, if required, is sought from independent external consultants.
- All KMP receive a base salary (which is based on factors such as length of service and experience), superannuation, fringe benefits and performance incentives.
- Performance incentives are generally only paid once predetermined key performance indicators (KPI's) have been met.
- Incentives paid in the form of options or rights are intended to align the interests of the KMP and Group with those of the shareholders. In this regard, KMP are prohibited from limiting risk attached to those instruments by use of derivatives or other means.
- The Board reviews KMP packages annually by reference to the Group's performance, executive performance and comparable information from industry sectors.

In accordance with best practice corporate governance, the structure of non-executive director and executive director remuneration is separate.

The performance of KMP is measured against criteria agreed generally annually with each executive and is based predominantly on the forecast growth of shareholders' value or mining resources under management. All bonuses and incentives must be linked to predetermined performance criteria. The Board may, however, exercise its discretion in relation to approving incentives, bonuses and options, and can recommend changes at any time. Any change must be justified by reference to measurable performance criteria. The policy is designed to attract the highest calibre of executives and reward them for performance results leading to long-term growth in shareholder wealth.

Non-executive Director Remuneration

The Board's policy is to remunerate non-executive Directors at market rates for time, commitment and responsibilities. The Board determines payments to the non-executive Directors and reviews their remuneration annually, based on market practice, duties and accountability. Independent external advice is sought when required. The current amount has been set at an amount not to exceed \$200,000 per annum. The maximum aggregate amount of fees that can be paid to non-executive Directors is subject to approval by shareholders at general meeting.

KMP are also entitled and encouraged to participate in the employee share and option arrangements to align Directors' interests with shareholders' interests.

Options granted under the arrangement do not carry dividend or voting rights. Each option is entitled to be converted into one ordinary share once the interim or final financial report has been disclosed to the public and is measured using the Black-Scholes and other appropriate valuation approach.

Executive Remuneration

The executive remuneration and reward framework has four components:

- base pay and non-monetary benefits
- short-term performance incentives
- share-based payments
- other remuneration such as superannuation and long service leave

The combination of these comprises the executive's total remuneration.

Fixed remuneration, consisting of base salary, superannuation and non-monetary benefits, are reviewed annually by the Board based on individual and the overall performance of the consolidated entity.

Executives may receive their fixed remuneration in the form of cash or other fringe benefits (for example motor vehicle benefits) where it does not create any additional costs to the consolidated entity and provides additional value to the executive.

Performance-based Remuneration

KPI's are set annually, with a certain level of consultation with KMP. The measures are specifically tailored to the area each individual is involved in and has a level of control over. The KPI's target areas the Board believes hold greater potential for Group expansion and shareholder value, covering financial and non-financial as well as short and long-term goals. The level set for each KPI is based on budgeted figures for the Group and respective industry standards.

The short-term incentives (STI) program is designed to align the Group's target with the performance hurdles of the executives.

Performance in relation to the KPI's is assessed either six monthly or annually, with bonuses being awarded depending on the number and deemed difficulty of the KPI's achieved. Following the assessment, the KPI's are reviewed by the Board in light of the desired and actual outcomes, and their efficiency is assessed in relation to the Group's goals and shareholder wealth, before the KPI's are set for the following period.

In determining whether or not a KPI has been achieved, the Group bases the assessment on audited figures; however, where the KPI involves comparison of the Group, or a division within the Group, to the market, independent reports are obtained from organisations such as Standard & Poor's.

The long-term incentives ('LTI') include long service leave and share-based payments. Options and performance rights are awarded to executives. The Board reviewed the long-term equity-linked performance incentives specifically for executives during the year ended 30 June 2023.

Voting and comments made at the company's 2022 Annual General Meeting ('AGM')

At the 2022 AGM, 99% of the votes received supported the adoption of the remuneration report for the year ended 30 June 2022. The company did not receive any specific feedback at the AGM regarding its remuneration practices.

During the financial year ended 30 June 2023, the group did not engage the services of such consultants.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

The consolidated entity has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

The following Accounting Standards and Interpretations are most relevant to the consolidated entity:

a) Basis of Preparation

These general-purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the Corporations Act 2001, as appropriate for for-profit oriented entities.

These financial statements also comply with International Financial Reporting Standards as issued by the International Accounting Standards Board ('IASB').

The Australasian Metals Limited is a for-profit entity for financial reporting purposes under Australian Accounting Standards. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

Except for cash flow information, the financial statements have been prepared on an accrual basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets, and financial liabilities.

b) Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of Australasian Metals Limited as at 30 June 2023 and the results of all subsidiaries for the year then ended. Australasian Metals Limited and its subsidiaries together are referred to in these financial statements as the 'consolidated entity'.

Subsidiaries are all those entities over which the consolidated entity has control. The consolidated entity controls an entity when the consolidated entity is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the consolidated entity. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between entities in the consolidated entity are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the consolidated entity.



Where the consolidated entity loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The consolidated entity recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

c) Revenue and other income

Interest

Interest revenue is recognised using the effective interest rate method, which, for floating rate financial assets, is the rate inherent in the instrument. All revenue is stated net of the amount of goods and services tax (GST).

Government Grant

Government grants relating to costs are deferred and recognised in profit or loss over the period necessary to match them with the costs that they are intended to compensate.

Research and Development (R&D) tax incentive

R&D tax incentives are recognised as income in the statement of profit or loss when they are received.

d) Income tax

The income tax expense or benefit for the period is the tax payable on that period's taxable income based on the applicable income tax rate for each jurisdiction, adjusted by the changes in deferred tax assets and liabilities attributable to temporary differences, unused tax losses and the adjustment recognised for prior periods, where applicable.

Deferred tax assets and liabilities are recognised for temporary differences at the tax rates expected to be applied when the assets are recovered or liabilities are settled, based on those tax rates that are enacted or substantively enacted, except for:

- When the deferred income tax asset or liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting nor taxable profits; or
- When the taxable temporary difference is associated with interests in subsidiaries, associates or joint ventures, and the timing of the reversal can be controlled, and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

The carrying amount of recognised and unrecognised deferred tax assets are reviewed at each reporting date. Deferred tax assets recognised are reduced to the extent that it is no longer probable that future taxable profits will be available for the carrying amount to be recovered. Previously unrecognised deferred tax assets are recognised to the extent that it is probable that there are future taxable profits available to recover the asset.

Deferred tax assets and liabilities are offset only where there is a legally enforceable right to offset current tax assets against current tax liabilities and deferred tax assets against deferred tax liabilities; and they relate to the same taxable authority on either the same taxable entity or different taxable entities which intend to settle simultaneously.



e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits available on demand with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

f) Trade and other receivables

Trade receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any allowance for expected credit losses. Trade receivables are generally due for settlement within 30 days.

The consolidated entity has applied the simplified approach to measuring expected credit losses, which uses a lifetime expected loss allowance. To measure the expected credit losses, trade receivables have been grouped based on days overdue.

Other receivables are recognised at amortised cost, less any allowance for expected credit losses.

g) Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions to the instrument. For financial assets, this is the date that the Group commits itself to either the purchase or sale of the asset (i.e., trade date accounting is adopted).

Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Trade receivables are initially measured at the transaction price if the trade receivables do not contain a significant financing component or if the practical expedient was applied as specified in AASB 15.63.

Classification and subsequent measurement

Financial liabilities

The Group's financial instruments are subsequently measured at amortised cost.

All other financial liabilities are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest expense in profit or loss over the relevant period. The effective interest rate is the internal rate of return of the financial asset or liability. That is, it is the rate that exactly discounts the estimated future cash flows through the expected life of the instrument to the net carrying amount at initial recognition.

A financial liability is held for trading if:

- it is incurred for the purpose of repurchasing or repaying in the near term;
- part of a portfolio where there is an actual pattern of short-term profit taking; or
- a derivative financial instrument (except for a derivative that is in a financial guarantee contract or a derivative that is in an effective hedging relationships).

Any gains or losses arising on changes in fair value are recognised in profit or loss to the extent that they are not part of a designated hedging relationship are recognised in profit or loss.

The change in fair value of the financial liability attributable to changes in the issuer's credit risk is taken to other comprehensive income and are not subsequently reclassified to profit or loss. Instead, they are transferred to retained earnings upon derecognition of the financial liability. If taking the change in credit risk in other comprehensive income enlarges or creates an accounting mismatch, then these gains or losses should be taken to profit or loss rather than other comprehensive income.

A financial liability cannot be reclassified.

Financial assets

Financial assets are subsequently measured at:

- amortised cost;
- fair value through other comprehensive income; or
- fair value through profit or loss.

Measurement is on the basis of two primary criteria:

- the contractual cash flow characteristics of the financial asset; and
- the business model for managing the financial assets.

A financial asset that meets the following conditions is subsequently measured at amortised cost:

- the financial asset is managed solely to collect contractual cash flows; and
- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates.

A financial asset that meets the following conditions is subsequently measured at fair value through other comprehensive income:

- the contractual terms within the financial asset give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates;
- the business model for managing the financial assets comprises both contractual cash flows collection and the selling of the financial asset.

By default, all other financial assets that do not meet the measurement conditions of amortised cost and fair value through other comprehensive income are subsequently measured at fair value through profit or loss.



The Group initially designates a financial instrument as measured at fair value through profit or loss if:

- it eliminates or significantly reduces a measurement or recognition inconsistency (often referred to as "accounting mismatch") that would otherwise arise from measuring assets or liabilities or recognising the gains and losses on them on different bases;
- it is in accordance with the documented risk management or investment strategy, and information about the groupings was documented appropriately, so that the performance of the financial liability that was part of a group of financial liabilities or financial assets can be managed and evaluated consistently on a fair value basis;
- it is a hybrid contract that contains an embedded derivative that significantly modifies the cash flows otherwise required by the contract.

The initial designation of the financial instruments to measure at fair value through profit or loss is a one-time option on initial classification and is irrevocable until the financial asset is derecognised.

Equity instruments

At initial recognition, as long as the equity instrument is not held for trading and not a contingent consideration recognised by an acquirer in a business combination to which AASB 3: Business Combinations applies, the Group made an irrevocable election to measure any subsequent changes in fair value of the equity instruments in other comprehensive income, while the dividend revenue received on underlying equity instruments investment will still be recognised in profit or loss.

Regular way purchases and sales of financial assets are recognised and derecognised at settlement date in accordance with the Group's accounting policy.

Derecognition

Derecognition refers to the removal of a previously recognised financial asset or financial liability from the statement of financial position.

Derecognition of financial liabilities

A liability is derecognised when it is extinguished (i.e., when the obligation in the contract is discharged, cancelled or expires). An exchange of an existing financial liability for a new one with substantially modified terms, or a substantial modification to the terms of a financial liability is treated as an extinguishment of the existing liability and recognition of a new financial liability.

The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

Derecognition of financial assets

A financial asset is derecognised when the holder's contractual rights to its cash flows expires, or the asset is transferred in such a way that all the risks and rewards of ownership are substantially transferred.



All of the following criteria need to be satisfied for derecognition of financial asset:

- the right to receive cash flows from the asset has expired or been transferred;
- all risk and rewards of ownership of the asset have been substantially transferred; and
- the Group no longer controls the asset (i.e., the Group has no practical ability to make a unilateral decision to sell the asset to a third party).

On derecognition of a financial asset measured at amortised cost, the difference between the asset's carrying amount and the sum of the consideration received and receivable is recognised in profit or loss.

On derecognition of a debt instrument classified as at fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment revaluation reserve is reclassified to profit or loss.

On derecognition of an investment in equity which was elected to be classified under fair value through other comprehensive income, the cumulative gain or loss previously accumulated in the investment revaluation reserve is not reclassified to profit or loss but is transferred to retained earnings.

Impairment

The Group recognises a loss allowance for expected credit losses on:

- financial assets that are measured at amortised cost or fair value through other comprehensive income;
- lease receivables;
- contract assets (e.g., amounts due from customers under construction contracts);
- loan commitments that are not measured at fair value through profit or loss; and
- financial guarantee contracts that are not measured at fair value through profit or loss.

Loss allowance is not recognised for:

- financial assets measured at fair value through profit or loss; or
- equity instruments measured at fair value through other comprehensive income.

Expected credit losses are the probability-weighted estimate of credit losses over the expected life of a financial instrument. A credit loss is the difference between all contractual cash flows that are due and all cash flows expected to be received, all discounted at the original effective interest rate of the financial instrument.

The Group uses the simplified approach to impairment, as applicable under AASB 9: Financial Instruments.

Simplified approach

The simplified approach does not require tracking of changes in credit risk at every reporting period, but instead requires the recognition of lifetime expected credit loss at all times. This approach is applicable to:

- trade receivables or contract assets that result from transactions within the scope of AASB 15: Revenue from Contracts with Customers and which do not contain a significant financing component; and
- lease receivables.

In measuring the expected credit loss, a provision matrix for trade receivables was used taking into consideration various data to get to an expected credit loss (i.e., diversity of customer base, appropriate groupings of historical loss experience, etc).



Recognition of expected credit losses in financial statements

At each reporting date, the Group recognises the movement in the loss allowance as an impairment gain or loss in the statement of profit or loss and other comprehensive income.

The carrying amount of financial assets measured at amortised cost includes the loss allowance relating to that asset.

Assets measured at fair value through other comprehensive income are recognised at fair value, with changes in fair value recognised in other comprehensive income. Amounts in relation to change in credit risk are transferred from other comprehensive income to profit or loss at every reporting period.

For financial assets that are unrecognised (e.g., loan commitments yet to be drawn, financial guarantees), a provision for loss allowance is created in the statement of financial position to recognise the loss allowance.

h) Property plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the company. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

i) Right-of-use assets

A right-of-use asset is recognised at the commencement date of a lease. The right-of-use asset is measured at cost, which comprises the initial amount of the lease liability, adjusted for, as applicable, any lease payments made at or before the commencement date net of any lease incentives received, any initial direct costs incurred, and, except where included in the cost of inventories, an estimate of costs expected to be incurred for dismantling and removing the underlying asset, and restoring the site or asset.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the consolidated entity expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life. Right-of-use assets are subject to impairment or adjusted for any remeasurement of lease liabilities.

The consolidated entity has elected not to recognise a right-of-use asset and corresponding lease liability for short-term leases with terms of 12 months or less and leases of low-value assets. Lease payments on these assets are expensed to profit or loss as incurred.

j) Lease liabilities

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the consolidated entity's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties. The variable lease payments that do not depend on an index or a rate are expensed in the period in which they are incurred.

Lease liabilities are measured at amortised cost using the effective interest method. The carrying amounts are remeasured if there is a change in the following: future lease payments arising from a change in an index or a rate used; residual guarantee; lease term; certainty of a purchase option and termination penalties. When a lease liability is remeasured, an adjustment is made to the corresponding right-of use asset, or to profit or loss if the carrying amount of the right-of-use asset is fully written down.

k) Exploration and evaluation costs

Exploration and evaluation expenditure in relation to separate areas of interest for which rights of tenure are current is carried forward as an asset in the statement of financial position where it is expected that the expenditure will be recovered through the successful development and exploitation of an area of interest, or by its sale; or exploration activities are continuing in an area and activities have not reached a stage which permits a reasonable estimate of the existence or otherwise of economically recoverable reserves.

Accumulated costs in relation to an abandoned area are written off in full against profit or loss in the period in which the decision to abandon the area is made.

When production commences, the accumulated costs for the relevant area of interest are amortised over the life of the area according to the rate of depletion of the economically recoverable reserves.

A regular review is undertaken of each area of interest to determine the appropriateness of continuing to capitalise costs in relation to that area.

l) Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

m) Trade and other payables

These amounts represent liabilities for goods and services provided to the consolidated entity prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured

at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

n) Finance costs

Finance costs attributable to qualifying assets are capitalised as part of the asset. All other finance costs are expensed in the period in which they are incurred.

o) Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Assets and liabilities measured at fair value are classified into three levels, using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. Classifications are reviewed at each reporting date and transfers between levels are determined based on a reassessment of the lowest level of input that is significant to the fair value measurement.

For recurring and non-recurring fair value measurements, external valuers may be used when internal expertise is either not available or when the valuation is deemed to be significant. External valuers are selected based on market knowledge and reputation. Where there is a significant change in fair value of an asset or liability from one period to another, an analysis is undertaken, which includes a verification of the major inputs applied in the latest valuation and a comparison, where applicable, with external sources of data.

p) Issued capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

q) Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses, assets and liabilities are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

r) Non-current assets classified as held for sale

Non-current assets are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continued use. They are measured at the lower of their carrying amount and fair value less costs of disposal. For non-current assets to be classified as held for sale, they must be available for immediate sale in their present condition and their sale must be highly probable.

An impairment loss is recognised for any initial or subsequent write down of the non-current assets to fair value less costs of disposal. A gain is recognised for any subsequent increases in fair value less costs of disposal of a non-current assets but not in excess of any cumulative impairment loss previously recognised.

Non-current assets classified as held for sale classified as held for sale are presented separately on the face of the statement of financial position, in current assets.

s) Significant accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectation of future events, management believes to be reasonable under the circumstances. The resulting accounting judgments and estimates will seldom equal the related actual results. In the process of applying the Group's accounting policies, management has made the following judgments, apart from those involving estimations, which have the most significant effect on the amounts in the financial statements.

Exploration and evaluation expenditure

The Group's accounting policy for exploration and evaluation expenditure is set out at Note 1(k). The application of this policy necessarily requires management to make certain estimates and assumptions as to future events and circumstances. Any such estimates and assumptions may change as new information becomes available. If, after having capitalised expenditure under the policy, it is concluded that the expenditures are unlikely to be recovered by future exploitation or sale, then the capitalised amount will be written off to the statement of comprehensive income.

Share-based payment transactions

The Group measures the cost of equity-settled transactions by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by using either the Binomial, market value or Black-Scholes model taking into account the terms and conditions upon which the instruments were granted. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amounts of assets and liabilities within the next annual reporting period but may impact profit or loss and equity.

Financial Risk Management Policies

The Board monitors the Group's financial risk management policies and exposures and approves financial transactions within the scope of its authority. It also reviews the effectiveness of internal controls relating to commodity price risk, counterparty credit risk, foreign currency risk, liquidity risk and interest rate risk.

25. EVENTS AFTER THE END OF THE YEAR

Fairview Gold Project

In July 2023, the Group executed a Tenement Sale Agreement with Marquee Resources Limited (a listed corporation with ASX code: MQR) for the sale of the Fairview Gold Project, Western Australia with consideration of 6.5 million fully paid ordinary shares in MQR (with market value of \$250,000) plus 6 million options in MQR expiring 3 years from the date of issue with an exercise price of \$0.05. The shares and options will be subject to 6-months voluntary escrow from date of issue. The sale of Fairview Gold Project allows the Group to focus on its lithium, gold and bauxite/titanium projects in the Northern Territory and Queensland.

Mt Peake Lithium Project

In July 2023, the Group was awarded a grant of \$95,185 (inclusive of GST) under the Resourcing the Territory initiative, which is administered by the Northern Territory Geological Survey. The funds from the grant will be applied towards the Group's maiden diamond drilling program at the highly prospective Mt Peake Lithium Project in the Northern Arunta province, which is expected to start in the third quarter of year 2023. This additional funding has allowed the Group to test the well-defined targets with less financial risk and the Group has the capacity to design an expanded drilling program if needed which will encompass a greater area than would otherwise be possible.

Additionally, the Group has obtained its Aboriginal Area Protection Authority certificate, which allows the Group to conduct diamond drilling in Mt Peake high priority targets. The Group has an approved mining management plan (MMP) in place, which means the Group now has all permits in place to conduct the very first diamond drilling program for Lithium mineralization in this under-explored region.

Other than the above, no matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the Group, the results of those operations, or the state of affairs of the Group in future financial years.
