## VOTING ENTITLEMENTS

### Time and place of meeting

Notice is given that the 2023 Annual General Meeting of Shareholders of TerraCom Limited (**Company**) will be held at 2:00pm (AEDT) on Wednesday 29 November 2023 at the Offices of K&L Gates, Level 31, 1 O'Connell Street, Sydney NSW 2000.

This Notice of Meeting incorporates, and should be read together with, the Explanatory Statement and accompanying Proxy Form.

### Voting entitlements

The Directors have determined pursuant to Regulation 7.11.37 of the *Corporations Regulations 2001* (Cth) that, for the purposes of this Meeting, a Shareholder's voting entitlement will be taken to be the entitlement of the persons shown in the register of Shareholders as at 7:00pm (AEDT) on 28 November 2023. Share transfers registered after that time will be disregarded in determining entitlements to attend and vote at the Meeting.

### Voting procedure

Voting on the proposed Resolutions at this Meeting will be conducted by poll. Under the Constitution, any poll will be conducted as directed by the Chair.

Shareholders can vote in one of two ways:

- (a) by attending the Meeting in person and voting; or
- (b) by appointing a proxy or attorney to attend and vote on their behalf.

### Voting at the meeting

To vote in person, attend the Meeting at the time, date and place set out above.

Ordinary resolutions require the support of more than 50% of those Shareholders voting in person, by proxy, by representative or by attorney.

On a poll, every Shareholder present (in person, by proxy, attorney or representative) and entitled to vote, has one vote for every fully paid Ordinary Share held (subject to any voting restrictions that may apply).

### Voting by proxy

Please note:

- (a) every Shareholder entitled to attend the Meeting and vote has a right to appoint a proxy. A Shareholder entitled to attend and cast two or more votes at the Meeting is entitled to appoint two proxies and may specify the proportion or number of votes each proxy is appointed to exercise;
- (b) a proxy appointed to attend and vote for a Shareholder has the same rights as the Shareholder to speak at the meeting, to vote (but only to the extent allowed by the appointment) and to join in a demand for a poll;

- (c) a proxy need not be a shareholder of the Company;
- (d) an instrument appointing a proxy may be in the form of the proxy attached to this Notice of Meeting;
- (e) if a Shareholder appoints two proxies, and the appointment does not specify the proportion or number of the Shareholder's votes each proxy is appointed to exercise, each proxy may exercise one-half of the Shareholder's votes;
- (f) a Shareholder may specify the manner in which a proxy is to vote in respect of a particular Resolution. In this instance, the proxy may only vote on a Resolution as directed by the Shareholder. If the Shareholder has directed the proxy how to vote on a particular Resolution and either the proxy fails to attend the meeting, or chooses not to vote on a poll for a Resolution, then the Chair of the meeting will be deemed to be the Shareholder's proxy and will vote the Shares as directed by the Shareholder;
- (g) if a Shareholder does not direct the proxy how to vote on a particular Resolution, the shareholder is authorising the proxy to vote as the proxy decides, subject to any applicable voting exclusions/prohibitions;
- (h) if a shareholder appoints the Chair of the Meeting as their proxy using the enclosed proxy form (or the Chair becomes proxy by default) without specifying the way the proxy is to vote on a particular Resolution, by completing and signing the proxy form from the Shareholder will be expressly authorising the Chair to exercise the proxy as he or she sees fit, even if the Resolution, is connected directly or indirectly with the remuneration of a member of the Company's key management personnel;
- (i) to be a valid appointment of a proxy, a proxy form must be signed by the Shareholder or the Shareholder's attorney. Proxies given by corporations must be signed either under section 127 of the *Corporations Act 2001* (Cth) (**Corporations Act**) or in accordance with the Constitution of the corporation. In the case of joint holdings, at least one of the joint holders must sign the proxy form;
- (j) if a proxy form is signed by a person who is not the registered Shareholder, then the relevant authority (e.g. in the case of proxy forms signed by an attorney, the power of attorney or a certified copy of the power of attorney) must either have been provided previously to the Company or be enclosed with the proxy form;

## EXPLANATORY STATEMENT

This Explanatory Statement contains an explanation of, and information about, the Resolutions to be considered at the 2023 Annual General meeting. Shareholders should read this Explanatory Statement in full. The Explanatory Statement forms part of the accompanying Notice of Meeting and should be read with the Notice of Meeting.

### Financial statements and reports

As required by the Corporations Act, the TerraCom Limited Annual Report (comprising the Financial Report, Directors' Report and Auditor's Report for the Company) for the year ended 30 June 2023 will be laid before the Meeting. There is no requirement for Shareholders to vote on these reports.

A copy of the 2023 Annual Report is available on the Company's website at [www.terra.com/resources.com](http://www.terra.com/resources.com) and on the ASX platform under the Company's code "TER".

Shareholders will be given a reasonable opportunity at the Meeting to ask questions about, and make comments on, the financial statements and reports.

Shareholders will also be given an opportunity at the Meeting to ask the Company's auditor, BDO, questions relevant to audit matters, including the Independent Auditor's Report.

In addition to taking questions at the Meeting, written questions may be sent by mail (to the Company's registered office) or by email ([info@terra.com/resources.com](mailto:info@terra.com/resources.com)) to the Chair or to the Company's auditor. Written questions to the auditor must be in relation to the content of the auditor's report and the conduct of the audit. All written questions to the Chair or the auditor should be submitted no later than 5 business days before the Meeting.

### Resolution 1 – Remuneration Report

The Remuneration Report is set out on pages 41 to 54 of the Company's 2023 Annual Report. A copy of the 2023 Annual Report is available on the Company's website at [www.terra.com/resources.com](http://www.terra.com/resources.com) and on the ASX platform under the Company's code "TER".

The Remuneration Report:

- explains the Board's policy in relation to the nature and level of remuneration paid to Directors and key management personnel (KMP) within the Company;
- discusses the link between the Board's remuneration policy and the Company's performance;
- provides a detailed summary of performance conditions, why they were chosen and how performance is measured against them; and
- sets out remuneration details for each Director and for each member of the Company's KMP.

A reasonable opportunity will be provided for discussion of the Remuneration Report at the 2023 Annual General Meeting.

### "Two Strikes" Rule

Section 250R(3) of the Corporations Act provides that the vote on the adoption of the Remuneration Report is for advisory purposes only and will not bind the Directors or the Company. However, under the Corporations Act, if a company's Remuneration Report receives an 'against' vote of 25% or more at two consecutive annual general meetings, a resolution must then be put to Shareholders at the later annual general meeting as to whether another meeting should be held (within 90 days) at which all Directors (other than the managing director) who were in office at the date of that resolution must stand for re-election. So, Shareholders will be entitled to vote in favour of holding a general meeting to re-elect the Board if the Remuneration Report receives "two strikes".

At the Company's 2022 Annual General Meeting, less than 25% of the votes cast opposed the adoption of the Remuneration Report and therefore the "two strikes" process was not invoked.

### Voting Prohibition Statement

In accordance with the Corporations Act, the Company will disregard any votes cast on Resolution 1:

- by or on behalf of a member of the Company's KMP (including Directors) details of whose remuneration are included in the Remuneration Report for the year ended 30 June 2023 or their Closely Related Parties, regardless of the capacity in which the vote is cast; or
- as a proxy by a person who is a member of the KMP at the date of the Meeting or their Closely Related Parties,

unless the vote is cast as proxy for a person entitled to vote on the Resolution:

- in accordance with a direction on the proxy form; or
- by the Chair of the Meeting where the appointment expressly authorises the chair to exercise the proxy, even if the Resolution is connected directly or indirectly with the remuneration of a member of the KMP.

**Closely Related Party** is defined in the Corporations Act and includes the KMP's spouse, dependents, and certain other close family members, as well as any companies controlled by a member of the KMP.

Noting that each Director has a personal interest in their own remuneration from the Company, as set out in the Remuneration Report, the Directors unanimously recommend Shareholders vote in **favour** of Resolution 1.

The Chair intends to vote all available proxies in **favour** of Resolution 1.

## **Resolution 2 – Re-Election of Mr Mark Lochtenberg**

In accordance with section 15.3(a) of the Company's Constitution, dealing with the retirement of Directors, Mr Mark Lochtenberg will retire from office at the 2023 Annual General Meeting.

In accordance with the requirements of section 15.3(c) of the Constitution, Mr Lochtenberg is eligible for re-election.

Information about Mr Lochtenberg is noted below. The Chair of the Meeting intends to vote all available proxies in **favour** of Resolution 2.

*Appointment Details:* Non-Executive Chairman, appointed 28 January 2022. The Company considers Mr Lochtenberg to be an independent director.

*Qualifications and Experience:* Mr Lochtenberg graduated with a Bachelor of Law (Hons) degree from Liverpool University, UK and has been actively involved in the coal industry for more than 25 years. He was the Executive Chairman and founding Managing Director of ASX Listed Cockatoo Coal Limited. He was also formerly the co-head of Glencore International AG's worldwide coal division, where he spent 13 years overseeing a range of trading activities including the identification, due diligence, negotiation, acquisition and aggregation of the coal project portfolio that would become Xstrata Coal. Prior to this, Mr Lochtenberg established a coal "swaps" market for Bain Refco, (Deutsche Bank) after having served as a senior coal trader for Hansen Neuerburg AG and as coal marketing manager for Peko Wallsend Limited.

*Other current directorships:* Mr Lochtenberg is currently Chairman of ASX Listed silver and gold producer Equus Mining Limited (ASX: EQE), ASX Listed Nickel Industries Ltd. (ASX: NIC) and Chairman of Montem Resources Limited.

*Former directorships (last 3 years):* Nil.

*Special responsibilities:* Chair of the Remuneration Committee.

The Directors (other than Mr Lochtenberg) unanimously endorse Mr Lochtenberg as a candidate for re-election and recommend shareholders vote in **favour** of Resolution 2.

## **Resolution 3 – Election of Directors**

As per section 15.1 of the Company's Constitution any Director, except the Managing Director, appointed during the year by the Directors of the Company, must be elected by shareholders at the next Annual General Meeting following his or her appointment.

Information about Directors standing for election are noted below. The Chair of the Meeting intends to vote all available proxies in **favour** of Resolutions 3a and 3b.

### **Resolution 3a – Election of Mr Mark Ludski**

*Appointment details:* Non-Executive, Independent Director, Appointed 7 December 2022.

*Qualifications and Experience:* Mr Ludski is a finance professional with in-excess of 30 years' corporate experience within ASX listed public companies and professional accounting firms gaining experience in capital management, governance related activities and providing audit, taxation and business advisory services. Mr Ludski is university degree qualified, a member of Chartered Accountants in Australia and New Zealand and the Australian Institute of Company Directors. Mark previously held the role of Chief Financial Officer for over 22 years with ASX Listed Company, Ainsworth Game Technology Limited (ASX: AGI). Mark still remains as Company Secretary with AGI, a role he has held for over 22 years.

*Other current directorships:* Non-Executive Director for Angel Action Pty Ltd as Trustee for The Ainsworth Foundation.

*Former directorships (last 3 years):* Nil.

*Special responsibilities:* Chair of the Audit Committee.

The Directors (other than Mr Ludski) unanimously endorse Mr Ludski as a candidate for election and recommend shareholders vote in **favour** of Resolution 3a.

### **Resolution 3b – Election of Mr David Norris**

*Appointment details:* Non-Executive Director, appointed 6 October 2023. Mr Norris is a representative of TerraCom substantial shareholder, the John Singleton Group, and for this reason is not deemed to be independent. At the date of this document, the John Singleton Group, via Bonython Coal No 1 Pty Ltd, own approximately 9.85% voting shares on issue in TerraCom.

*Qualifications and Experience:* David is a highly experienced financial professional with over 20 years' experience in board-level decision-making, investment strategies, and accounting practices. David has held prominent positions in various organisations, including Director at Deloitte and is currently CEO at the John Singleton Group. His experience enables him to analyse complex financial data and provide valuable insights to support strategic decision-making. David has a deep understanding of financial regulations, taxation and accounting principles, ensuring compliance and accurate financial reporting. In his current role, David is responsible for identifying investment opportunities, conducting due diligence, and implementing sound investment strategies. David holds a Bachelor's Degree in Commerce, and is a member of both the Chartered Accountants Australia New Zealand, and the Australian Institute of Company Directors. In his current role, David is actively involved as a director on multiple company boards and private equity funds.

*Other current directorships:* None noted.

*Former directorships (last 3 years):* None noted.

*Special responsibilities:* None noted.

The Directors (other than Mr Norris) unanimously endorse Mr Norris as a candidate for election and recommend shareholders vote in **favour** of Resolution 3b.

## Resolution 4 – Replacement of Constitution

### General

Under section 136(2) of the Corporations Act, a company may modify or repeal its constitution or a provision of its constitution by special resolution of Shareholders.

Resolution 4 seeks the approval of Shareholders to repeal the Company's existing Constitution dated 22 July 2010 (**Existing Constitution**) and adopt a new constitution (the **Proposed Constitution**), which is being updated to ensure that it reflects the current requirements of the Corporations Act, Listing Rules and good governance.

The Directors believe that it is preferable in the circumstances to replace the Existing Constitution with the Proposed Constitution, rather than to amend a multitude of specific rules.

The Proposed Constitution is broadly consistent with the provisions of the Existing Constitution. Accordingly, the Directors believe these amendments are not material nor will they have any significant impact on Shareholders.

A copy of the Proposed Constitution is available for review by Shareholders at the Company's website [www.terraacomresources.com](http://www.terraacomresources.com) and at the office of the Company. A copy of the Proposed Constitution can also be sent to Shareholders upon request to the Company Secretary at [cosecaus@terraacomresources.com](mailto:cosecaus@terraacomresources.com).

If Resolution 4 is passed, the Company will adopt the Proposed Constitution with effect from the date of the 2023 Annual General Meeting, being 29 November 2023.

### Summary of proposed changes

There are amendments that are not material or that have no material impact on Shareholders. These include:

- updating immaterial provisions to reflect the current position under the Corporations Act, Listing Rules and other applicable rules; and
- of a drafting, procedural or administrative nature.

The amendment which may be considered material is:

- although the Existing Constitution expressly provides for holding general meetings at two or more venues using technology, the provisions of the Proposed Constitution more clearly provide that any general meeting may be held virtually, using technology only, provided the technology gives members, as a whole, a reasonable opportunity to attend, participate, be heard and vote and otherwise meets applicable legal requirements.

### Additional information

Resolution 4 is a special resolution and therefore requires approval of 75% of the votes cast by Shareholders present and eligible to vote (in person, by proxy, by attorney or, in the case of a corporate Shareholder, by a corporate representative).

The Directors unanimously recommend that Shareholders vote in **favour** of Resolution 4.

The Chair of the Meeting intends to vote all available proxies in **favour** of Resolution 4.
