## Results and Adjournment of Meeting

Atomos Limited (**ASX: AMS**, 'Atomos' or the 'Company') is pleased to advise that resolutions 3 to 5 presented in the Notice of Meeting sent to shareholders, were put to shareholders at the Company's Annual General Meeting, held today.

The voting on these resolutions was conducted via a poll. The consideration of the FY23 financial report and the vote on Resolution 2 (the advisory vote on the Remuneration Report) were held over pending finalisation and release of the Company's annual report for FY23. Resolutions 3 and 5 were passed as ordinary resolutions and Resolution 4 was not passed as a special resolution of the Company.
