BTC Cardio enters into exclusive distribution agreement with Eurosets

Highlights:

- BTC Cardio granted exclusive sales and distribution rights to the Eurosets range of products in Australia and New Zealand

- TGA approved and available immediately in Australia

Melbourne, Australia: **BTC health** (ASX : BTC) (the **Company** or **BTC**) is pleased to announce that its wholly owned investee company, BTC Cardio Pty Ltd has entered into an agreement with Eurosets S.r.l. granting the company exclusive rights to sell and distribute its range of Cardiopulmonary and Extracorporeal Life Support systems in Australia and New Zealand.

Founded in 1991 and part of the GVN Care&Research Group, Eurosets is a leading Italian manufacturing company located in the biomedical district of Medolla. It is a supplier of high-quality oxygenators, including Horizon, Remowell 2 and Trilly 2, which are used extensively in cardiac surgery bypass procedures, as well as a complete range of systems, consumables, and accessories, including Ecmolife and Colibri for Extracorporeal Life Support (ECLS). ECLS is a technique of providing prolonged cardiac and respiratory support to persons whose heart and lungs are unable to provide an adequate amount of gas exchange or blood perfusion to sustain life. https://eurosets.com

During 2020/21, there were 12,700 coronary artery bypass graft procedures, 12,000 heart valve repair or replacement procedures, and 129 heart transplants performed in public and private hospitals across Australia¹. During the same year the national data base recorded 451 extra corporal membrane oxygenation (ECMO) patient cases from 28 hospitals in Australia². ECMO is one of the most expensive medical interventions, costing \$305,463 per complex admission to the intensive care unit³.

Eurosets was introduced to BTC Cardio by Tau Investments Australia, a strategic investor in BTC. The Ecmolife and Colibri systems, and the full range of Eurosets oxygenators are already approved by the Therapeutic Goods Administration and available for immediate sale in Australia.

Dr Richard Treagus, Executive Chairman commented, "This is a decisive step for BTC Cardio, our recently formed investee company, as we establish and build a strong presence in this highly specialized field of medical care. The Eurosets products represent the very best of medical innovation and quality, and importantly we share Euroset's vision of helping people get back to doing the things they love."
