# SRJ secures foothold in US market as first BoltEx® orders secured

## **HIGHLIGHTS**

- SRJ secures two contracts in the United States for supply of BoltEx® product
- Orders placed by two companies operating in American West and Gulf of Mexico
- Agreements mark SRJ's entry into US oil and gas markets

SRJ Technologies Group (ASX: SRJ; "SRJ" or "the Company") is pleased to announce the award of two contracts with US-based companies, marking SRJ's entrance to the US market.

A contract has been secured with Black Hills Energy Corp LLC (NYSE:BKH; "Black Hills Energy"), to support asset integrity management of their US gas distribution network.

Black Hills Energy is a producer and distributer of natural gas and electricity, servicing 1.3 million customers in eight states across the US.

A contract has also been secured with Magnolia Torque and Testing Inc for the supply of BoltEx® flange clamps to support maintenance work offshore in the Gulf of Mexico.

Magnolia is a maintenance and repair contractor specialising in Flange Management Services, and clients including BP, Shell, Chevron, OXY and ConocoPhillips.

The combined value of both contracts is AUD\$225k (USD\$126k).

Both Magnolia and Black Hills Energy recognised the economic value and enhanced safety benefits of using BoltEx® for ongoing upkeep of pipework and pipeline systems.

SRJ's BoltEx® flange clamps will enable both companies to undertake maintenance and repair work while avoiding costly operational outages.

The order is subject to SRJ's standard terms and conditions for a product sale as detailed on its website.
