## Re: Southern Cross Media Group Ltd (ASX: SXL)

We refer to the Form 604: Notice of change of interests of substantial holder lodged by Allan Gray Australia Pty Limited (**Allan Gray Australia**) and its related bodies corporate (together, the **Allan Gray Group**) on 22 June 2023 with respect to their relevant interests in Southern Cross Media Group Limited (**SXL**) ordinary shares (the **June Notice**).

The June Notice disclosed that the Allan Gray Group had as at 20 June 2023 a relevant interest in 39,431,083 ordinary shares in SXL, representing voting power of 16.44%. The June Notice did not, however, take into account the Allan Gray Group's deemed relevant interest in SXL shares held by ARN Media Limited (A1N) and its associates (such SXL shares representing 14.8% voting power), which arose under section 608(3)(a) of the Corporations Act 2001 (Cth) (the Act) as a result of Allan Gray Group having a greater than 20% relevant interest and voting power in A1N at that time (specifically 20.04% at the time). At no time did the Allan Gray Group have any power to control the right to vote attaching to, or the disposal of, any SXL shares held by A1N and its associates. A corrected June Notice appears as Annexure A to this letter.

On 31 October 2023, the Allan Gray Group's relevant interest in A1N shares and voting power fell below 20% and accordingly the Allan Gray Group was no longer deemed to hold a relevant interest in SXL shares held by A1N and its associates under section 608(3)(a) of the Act. A further Form 604: Notice of change of interests of substantial holder reflecting the Allan Gray Group's relevant interest in SXL shares as at, and its corresponding voting power as at, 31 October 2023 (the **October Notice**) appears as **Annexure B**.

The Allan Gray Group filed a Form 604: Notice of change of interests of substantial holder on 21 November 2023 disclosing Allan Gray Group's relevant interest in 28,714,488 ordinary shares in SXL as at 17 November 2023, representing a voting power of 11.97% (the **November Notice**). For clarity, having regard to the corrected June Notice and new October Notice annexed this letter, we have restated the November Notice as **Annexure C**. The original June Notice lodged on 22 June 2023 and original November Notice lodged on 21 November 2023 may be disregarded.
