

ASX Announcement: 5GN announces acquisition of Security Shift for \$4M

On 16th January 2024 5G Networks Limited (ASX:5GN) (**5GN**) Acquired Security Shift Pty Ltd and associated entities for \$4m representing a 3 times EBITDA multiple or 1 times revenue.

The Transaction will be funded from existing cash reserves and \$1.24m in shares in 5GN. The total Cash payments consist of an upfront payment of \$1.66m and two deferred payments of \$550k payable over the next two years.
