# 1H24 Guidance Update - Revenue Growth Continues

Aerometrex Limited (ASX: AMX) is pleased to provide an update on preliminary unaudited guidance for 1H24 results.

## Preliminary 1H24 financial guidance:

Aerometrex expects to report a record first half (1H) revenue outcome, driven by strong ongoing performance of the LiDAR and MetroMap product lines.

# Commenting on the unaudited 1H24 results, Aerometrex Managing Director Steve Masters said:

"Our estimated 1H24 outcomes have continued to build on the ongoing organisational and operational enhancements across the business. I am very pleased with what we are seeing in the estimated financial results for 1H24 which provides a solid foundation into 2H24.

Record first half revenue outcomes for our MetroMap and LiDAR product lines are expected to be reported, with MetroMap Annual Recurring Revenue (ARR) continuing its growth trajectory."

Aerometrex will release its 1H24 financial result in February 2024 following completion of the audit review.

This release is approved by the Board of Directors of Aerometrex Limited.
