I would like to thank my peers and the Board for the opportunity to be part of Boral's 'Good to Great' journey and I am committed to ensuring a seamless and successful CFO transition."

Vik Bansal, CEO & Managing Director said: "Over the past couple of months, we have assisted and explored various options to keep Belinda at Boral. I appreciate that this decision was very difficult and while I'm disappointed, I fully support and respect her decision. I wish her well in her future endeavours."

"Meanwhile, I am pleased to confirm that Stefan Camphausen will join Boral as Chief Financial Officer. I welcome Stefan to Boral and look forward to working with him."

Stefan is an experienced executive and has a considerable background as a CFO of complex industrial organisations in Australia and in Europe, leading large finance teams. His most recent role is as CFO of Bapcor, an ASX-listed firm.
