## Janison signs agreement with the NSW Department of Education to deliver computer-based selective education placement tests

**The agreement is expected to generate up to A\$45M in revenue, provided all work stages are approved.**

**Janison Education Group Limited** (ASX:JAN) ("**Janison**" or the "**Company**"), announces that it has signed an agreement with the NSW Department of Education (the department) and Cambridge University Press & Assessment (Cambridge) to deliver the state's selective education placement tests as computer-based test via Janison's digital assessment platform.

Following a competitive tender process, the department has appointed Janison to provide a range of services to deliver computer-based testing for over 30,000 students each year for NSW's Selective High School and Opportunity Class Placement Tests from 2025. These services include providing the placement tests, the computer-based test platform, and managing the test centres including invigilation.

*"Janison is delighted to have been selected by the department to host the placement tests and support the digital transformation of testing in NSW. This 5-year agreement extends the 20-plus years relationship that Janison and the department have worked together",* commented Wayne Houlden, Founder and interim Managing Director of Janison.

This is the largest contract signed in the Company's history and demonstrates the value of Janison's digital assessment platform for hosting high stakes assessments. The contract further bolsters Janison's relationship with Cambridge by working with them to deliver the placement test specification design, test content development, paneling, marking, and scoring.

The agreement is expected to generate revenue of up to A\$45M over the initial 5-year term (provided all stages are approved) with an option for the department to extend for a further 5-year term. Janison expects work to commence on the new platform and services early in 2024, with key deliverables including:

- the digitisation of test administration procedures,
- the development of an on-demand practice-test environment,
- the implementation, configuration, and piloting of the delivery platform.

Janison expects pilots of the new platform to be concluded in 2024. A full rollout of the digital assessment platform for the department will be completed in 2025.

## Background

All NSW public schools support high-potential and gifted students. Opportunity classes, selective high schools, and placement tests form part of the department's commitment to identify, and provide a range of opportunities for, academically high-potential and gifted students in NSW.

The department currently delivers the Selective High-School and Opportunity Class Placement Tests to over 30,000 students in paper-based format on one single day each year.

Janison's digital assessment platform offers many benefits over paper-based tests including increased efficiency, flexibility, security, and accessibility, while also providing a more engaging and interactive testing experience. Janison's platform is trusted by governments and educational bodies globally.

Janison and Cambridge University Press & Assessment (Cambridge) have worked on previous projects together.
