## Alcidion signs \$3.4M contract extension with DGT NHS Trust

- Alcidion extends contract with Dartford and Gravesham NHS Trust for an additional 3 years for Miya Precision and associated modules to deliver electronic observations and assessments, manage patient flow and support electronic documentation
- The contract value is \$3.4M (£1.7M) over the new contract period of 3 years
- The contract extension will include a move to cloud based delivery

**Melbourne, Victoria:** Alcidion Group Limited (ASX:ALC) today advises it has signed a contract extension with Dartford and Gravesham NHS Trust ("DGT") for use of its Miya Precision platform including the modules Flow, Access, Command, Observations, Assessments, eNoting and some associated partner products.

DGT was the first Miya Precision implementation in the UK. They initially contracted in March 2019 for Miya Precision to cover their needs for electronic observations, assessments, clinical noting and patient flow. This initial contract had a five-year term which expires in early March. Subsequent additional Miya Precision and partner modules such as Emergency Department and Order Comms were added to scope during the initial term between Alcidion and DGT.

DGT have successfully deployed Miya Precision to support their digital strategy. Miya Precision has been used to support digitising care including electronic observations, digital patient assessment and patient flow. The success of the modular approach positions DGT well for future enhancement to its digital strategy.

Alcidion Group Managing Director, Kate Quirke, said: "We have a long-standing partnership with DGT and we are pleased to be able to extend the arrangement allowing DGT to continue to gain the value of improved patient flow and support for their clinical staff, ultimately benefitting patient care."
