In determining the number of votes cast on the resolutions of Scentre Group Trust 1, Scentre Group Trust 3, each SCG securityholder has 1 vote for each dollar value of the total units they have in Scentre Group Trust 1, Scentre Group Trust 2 or Scentre Group Trust 2 or Scentre Group Trust 3 (as applicable). The value of units for the relevant Trust is the proportion of the last sale price of SCG securities on the ASX on Wednesday, 3 April 2024 attributed to the units in the Trust, equal to the proportion of the last published net asset value of the Trust bears to the last published aggregate net asset value of SCG.
