## LETTER FROM THE CHAIR

1 August 2024

#### Dear Securityholder

On behalf of the Boards of Arena REIT Limited and Arena REIT Management Limited, the responsible entity for the trusts that comprise Arena REIT ("Arena REIT"), I am pleased to offer you the opportunity to participate in this Security Purchase Plan ("SPP").

Arena REIT recently conducted a fully underwritten institutional placement of approximately 31.7 million Securities at \$3.78 per Security, raising \$120 million ("Institutional Placement").

It is intended that the proceeds from the Institutional Placement and SPP will provide capacity to fund the acquisition and development of:

- six early learning centre properties for a total investment of \$58 million; and
- four early learning centre developments with total anticipated project investment of \$34 million,

and to increase balance sheet capacity to accommodate pipeline growth and execute future opportunities consistent with Arena's investment objective to provide predictable distributions with earnings growth prospects over the medium to long term. You can obtain more information about the Institutional Placement, and some of the key risks associated with an investment in Securities, in the presentation released by Arena REIT to the ASX on 23 July 2024.

#### The offer

The SPP is offered exclusively to all Eligible Securityholders, being registered holders as at 7pm (Sydney time) on Tuesday 22 July 2024 ("Record Date") with a registered address in Australia or New Zealand. For New Zealand Securityholders, you must still be a Securityholder on the date of this letter. Certain Eligible Securityholders who are custodians holding Securities on behalf of certain beneficiaries are also offered the opportunity to participate in the SPP in accordance with the Terms and Conditions. Excluded Securityholders (as defined in the Terms and Conditions) will not be invited to participate in the SPP.

The SPP provides Eligible Securityholders with an opportunity to contribute \$2,500, \$5,000, \$10,000, \$15,000, \$20,000, \$25,000 or \$30,000 in applying for new Securities.

The issue price of Securities under the SPP will be \$3.78 per Security ("Issue Price"). This is the same price as the Institutional Placement, calculated as a 4.5% discount to the last closing price of \$3.96 on 22 July 2024, and a 5.1% discount to the 5 day volume weighted average price of \$3.9844 to 22 July 2024. The Issue Date of the Securities issued under the SPP will be 27 August 2024 and these Securities will not be eligible to participate in Arena's distribution for the six months ending 30 June 2024 (which is scheduled to be paid on 8 August 2024).

The Issue Price may differ from the market price of Securities on the day Securities are issued or allotted to you. The market price or value of Securities is subject to market volatility. It may be higher or lower, at any time, than the Issue Price of the Securities you receive. The market price may change between the date the Securities are offered and the date the Securities are issued or allotted to you under the SPP.

The SPP is not underwritten and the total amount to be raised under the SPP will be up to \$20 million.

However, if demand exceeds \$20 million:

- Arena REIT may scale back Applications. If this happens, you may be allocated fewer Securities under the SPP than the
  parcel of Securities for which you applied, and you will be refunded the difference in the Application amount (without
  interest payable on funds prior to your refund). Any scale back will be applied on a pro rata basis to all participants having
  regard to their existing Security holding as at the Record Date; or
- Arena REIT may (in its absolute discretion) determine to increase the amount raised to reduce or eliminate the need to scale back Applications.

Participation in the SPP is entirely voluntary. All Securities issued under the SPP will rank equally with existing fully paid Securities and will carry the same voting rights and entitlement to receive distributions from 27 August 2024.

No brokerage, commissions or other transaction costs apply to purchases under the SPP.

#### How to accept this offer

To apply for Securities under the SPP, you must make payment directly via BPAY or EFT (for Eligible Securityholders in New Zealand who are unable to pay by BPAY).

This letter and its attachments set out the details and Terms and Conditions of the SPP. I encourage you to read the enclosed material, as well as the investor presentation (including the 'Key Risks' section) released by Arena REIT to the ASX on 23 July 2024 and seek your own financial and tax advice in relation to the offer, before you decide whether to participate.

#### 1 Offer timetable

- 1.1 This offer is dated, and taken to be made on 1 August 2024.
- 1.2 The offer opens at 9am (Sydney time) on 1 August 2024 ("Opening Date") and closes at 5pm (Sydney time) on 22 August 2024 ("Closing Date"). BPAY and EFT payments may not be processed and may not be valid if they have not been received by the Closing Date.
- 1.3 Any reduction in allotments or acceptance of over subscription of Securities under the SPP is proposed to be announced prior to the Issue Date.
- 1.4 (a) The Securities will be issued on the Issue Date.(b) It is expected that the Securities will be allotted on the Issue Date.
  - (c) A transaction confirmation is expected to be dispatched to you on or around the Dispatch Date.

#### 2 Eligible Securityholders

- 2.1 You may only participate in the SPP if you are an Eligible Securityholder.
- 2.2 Subject to clause 2.4, Eligible Securityholders who receive more than one offer under the SPP (for example, because they hold Securities in more than one capacity or in different registered holdings) may apply on different Application Forms for Securities under the SPP but may not apply for Securities under the SPP with an aggregate value of more than \$30,000 across all of their holdings.
- 2.3 If two or more persons are recorded in Arena REIT's security register as jointly holding Securities, they are taken to be a single registered holder of Securities for the purposes of the SPP and they are entitled to participate in the SPP in respect of that holding as a single holding only. If as joint holders you receive more than one offer under the SPP due to multiple identical holdings, you may still only contribute a maximum of \$30,000 in applying for Securities. An agreement, representation, acknowledgement or certification given by any joint holder of Securities is taken to be an agreement, representation, acknowledgement or certification given by all joint holders.

- 2.4 If you are a custodian, trustee or nominee within the definition of "custodian" in ASIC Corporations Instrument 2019/547 ("Custodian"), you may contribute a maximum of \$30,000 in applying for Securities under the SPP for each participating beneficiary on whose behalf you or a downstream custodian holds Securities (with joint holders taken to be a single holder). If you are not a Custodian, the rules for multiple single holdings apply and you may only contribute a maximum of \$30,000 in applying for Securities. - 2.5 If you are an Eligible Securityholder, your rights under this offer are personal to you and nonrenounceable, so you may not transfer them.
- 2.6 The offer under the SPP is made on the same Terms and Conditions to each Eligible Securityholder (whether you are a Custodian or hold Securities on your own account).

#### 3 Applications for Securities

#### Limitations on Applications

- 3.1 Subject to clause 3.2, if you are an Eligible Securityholder, you may apply to purchase a parcel of Securities valued at \$2,500, \$5,000, \$10,000, \$15,000, \$20,000, \$25,000 or \$30,000 under the SPP.
- 3.2 This parcel may be subject to scaling back and rounding.

#### **Paying for Securities**

- 3.3 If you wish to participate in the SPP, you must make payment by:
  - (a) BPAY if you have an Australian bank account enabled for this purpose on or after 1 August 2024. BPAY customers must use the unique customer reference

number shown on the instructions to the Application Form which is required to identify your holding; or

(b) If you are an Eligible Securityholder in New Zealand and are unable to pay by BPAY you may pay by EFT. #### Representations in respect of Applications

- 3.4 If you submit an Application, in addition to any representations set out in the Application Form, you represent to Arena REIT that the total of the Application price for the following does not exceed \$30,000:
  - (a) the Securities you are applying for;
  - (b) any other Securities you are applying for under the SPP, or Securities or interests in the class issued under a similar arrangement in the 12 months before your Application under the SPP;
  - (c) any other Securities in the class which you have instructed a Custodian to acquire on your behalf under the SPP; and
  - (d) any other Securities or interests in the class issued to a Custodian under an arrangement similar to the SPP in the 12 months before your Application under the SPP as a result of you instructing the Custodian or another Custodian, which resulted in you holding a beneficial interest in the Securities or in the class.

#### Arena REIT's rights in respect of Applications

- 3.5 Arena REIT may reject, cancel or terminate your Application to purchase Securities under the SPP, including if:

  - **(b)** unless you are applying as a Custodian, you are applying to buy more than \$30,000 (in aggregate) of Securities under the SPP;

  - (e) Arena REIT has reasonable grounds to believe that you are not an Eligible Securityholder (subject to compliance with any law, applicable ASIC or ASX requirements); or

(f) if Arena REIT is required to reject Applications under, or in order to comply with, ASIC Corporations Instrument 2019/547.

#### Amount to be raised and scale back

- 3.6 Subject to clause 3.7, Arena REIT has determined that the amount raised through the SPP will be up to \$20 million. If demand exceeds \$20 million, Arena REIT may either:
  - (a) scale back Applications; or
  - (b) increase the amount raised to reduce or eliminate the need to scale back Applications.
- 3.7 If there is a scale back you may not receive all the Securities for which you have applied. Any scale back will be applied on a pro rata basis to all participants having regard to their existing Security holding as at the Record Date (and subject to each Eligible Securityholder's \$30,000 participation limit). If a scale back produces a fractional number when applied to your Parcel, the number of Securities you will be allotted will be rounded.
- 3.8 If there is a scale back, Arena REIT will refund to you by direct credit deposit to your nominated bank account, the difference between your Application money and the total Issue Price for the Securities allotted to you under the SPP (provided that you will not receive a refund for an amount which is less than the Issue Price of one Security).

#### Interest

3.9 No interest will be paid on any Application money returned to you.

#### Significance of applying for Securities
