Titomic makes further advances in the U.S. aerospace and defence industries

Titomic receives purchase orders worth A\$577k from global U.S. aerospace and defence prime

Highlights:

- Titomic receives further purchase orders from a global U.S. aerospace and defence prime totalling A\$577k.
- These orders represent a significant milestone in the Company’s relationship with this global U.S. aerospace and defence prime reflecting a qualification period spanning several years with this order taking cumulative orders on this project to over A\$1.0 million.
- Titomic has recently seen success across several other defence and aerospace projects including its first sale to Triton Systems, OMIC R&D and the launch of its joint venture with Repkon in recent months.
- The A\$577K order adds to the overall positive momentum in Titomic’s business with the Company having received A\$8.0 million in new orders since March this year.
