## SCHEME BECOMES LEGALLY EFFECTIVE

**APM Human Services International Limited** (ASX: APM; 'APM') refers to its announcement made earlier today and confirms that it has lodged with the Australian Securities and Investments Commission (**ASIC**) an office copy of the orders made by the Supreme Court of New South Wales (**Court**) approving the proposed acquisition by Ancora BidCo Pty Ltd, a wholly-owned indirect subsidiary of funds managed and advised by Madison Dearborn Partners, LLC (**MDP**), of all of the shares of APM not already held by MDP or its affiliates, by way of a scheme of arrangement under part 5.1 of the *Corporations Act 2001* (Cth) (**Scheme**).

Unless defined otherwise in this announcement, capitalised terms have the meanings given to them in the scheme booklet dated 16 August 2024.

### Lodgement of Court orders and suspension of trading

An office copy of the Court orders lodged with ASIC is attached to this announcement as **Annexure A**.

The Scheme is now legally Effective, and it is expected that quotation of APM Shares will be suspended from the close of trading today, Wednesday, 25 September 2024.

### Payment of Scheme Consideration

APM Shareholders will be provided the Scheme Consideration (being either the All Cash Consideration, the Mixed Consideration, or the All Scrip Consideration, as applicable) on Implementation of the Scheme, which is expected to take place on Thursday, 10 October 2024 in respect of APM Shares held at the Scheme Record Time of 7:00 pm (Sydney time) on 30 September 2024.

Any changes to the timeline set out above will be announced by APM on the ASX.

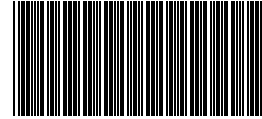

THE COURT ORDERS THAT:

1 Pursuant to section 411(4)(b) of the Corporations Act 2001 (Cth) (the Act), the scheme of arrangement between APM Human Services International Ltd ACN 639 621 766 (APM) and Scheme Shareholders (as defined in the Scheme), the terms of which are contained in Attachment B to the Scheme Booklet dated 13 August 2024 (a copy of which is Exhibit 1 in the proceeding) (Scheme), as amended by Order 2 below, be approved.
