**BIGRLYI DRILLING YIELDS MORE
OUTSTANDING RESULTS**

HIGHLIGHTS

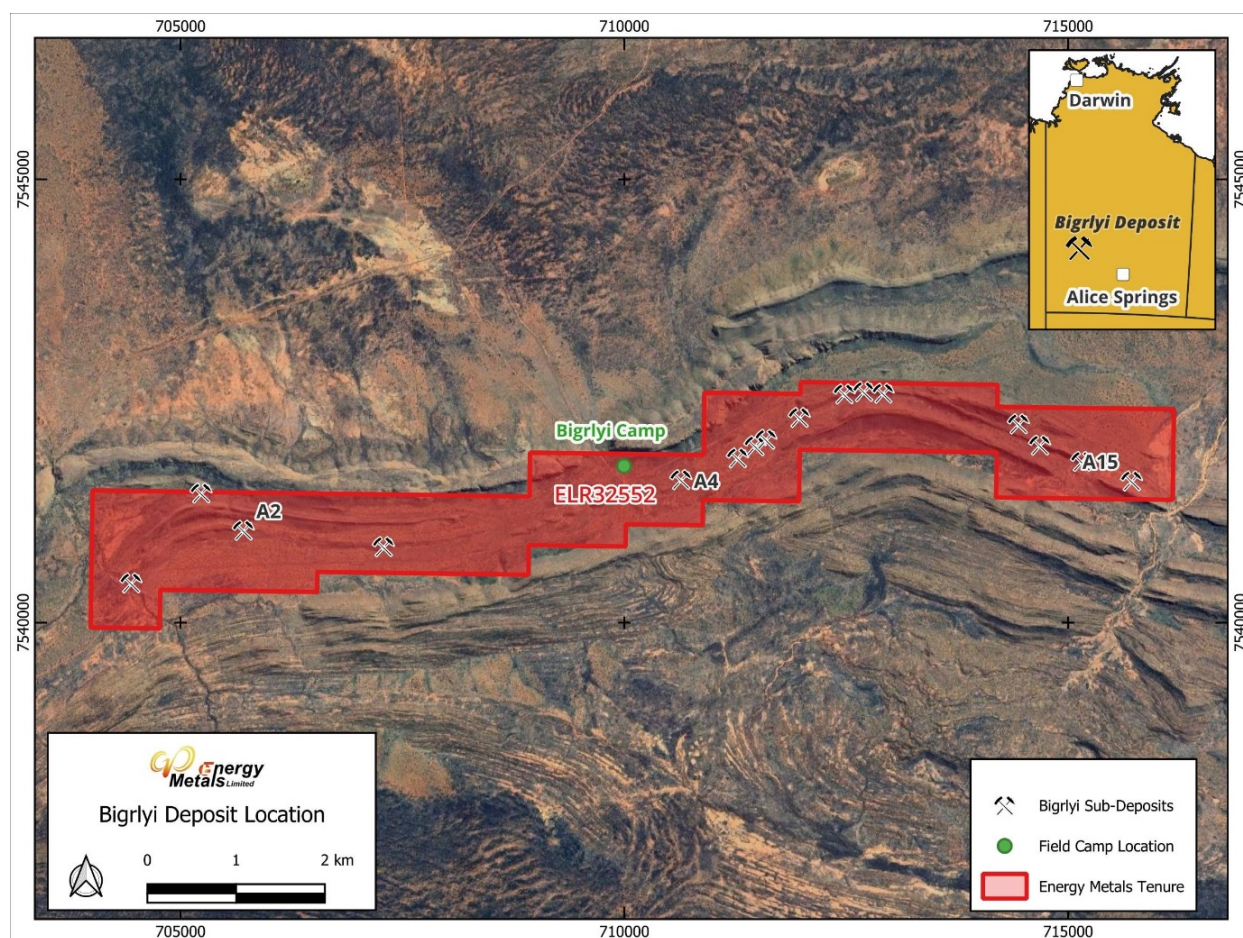
- **Multiple drillholes strike high-grade uranium mineralisation at the A2, A4, and A15 sub-deposits.**
- **All three sub-deposits delivered outstanding results in excess of 1% eU₃O₈.**
- **BRC2430 returned 5.1m at 4,500ppm eU₃O₈ (with a maximum of 14,500ppm eU₃O₈) from 129m depth at the A2 sub-deposit.**
- **BRD2415 returned 5.0m at 3,400ppm eU₃O₈ at the A4 sub-deposit.**
- **BRC2428 returned 1.1m at 8,600ppm eU₃O₈ (with a maximum of 21,200ppm eU₃O₈) from 129m depth at the A15 sub-deposit.**
- **The 2024 drilling program has now concluded with all samples delivered to the laboratory and chemical assays in progress.**
- **Equivalent U₃O₈ concentrations (eU₃O₈) have been calculated from downhole gamma surveys.**

Australian uranium exploration company **Energy Metals Limited (ASX: EME; Energy Metals or the Company)** is pleased to announce more outstanding results from its resource extension drilling campaign at the Bigrlyi Project.

Located in the Ngalia Basin – approximately 350km northwest of Alice Springs, the Project is classified as a sandstone-hosted uranium and vanadium deposit, occurring within the sub-vertical Mt Eclipse sandstone, which contains a sequence of medium-to-coarse grained felspathic sandstones. The Project is a joint venture (JV) between Energy Metals (72.4%), NT Uranium (20.8%), and Noble Investments (6.8%).

In July 2024, Energy Metals commenced its drilling campaign to grow the uranium resource at Bigrlyi, which is currently 6.32Mt at an average grade of 1,530ppm for 9.66Kt (21.3 MLbs) contained U_3O_8 using a 500ppm cut-off¹. The MRE comprises 18.2% Measured Resource, 54.3% Indicated Resource, with the remaining 27.5% classified as Inferred Resource (see Table 3 for details).

Commenting on the drilling results, Managing Director Shubiao Tao said: *“The drilling results at Bigrlyi have been outstanding this year, with grades from the A2, A4, and A15 sub-deposits all exceeding 500 ppm. More importantly, all sub-deposits returned a high-grade result over 1% eU_3O_8 . These results not only confirm the continuity of the Bigrlyi deposits but also boost our confidence in the potential for further resource growth at Bigrlyi”.*

The Company has completed 11,055m of RC and diamond drilling in 2024, targeting three sub-deposits with good potential for resource growth. These sub-deposits, known as A2, A4, and A15, are shown on the location map above (see Figure 1). Selected drilling samples have been submitted to a commercial laboratory in Adelaide for chemical assays, with the analyses currently in progress.

The completed drillholes have been surveyed with calibrated downhole gamma probes which can be used to calculate an equivalent U_3O_8 concentration (eU_3O_8) based on the downhole gamma response. This is a widely used technique in uranium exploration which provides rapid results with good levels of precision and accuracy provided uranium radioactive daughter decay products are all in secular equilibrium, which is known to be the case at Bigrlyi. It should be noted that the model of gamma probe used at Bigrlyi may become over-saturated in zones of very high radioactivity ($>1\%$ eU_3O_8) potentially leading to under-estimation of eU_3O_8 grade in these zones. Chemical assays of drill core or drill chips are utilised as a validation method; however, because of the penetrative nature of gamma rays, eU_3O_8 values relate to a larger sample volume than chemical assays and are often considered more representative.

Outstanding results were delivered from all three sub-deposits, with drillholes regularly exceeding 10,000ppm (1%) eU_3O_8 . Intersections reported include BRC2430, an RC hole in the centre of the A2 subdeposit, which returned **5.1m at 4,500ppm eU_3O_8** from 129.1m downhole. This includes a high-grade core of 0.6m at 12,600ppm eU_3O_8 from a depth of 129.7m, with the true width of the full intersection estimated to be 4.1m. This ranks in the top five best intersections recorded at A2 since its discovery.

Following on from the recently reported² results at A4, BRD2415 returned **5m at 3,400ppm eU_3O_8** from 428.7m downhole. This intersection comes from a diamond drillhole 100m northeast along strike from those outstanding results in BRD2408 (10.6m at 8,600ppm eU_3O_8) and BRD2409 (5.3m at 6,100ppm eU_3O_8) and demonstrates the volume potential of this under-explored high-grade zone.

There were two standout intersections at A15 with BRD2417 returning **1.8m at 5,500ppm eU_3O_8** from 375.9m downhole, and BRC2428 returning **1.1m at 8,600ppm eU_3O_8** from 128.7m downhole.

Seven RC holes were completed at A2, with four returning significant intersections above the threshold of 500ppm average grade and 0.5m downhole width. Of the remaining three holes, two had no significant intersections (NSI) while the third (BRC2429) was unable to be gamma surveyed due to silted inner tubes. BRC2429 may still return significant intersections once the chemical assays are received. In addition, two RC holes at A2 were suspended before hitting the target depth due to difficult ground conditions. These will be completed with diamond tails in a future drilling program.

Nine diamond drillholes were completed at A4, of which seven returned significant intersections as defined above. The remaining two holes had NSI and were both impacted by localised faulting which offset the targeted ore zones. Another six RC pre-collars were drilled for diamond tails not completed during this program. Further work will take place on these when drilling resumes in Q2 of 2025.

Three diamond drillholes were completed at A15, with two RC precollars drilled awaiting future diamond tails. Additionally, seven RC exploration holes were also completed at A15. The majority of drillholes at A15 targeted a complex fault-offset area at A15 East. Eight of the ten holes completed at A15 returned NSI – all from A15 East where it appears the geological model requires revision to improve future targeting.

The exploration team are now awaiting receipt of chemical assay results from the laboratory, which will enable them to finalise their interpretation and begin the process of updating wireframes and geological models. Once complete, a revised MRE will be calculated for Bigrlyi. Planning for further drilling next year at Bigrlyi and the surrounding regional tenement package has already begun, with an expected start date early in Q2 2025 once the Northern Territory wet season has finished and access can be established.

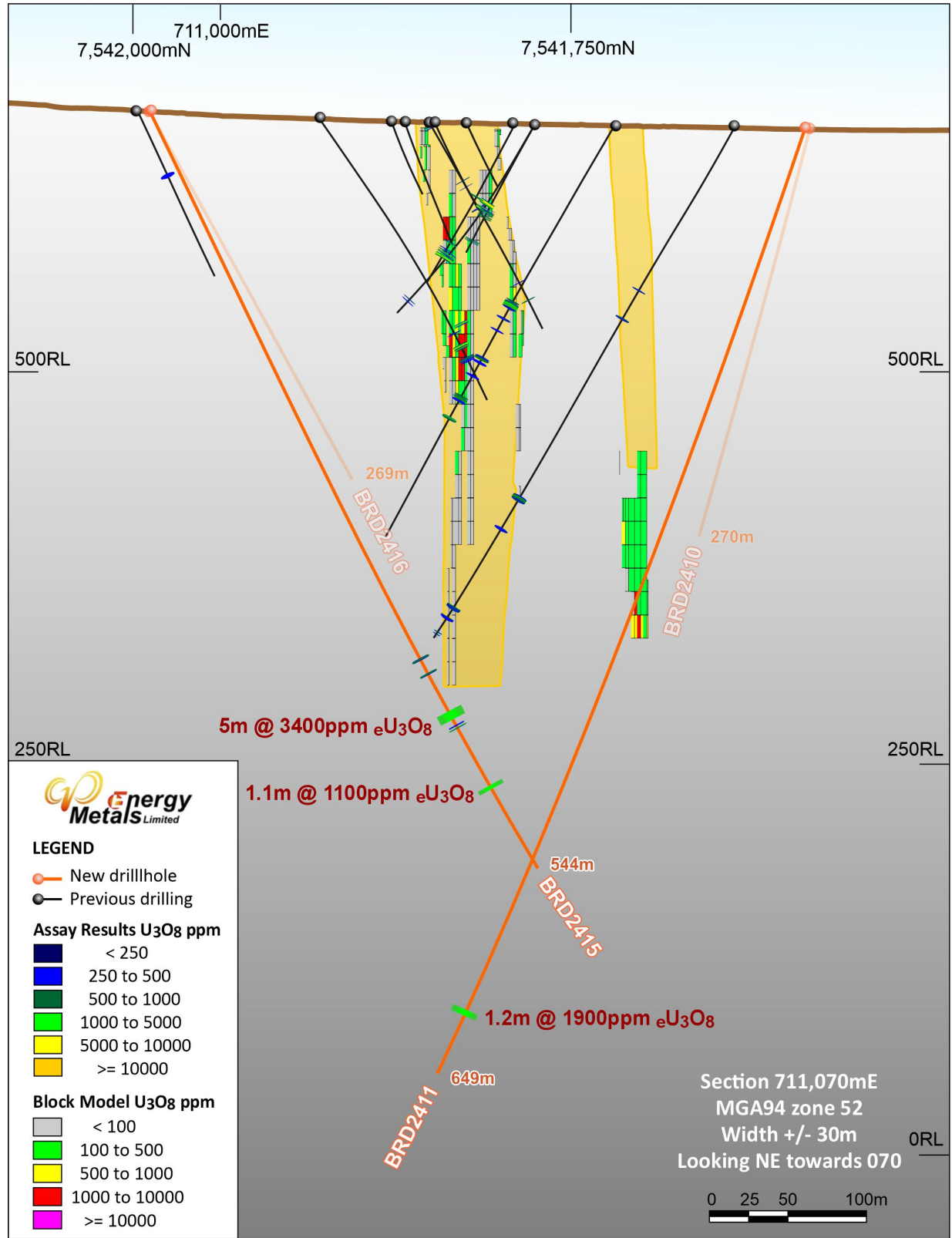

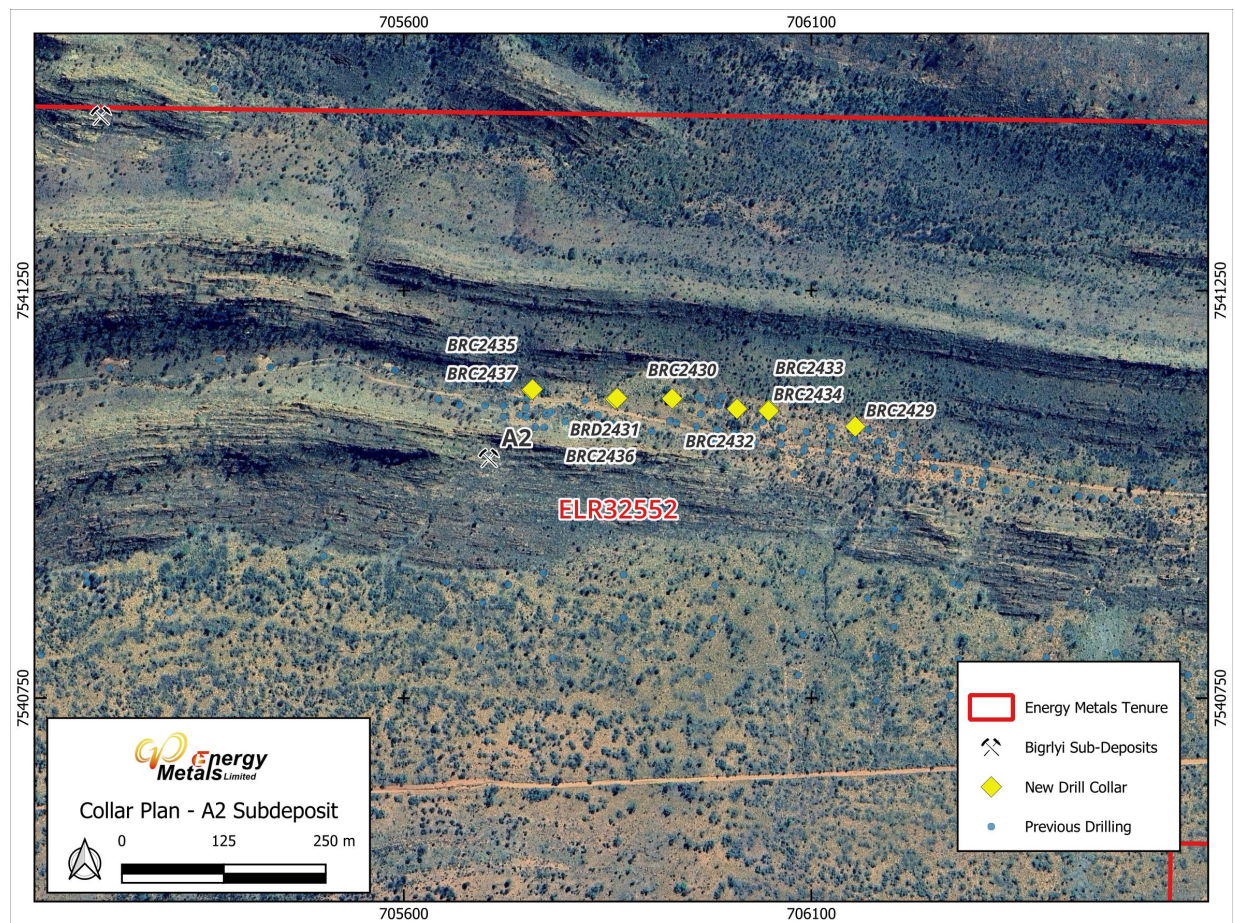

Figure 4B: Collar Plan Map for Recent Drillholes at A4

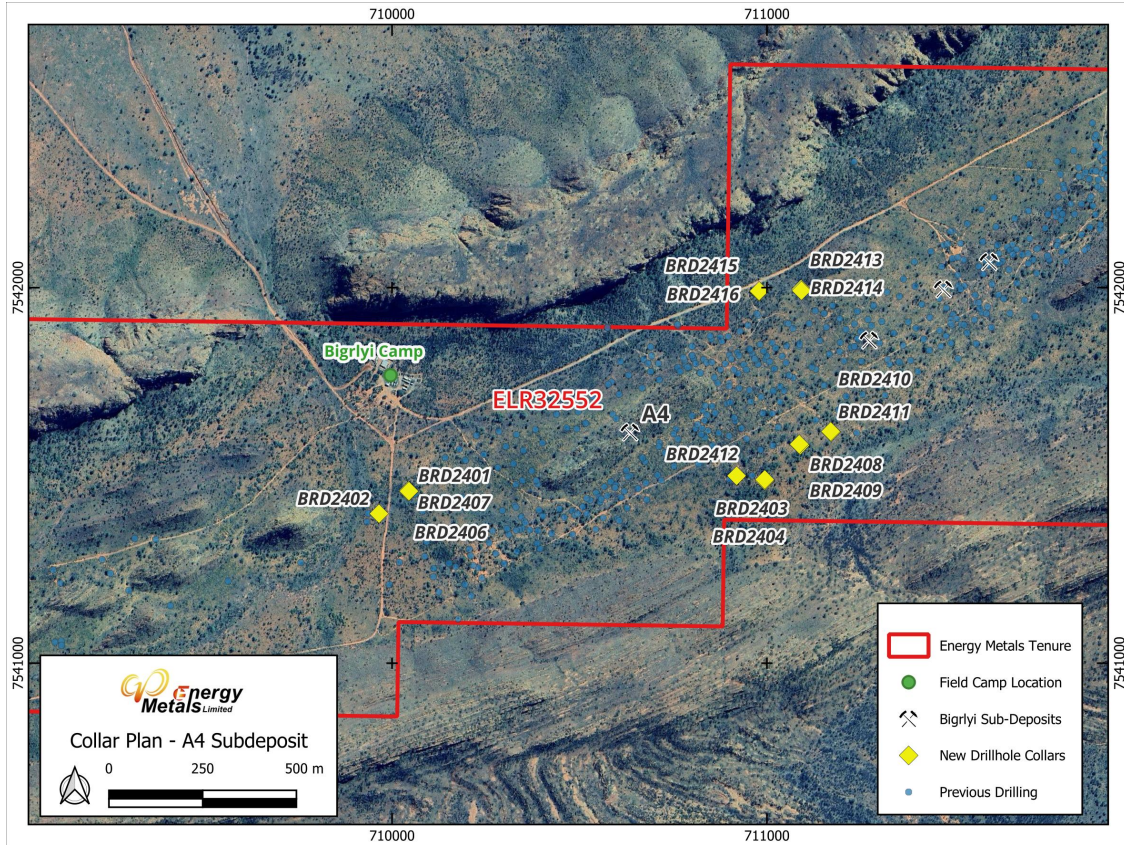
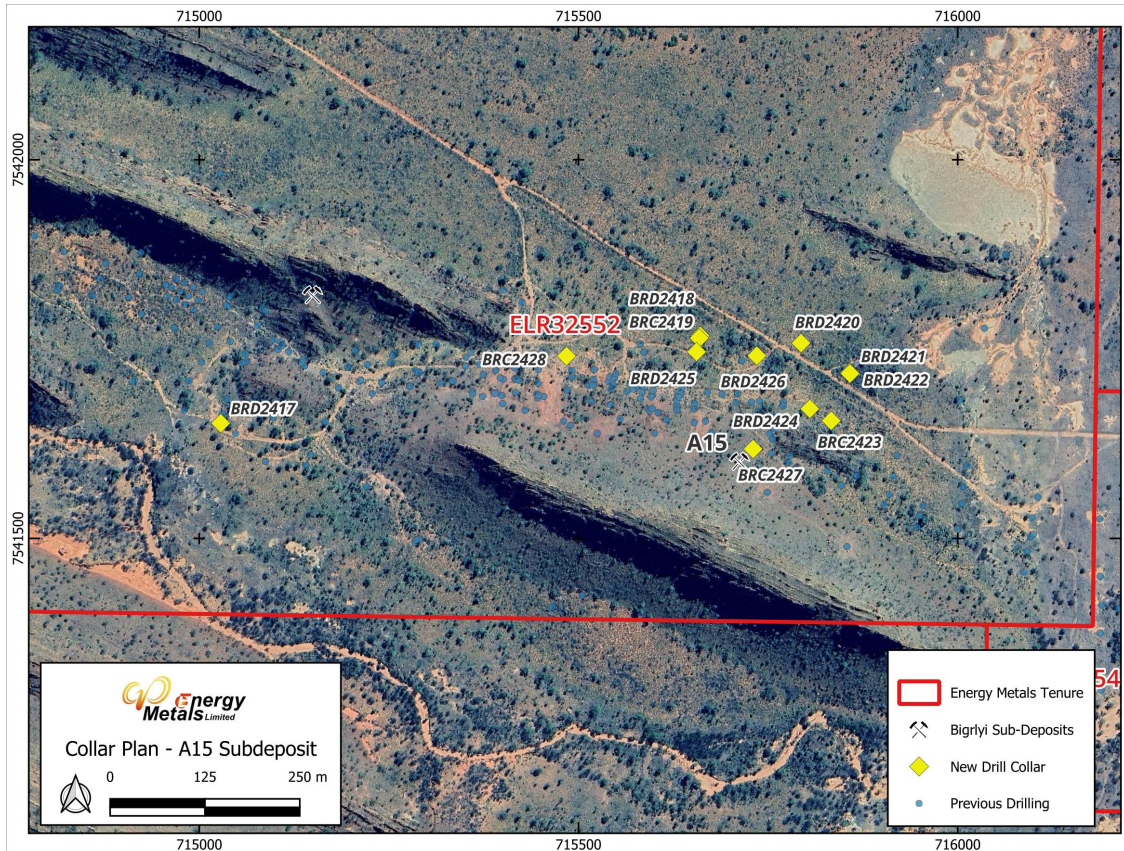


Figure 5C: Collar Plan Map for Recent Drillholes at A15

These background gamma rays add the equivalent of a few parts per million to the equivalent uranium values and are relatively constant in each geological unit. This technique is widely used in uranium exploration. The technique can be considered equivalent to a total digest since the uranium in fresh rock at Bigrlyi is in equilibrium

The probes are run at speeds not exceeding 10m per minute and collect data at 5cm intervals. The probes were initially calibrated at the Adelaide Calibration Model pits in Adelaide, South Australia, and the calibration checked on an ongoing basis using API standard reference materials. In addition, Energy Metals maintains a reference borehole on site which is used to compare probes, test for instrument drift over time, and confirm eU₃O₈ correction factors. The company plans to engage an independent contractor to carry out gamma logging of selected drillholes on completion of the program for validation purposes, however this work has not been carried out yet. Gamma measurements are converted to equivalent U₃O₈ values (eU₃O₈) by an algorithm that takes into account the probe and crystal used, density, hole diameter, ground water where applicable and drill rod or PVC pipe thickness. Down-hole gamma probe data is also de-convolved to more accurately reflect the true thickness of mineralisation due to edge smearing of the gamma signal. It should be noted that the EZ-GAMMA probe detector may become over-saturated in zones of very high radioactivity (>1% e U₃O₈) potentially leading to under-estimation of eU₃O₈ grade in these zones. All gamma data is compared with geochemical data both via downhole comparisons and overall populations in bivariate and distribution analysis to check for potential error or disequilibrium. To adequately compare with geochemistry gamma probe data is composited into intervals represented by the corresponding geochemical samples. However, because the methods sample different volumes, the correspondence between the two methods may not be exact. Energy Metals experience is that the two methods are generally in good agreement provided the interval of comparison is sufficiently large (>2m). Instantaneous spot verification of high gamma count zones is carried out on site using a handheld portable XRF (Olympus Vanta).
