

Voluntary Lodgement of Appendix 4C and Update

Sydney, 17 October 2024

We attach the Fiducian Group Limited's (ASX: FID) Appendix 4C for the most recent quarter ending 30 September 2024.

The lodgement of the Appendix 4C at the end of the first and third quarters of a financial year is a voluntary act undertaken by the company and is not required by the ASX.

In conjunction with the Appendix 4C, we also add the explanations that:

- (a) net inflows to the core Fiducian platform for the quarter ending 30 September 2024 was \$101 million (quarter ending September 2023: \$60 million net inflow); and
- (b) At 30 June 2024, badged platform and Auxilium fund balance was \$102 million and the net inflows for the quarter ending 30 September 2024 was \$22 million (\$84 million net outflow in the September 2023 quarter from transactional wholesale investors which had no revenue impact). The net outflows from legacy IFAs for the quarter ending 30 September 2024 was \$13 million (quarter ending September 2023: \$15 million net outflow)
- (c) Funds Under Management, Administration and Advice as at 30 September 2024 was \$14.2 billion (September 2023: \$12.4 billion).
