Notice of 2024 Annual General Meeting

Notice is given that the Annual General Meeting (**AGM** or **Meeting**) of 3P Learning Limited (**Company**) will be held at **10:30 am (AEDT) on Wednesday 20 November 2024** at the Company's registered office at 655 Parramatta Road, Leichhardt NSW 2040 for the purpose of transacting the business set out in this Notice. Registrations in person will commence at 10:00 am.

Items of Business

1. Receipt of Annual Financial Report

To receive and consider the Company's Financial Statements, Directors' Report and the Auditor's Report as set out in the Annual Report for the financial year ended 30 June 2024. No resolution or vote is required for this item of business.

2. Adoption of the FY24 Remuneration Report

To consider and, if thought fit, pass the following resolution as a non-binding ordinary resolution:

That the Remuneration Report for the financial year ended 30 June 2024 be adopted.

Note: The vote on this resolution is advisory only and does not bind the Company or the Directors. A voting exclusion applies to this resolution; see below for details. The non-executive Directors (which excludes Mr Matthew Sandblom, Executive Chairman) unanimously recommend that you vote in favour of this item.

3. Re-election of Directors

To consider and, if thought fit, pass the following as separate ordinary resolutions:

3a. Re-election of Mr Allan Brackin

 That Mr Allan Brackin, who retires in accordance with rule 10.3 of the Company's Constitution, and being eligible for re-election, be re-elected as a Director of the Company.

Note: The Directors unanimously support the re-election of Mr Brackin (with Mr Brackin abstaining from recommending his own re-election).

3b. Re-election of Ms Katherine Ostin

■ That Ms Katherine Ostin, who retires in accordance with rule 10.3 of the Company's Constitution, and being eligible for re-election, be re-elected as a Director of the Company.

Note: The Directors unanimously support the re-election of Ms Ostin (with Ms Ostin abstaining from recommending her own re-election).

3c. Re-election of Mr Matthew Sandblom

 That Mr Matthew Sandblom, who retires in accordance with rule 10.3 of the Company's Constitution, and being eligible for re-election, be re-elected as a Director of the Company.

Note: The Directors unanimously support the re-election of Mr Sandblom (with Mr Sandblom abstaining from recommending his own re-election).

Voting exclusions statement

The resolution at Item 2, "Adoption of the FY24 Remuneration Report", is connected directly with the remuneration of members of the Company's Key Management Personnel (**KMP**). The *Corporations Act 2001* (Cth) restricts KMP and their closely related parties from voting on these items. A "closely related party" of a KMP is defined in the Corporations Act; it includes a spouse, dependent, and certain other close family members, as well as any companies controlled by a member of the KMP.

In accordance with these requirements, the Company will disregard any votes cast on the resolution in Item 2:

- by or on behalf of a member of the Company's KMP named in the Remuneration Report or their closely related parties, regardless of the capacity in which the vote is cast; or
- as a proxy or an attorney for a person who is a member of the KMP at the date of the AGM or their closely related parties.

However, the Company will not disregard votes cast on the resolution in Item 2 if they are cast as proxy for a person entitled to vote on those items:

- in accordance with the directions on the voting form; or
- by the Chairman of the meeting pursuant to an express authorisation to exercise the proxy decides, even though Item 2 is connected with the remuneration of the Company's KMP; or
- by a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary, provided the following conditions are met:
 - the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting and is not an associate of a person excluded from voting on the resolution; and
 - o the holder votes on the resolution in accordance with the directions given by the beneficiary to the holder to vote in that way.

Voting entitlements

The Directors have determined, in accordance with regulation 7.11.37 of the *Corporations Regulations 2001* (Cth), that persons who are registered holders of shares of the Company as at **7:00 pm (AEDT) on Monday 18 November 2024** will be eligible to attend and to vote at the Meeting as a shareholder. Share transfers registered after that time will be disregarded in determining entitlements to attend and vote at the Meeting.

Further information in relation to each resolution to be considered at the AGM is set out in the enclosed Explanatory Notes. The information for shareholders and Explanatory Notes form part of this Notice of Meeting.

Information for shareholders | How to attend and vote

Voting on the proposed resolutions at this Meeting will be conducted by poll. If you are eligible to vote at the Meeting, you may:

- attend and vote at the Meeting;
- lodge a direct vote in advance of the Meeting; or
- appoint a proxy (including the Chair of the Meeting), corporate representative or attorney to attend the Meeting and vote on your behalf at the Meeting.

Voting at the Meeting

If you would like to attend and vote at the Meeting, please remember to bring the voting form accompanying this Notice of Meeting. The form will assist in registering your attendance. Shareholders and proxies who attend the Meeting will be able to vote on the resolutions directly, between the commencement of the Meeting and the closure of voting as announced by the Chair during the Meeting.

Direct voting

You may cast your vote in advance of the Meeting by following the instructions on the voting form accompanying this Notice of Meeting. If you lodge a direct vote, you are voting directly and are not appointing a third party, such as a proxy, to act on your behalf.

If you have lodged a direct vote, and subsequently attend the Meeting, your attendance will cancel your direct vote. If you also appoint a proxy or representative, your direct vote will override any votes cast by the proxy or representative.

Voting by proxy (including appointing the Chairman as your proxy)

Any shareholder who is entitled to attend and cast a vote at the meeting may appoint a proxy.

To vote by proxy please sign and return, prior to the meeting, the voting form accompanying this Notice of Meeting. You may also do this online at https://investorcentre.linkgroup.com.

A proxy need not be a 3PL Shareholder and may be an individual or a body corporate. If a body corporate is appointed as a proxy, it must ensure that it appoints a corporate representative in accordance with section 250D of the Corporations Act to exercise its powers as proxy, as discussed below.

A shareholder who is entitled to cast two or more votes may appoint two proxies to attend the meeting and vote on their behalf and may specify the proportion or number of votes each proxy is appointed to exercise. If a shareholder appoints two proxies and the appointment does not specify the proportion or number of the shareholder's votes each proxy may exercise, each proxy may exercise half of the votes (disregarding fractions). If you wish to appoint a second proxy, an additional proxy voting form may be obtained by calling the 3PL Share Registry on (+61) 1300 554 474.

If you do not instruct your proxy on how to vote, your proxy may vote as they see fit at the Meeting.

If a proxy appointment is signed by a 3PL Shareholder but does not name the proxy or proxies in whose favour it is given, the Chairman of the Meeting will act as proxy. If you appoint the Chairman of the Meeting as your proxy, and you do not direct your proxy how to vote on an item of business set out in this Notice of Meeting, then by completing and submitting the voting form you will be expressly authorising the Chairman of the Meeting to exercise the proxy and vote as the Chairman of the Meeting decides on that item of business (even though Item 2 is connected directly or indirectly with the remuneration of members of the KMP and the Chairman of the Meeting is a member of the KMP).

The Chairman of the Meeting intends to vote all available proxies in favour of each item of business.

If you choose to appoint a proxy to attend and vote on your behalf at the Meeting, you may still attend and participate in the Meeting, but you will not be entitled to vote at the Meeting unless you have revoked your proxy instructions by contacting the 3PL Share Registry as set out below.

Voting by corporate representative

If you are a body corporate, you may appoint a corporate representative to attend and vote at the Meeting on your behalf. The appointment must comply with section 250D of the Corporations Act.

Lodging your voting form

If a voting form is completed under power of attorney or other authority, the original or certified copy of the power of attorney or other authority must be lodged with the 3PL Share Registry. The original or certified power of attorney accompanying the completed voting form must be mailed or faxed to the 3PL Share Register, unless the power of attorney or other authority has previously been given to the 3PL Share Registry.

Questions from shareholders

The Chairman of the meeting will allow a reasonable opportunity for shareholders at the meeting to ask questions about and make comments on the management of the Company and on the Financial Report, the Directors' Report (including the Remuneration Report) and the Auditor's Report (collectively, **Reports**), as well as each of the Resolutions to be considered at the meeting.

Shareholders may also submit written questions to the Company before the AGM.

The Chair will endeavour to address as many of the more frequently raised relevant questions as reasonably possible. However, there may not be sufficient time available at the AGM to address all the questions raised. Please note that individual responses will not be sent to any shareholder.

A representative of the Company's auditor, KPMG, will attend the meeting. As the Meeting considers the reports, the Chair will allow a reasonable opportunity for shareholders at the Meeting to ask the auditor's representative questions relevant to the:

- · conduct of the audit;
- preparation and content of the Auditor's Report for the financial year ended 30 June 2024;
- accounting policies adopted by the Company in relation to the preparation of the financial statements contained in the Financial Report for that year;
- independence of the auditor in relation to the conduct of the audit.

Any written questions must be received by no later than **5:00 pm (AEDT)** on **Wednesday 13 November 2024**. Please submit them by email to the Company Secretary at secretary@3plearning.com (please include your full name and SRN).

Explanatory Notes

These notes form part of the 2024 AGM Notice of Meeting and are intended to provide shareholders of the Company with information to assess the proposed resolutions. The Directors recommend that shareholders read these Explanatory Notes in full before making any decision in relation to the resolutions.

1. Receipt of Annual Financial Report

In accordance with section 317 of the Corporations Act, the Company is required to lay before the Annual General Meeting the reports of the Directors and Auditors for the year ended 30 June 2024, and the Financial Report, including the Financial Statements of the Company, for the year ended 30 June 2024.

Shareholders will be able to ask questions and direct written questions received in advance to the Company's auditor, KPMG (the Auditor), if the question is relevant to:

- the content of the Auditor's Report to be considered at the Meeting; or
- the conduct of the audit of the Financial Report to be considered at the Meeting.

There is no requirement for a formal resolution on this item. Accordingly, there will be no formal resolution put to the AGM.

2. Adoption of the FY24 Remuneration Report

The Remuneration Report is presented within the Directors' Report on pages 41–57 of the Company's 2024 Annual Report. It is also available on the Company's website at https://www.3plearning.com/investors/results. It sets out the remuneration policy for the Company and explains the remuneration arrangements for non-executive Directors, the CEO and other KMP.

A voting exclusion applies to this item of business, as set out in the Notice of Meeting.

Shareholders will have the opportunity to ask questions or provide comments on the Remuneration Report. This resolution is advisory only. The Board will however take the outcome of the vote, as well as shareholder feedback, into consideration when reviewing the remuneration framework for future years. Shareholders should also note that if 25% or more votes cast are against the Remuneration Report, the first element in the Board spill provisions contained in the Corporations Act (i.e. the "two strikes" rule) will be triggered and would affect next year's AGM.

The Board unanimously recommends that shareholders VOTE IN FAVOUR of this resolution.

The Chairman of the Meeting intends to vote all available proxies in favour of this resolution.

3. Re-election of Directors

During the 2024 financial year, the Board performed a review of its skills matrix and an evaluation of its performance. These evaluations enable the Board to consider and confirm the recommendations to support the re-election of Mr Allan Brackin, Ms Katherine Ostin and Mr Sandblom at this AGM.

Article 10.3 (a) of the Company's Constitution provides that a director must not hold office without re-election past the third annual general meeting following their last election, or for more than three years, whichever is the longer. The directors who retire from office at the conclusion of the 2024 AGM as set out in the Notice of meeting, and who are each eligible to stand for re-election, offer themselves for re-election to the Board.

3a. Re-election of Mr Allan Brackin

Allan Brackin BAppSc



Allan Brackin has a notable track record in building revenue growth and market value in both private and public companies within the technology sector. He has over 40 years of experience, with a wealth of knowledge in business strategy, sales and marketing, process re-engineering, change management, financial management and merger and acquisition activity, and governance. Allan has held various senior roles as CEO, Managing Director, Founder or Chair for various well-known technology companies.

Allan was previously appointed in August 2021. The Board regards Allan as an independent director.

The Board (with Mr Brackin abstaining) unanimously recommends that shareholders VOTE IN FAVOUR of this resolution to re-elect Allan Brackin as a director.

The Chairman of the Meeting intends to vote all available proxies in favour of this resolution.

3b. Re-election of Ms Katherine Ostin

Katherine Ostin BCom, F Fin, GAICD Chartered Accountant



Katherine Ostin has deep and diverse experience in audit and risk management. Her strong financial aptitude was built upon 12 years of experience as senior audit partner at KPMG. Ms Ostin has a proven track record in strategic and superior business outcomes in a broad range of industries, including technology, content and communications, media and entertainment. Her current directorships include Dusk Group Limited, Capral Limited, Next Science Limited, Elanor Commercial Property Fund and Elanor Investors Group.

Kathy was previously appointed in August 2021. The Board regards Kathy as an independent director.

The Board (with Ms Ostin abstaining) unanimously recommends that shareholders VOTE IN FAVOUR of this resolution to re-elect Katherine Ostin as a director.

The Chairman of the Meeting intends to vote all available proxies in favour of this resolution.

3c. Re-election of Mr Matthew Sandblom

Matthew Sandblom BEcon



Matthew Sandblom is an education entrepreneur, driven by the idea of producing resources for students that deliver on the promise that they provide better ways to learn than other products. In 1989, Mr Sandblom started his first company, Pascal Press, to publish school workbooks and study guides. With over 35 years of experience, Mr Sandblom has founded or co-founded many successful companies, including 3P Learning, Blake Education, ClickView and Blake eLearning. Mr Sandblom is currently a major shareholder of 3P Learning.

Matthew is the Executive Chairman and was previously appointed in August 2021.

The Board (with Mr Sandblom abstaining) unanimously recommends that shareholders VOTE IN FAVOUR of this resolution to re-elect Matthew Sandblom as a director.

The Chairman of the Meeting intends to vote all available proxies in favour of this resolution.
