# Results of 2024 Annual General Meeting

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, the results of the 2024 Annual General Meeting (AGM) of Articore Group Limited (ASX:ATG) held on Thursday, 24 October 2024 are set-out below. All resolutions put to the AGM were decided by way of poll:

Resolution 1: Adoption of Remuneration Report - resolution passed (65.90% in favour)

Resolution 2: Election of Director - Robin Low - resolution passed (80.78% in favour)

Resolution 3: Election of Director - Robin Mendelson - resolution passed (80.93% in favour) Resolution 4: Election of Board Candidate - John Lewis - resolution passed (75.09% in favour)

Resolution 5: Approval of Non-executive Director participation in Equity Incentive Plan and issue of Equity Securities to Non-executive Directors in lieu of cash fees - resolution passed (71.63% in favour)

Resolution 6: Ratification of prior issue of Shares pursuant to ASX Listing Rule 7.4 - resolution passed (81.98% in favour)

Resolution 7: Ratification of prior issue of Employee Incentive Securities pursuant to ASX Listing Rule 7.4 - resolution 🗘 passed (80.86% in favour)

Resolution 8: Approval of Director participation in Equity Incentive Plan and issue of Equity Securities to Group CEO and Managing Director, Mr Martin Hosking - resolution passed (55.94% in favour)

Resolution 9: Renewal of proportional takeover provisions - resolution passed (80.91% in favour)

Resolution 10: Election of Non-Board Endorsed Candidate - Adam Hoydysh - resolution not passed (80.95% against)

Resolution 11: Election of Non-Board Endorsed Candidate - Daeyoung Choi - resolution not passed (80.97% against)

Resolution 12: Election of Non-Board Endorsed Candidate - Oliver Richner - resolution not passed (80.97% against)

As more than 25% of the votes were cast against Resolution 1 (Remuneration Report), this constitutes a "first strike" for the purposes of section 250U of the Corporations Act 2001.

The total number of valid proxy votes and direct votes received in respect of each item are set out in the enclosed report from Link Market Services Limited.
