#### 1 ACTION TO BE TAKEN BY SHAREHOLDERS, INCLUDING ATTENDING THE MEETING

Shareholders should read the Notice and this Explanatory Memorandum carefully before deciding how to attend and vote on the Resolutions.

#### 1.1 Proxies

All Shareholders are invited and encouraged to attend the Meeting. If a Shareholder is unable to attend in person, they can appoint a proxy to attend on their behalf by

signing and returning the Proxy Form (attached to the Notice) to the Company in accordance with the instructions on the Proxy Form. The Company encourages Shareholders completing a Proxy Form to direct the proxy how to vote on each Resolution.

The Proxy Form must be received no later than 48 hours before the commencement of the Meeting, i.e. by no later than 11.30am (AWST) on 27 November 2024. Any Proxy Form received after that time will not be valid for the Meeting.

#### 1.2 Corporate representatives

Shareholders who are body corporates may appoint a person to act as their corporate representative at the Meeting by providing that person with a certificate or letter executed in accordance with the Corporations Act authorising him or her to act as the body corporate's representative. The authority may be sent to the Company and/or registry in advance of the Meeting or handed in at the Meeting when registering as a corporate representative.

An appointment of corporate representative form is available from the website of the Company's share registry (Link Market Services Limited).

#### 1.3 Eligibility to vote

The Directors have determined that, for the purposes of voting at the Meeting, Shareholders are those persons who are the registered holders of Shares at 7.00pm (AEDT) on 27 November 2024.

#### 2 ANNUAL REPORT

There is no requirement for Shareholders to approve the Annual Report.

Shareholders will be offered the opportunity to:

- (d) discuss the Annual Report for the financial year ended on 30 June 2024 which is available on the ASX platform at <a href="www.asx.com.au">www.asx.com.au</a>; and
- (e) ask questions about or make comment on the management of the Company.

The chair of the Meeting will allow reasonable opportunity for the Shareholders as a whole at the Meeting to ask the auditor or the auditor's representative questions relevant to:

- (a) the conduct of the audit;
- (b) the preparation and content of the auditor's report;
- (c) accounting policies adopted by the Company in relation to the preparation of the financial statements; and
- (d) the independence of the auditor in relation to the conduct of the audit.

In addition to taking questions at the Meeting, written questions to the Company's auditor about:

- (e) the content of the auditor's report to be considered at the Meeting; and
- (f) the conduct of the audit of the annual financial report to be considered at the Meeting,

may be submitted no later than 5 business days before the Meeting to the Company Secretary at the Company's registered office.

#### 3 RESOLUTION 1 - REMUNERATION REPORT

#### 3.1 Introduction

The Remuneration Report is in the Directors' Report section of the Company's Annual Report.

By way of summary, the Remuneration Report:

- (g) explains the Company's remuneration policy and the process for determining the remuneration of its Directors and executive officers;
- (h) addresses the relationship between the Company's remuneration policy and the Company's performance; and
- (i) sets out remuneration details for each Director and each of the Company's executives and group executives named in the Remuneration Report for the financial year ended on 30 June 2024.

Section 250R(2) of the Corporations Act requires companies to put a resolution to their members that the Remuneration Report be adopted. The vote on this resolution is advisory only, however, and does not bind the Board or the Company. The Board will consider the outcome of the vote and comments made by Shareholders on the Remuneration Report at the Meeting when reviewing the Company's remuneration policies.

The Chair will give Shareholders a reasonable opportunity to ask questions about or to make comments on the Remuneration Report.

#### 3.2 Voting consequences

Under the Corporations Act, if 25% or more of votes that are cast are voted against the adoption of the Remuneration Report at two consecutive annual general

meetings, Shareholders will be required to vote at the second of those annual general meetings on a resolution that a further meeting is held at which all of the Company's Directors who were directors when the resolution to make the directors report considered at the later annual general meeting was passed (other than the Managing Director) must go up for re-election (**Spill Resolution**).

If more than 50% of votes cast are in favour of the Spill Resolution, the Company must convene a shareholder meeting (**Spill Meeting**) within 90 days of the second annual general meeting.

All of the directors of the company who were directors of the company when the resolution to make the directors' report considered at the second annual general meeting was passed, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for reelection at the Spill Meeting.

Shareholders approved the Company's Remuneration Report for financial year ended on 30 June 2023, and as a result there is no requirement to vote on a Spill Resolution if 25% or more of the votes cast vote against Resolution 1.

#### 4 RESOLUTION 2 - RE-ELECTION OF DIRECTOR

#### 4.1 Introduction

Listing Rule 14.4 provides as follows:

- (a) A director of an entity must not hold office (without re-election) past the third annual general meeting following the director's appointment or 3 years, whichever is the longer.
- (b) any director appointed to fill a casual vacancy holds office until the next following annual general meeting and is then eligible for re-election.

Rule 12.3(b) of the Company's Constitution provides that there must be an election of Directors at each annual general meeting, and that a Director appointed as a casual vacancy satisfies this requirement.

Rule 12.8 of the Company's Constitution states that any director appointed to fill a casual vacancy holds office until the next following annual general meeting and is then eligible for re-election.

#### 4.2 Resolution 2 - Eric Sondergaard

Mr Sondergaard was appointed on 23 April 2024 to fill a casual vacancy. In accordance with rule 12.3(ii) of the Company's Constitution, Mr Sondergaard offers himself for re-election.

Details of Mr Sondergaard's qualifications and experience are set out in the Company's 2024 Annual Report.

#### 4.3 Directors' recommendations

The Board (excluding Mr Sondergaard) recommends that Shareholders vote in favour of Resolution 2.

#### 5 RESOLUTION 3 - APPROVAL OF 10% PLACEMENT FACILITY

#### 5.1 General

The Company seeks Shareholder approval to issue Equity Securities up to 10% of its issued share capital through placements over a Relevant Period following shareholder approval (10% Placement Facility).

The exact number of Equity Securities to be issued under the 10% Placement Facility will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2 (refer to section 5.2(a) below).

Any funds raised will be used towards exploration and development of the Company's projects, potential acquisitions and general working capital. The allocation of funds raised will depend on the timing of fund raising, the development stages of the projects and the Company's circumstances at the time.

Resolution 3 is a special resolution and therefore requires approval of 75% of the votes cast by Shareholders present and eligible to vote (in person, by proxy, by attorney or, in the case of a corporate Shareholder, by a corporate representative).

#### 5.2 Listing Rules 7.1 and 7.1A

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary securities it had on issue at the start of that period. Under Listing Rule 7.1A, however, an eligible entity can seek approval from its members, by way of a special resolution passed at its annual general meeting, to increase this 15% limit by an extra 10% to 25%.

An eligible entity for the purposes of Listing Rule 7.1A is an entity that is not included in the S&P/ASX~300 Index and has a market capitalization of \$300 million or less. The Company is an eligible entity.

Resolution 3 seeks shareholder approval by way of special resolution for the Company to have the additional 10% capacity provided for in Listing Rule 7.1A to issue equity securities without shareholder approval.

If Resolution 3 is passed, the Company will be able to issue Equity Securities up to the combined 25% limit in Listing Rules 7.1 and 7.1A without any further Shareholder approval. If Resolution 3 is not passed, the Company will not be able to access the additional 10% capacity to issue Equity Securities without Shareholder approval provided for in Listing Rule 7.1A and will remain subject to the 15% limit on issuing Equity Securities without Shareholder approval set out in Listing Rule 7.1.

(a) Maximum number of Equity Securities which may be issued

The number of Equity Securities which may be issued, or agreed to be issued, under the 10% Placement Facility is prescribed in Listing Rule 7.1A.2 and is calculated as follows:

#### Number of Equity Securities = $(A \times D) - E$

- "A" the number of fully paid ordinary shares on issue at the commencement of the Relevant Period:
  - (A) plus the number of fully paid shares issued in the Relevant Period under an exception in Listing Rule 7.2 other than exception 9,16 or 17;
  - (B) plus the number of fully paid ordinary shares issued in the Relevant Period on the conversion of convertible securities within Listing Rule 7.2 exception 9 where:
    - the convertible securities were issued or agreed to be issued before the commencement of the Relevant Period; or
    - the issue of, or agreement to issue, the convertible securities was approved, or taken under the Listing Rules to have been approved, under Listing Rule 7.1 or Listing Rule 7.4;
  - (C) plus the number of fully paid ordinary shares issued in the Relevant Period under an agreement to issue securities within Listing Rule 7.2 exception 16 where:
    - the agreement was entered into before the commencement of the Relevant Period; or
    - the agreement or issue was approved, or taken under the Listing Rules to have been approved, under Listing Rule 7.1 or Listing Rule 7.4;
  - (D) plus the number of any other fully paid ordinary shares issued in the Relevant Period with approval under Listing Rule 7.1 or Listing Rule 7.4;
  - (E) plus the number of partly paid shares that became fully paid in the Relevant Period;
  - (F) less the number of fully paid ordinary shares cancelled in the Relevant Period.

"D" is 10%.

"E" is the number of Equity Securities issued or agreed to be issued under Listing Rule 7.1A.2 in the Relevant Period where the issue or

agreement has not been subsequently approved by Shareholders under Listing Rule 7.4.

The actual number of Equity Securities that may be issued under Listing Rule 7.1A is calculated at the date of issue of the Equity Securities in accordance with the above formula.

The ability of an entity to issue Equity Securities under Listing Rule 7.1A is in addition to the entity's 15% placement capacity under Listing Rule 7.1.

(b) Minimum Issue Price

  - (i) the date on which the price at which the Equity Securities are to be issued is agreed by the Company and the recipient of the Equity Securities; or
  - (ii) if the Equity Securities are not issued within 10 Trading Days of the date in paragraph (i) above, the date on which the Equity Securities are issued.
- (c) The issue under Listing Rule 7.1A can only be made for cash consideration. The Company intends to use any funds raised towards exploration and development of the Company's projects, potential acquisitions and/or general working capital.
- (d) There is a risk of economic and voting dilution to existing Shareholders in approving the 10% Placement Facility, including the risks that:
  - (i) the market price for the Company's Equity Securities may be significantly lower on the date of the issue of the Equity Securities than when Shareholders approve the 10% Placement Facility; and
  - (ii) the Equity Securities may be issued at a price that is at a discount to the market price for the Company's Equity Securities on the issue date.

The table has been prepared on the following assumptions:

- (i) Shareholders approve the Placement and a further 1,432,960,851 Shares are issued under it.
- (ii) The Company issues, or agrees to issue, the maximum number of Equity Securities available under the 10% Placement Facility.
- (iii) No Options have been exercised before the date of the issue of the Equity Securities.
- (iii) The 10% voting dilution reflects the aggregate percentage dilution against the issued share capital at the time of issue. This is why the voting dilution is shown in each example as 10%.
- (iv) The issue of Equity Securities under the 10% Placement Facility consists only of Shares. If the issue of Equity Securities includes quoted options, it is assumed that those quoted options are exercised into Shares for the purpose of calculating the voting dilution effect on existing Shareholders.

- (e) The Company is yet to identify the persons to whom Equity Securities will be issued to under the 10% Placement Facility. The Company's policy for allocating Equity Securities issued under the 10% Placement Facility will be determined on a case-by-case basis depending upon the purpose, and prevailing market conditions at the time, of any issue and having regard to factors including but not limited to the following:

- (i) The fundraising methods available to the Company, including but not limited to, rights issue or other issue which may minimise dilution to Shareholders.
- (ii) The effect of the issue of the Equity Securities on the control of the Company.
- (iii) The financial situation and solvency of the Company.
- (iv) Advice from corporate, financial and broking advisers (if applicable).

The subscribers may include existing substantial Shareholders and/or new Shareholders who are not related parties or associates of a related party of the Company.

- (f) No Equity Securities were issued under Listing Rule 7.1A.2 in the 12 month period preceding the date of the Meeting.
- (g) At the date of the Notice, the Company is not proposing to make an issue of Equity Securities under Listing Rule 7.1A.2 and no voting exclusion statement is required for the Notice.

#### 5.4 Directors' recommendation

The Board unanimously recommends that Shareholders vote in favour of Resolution 4. This will give the Company flexibility issue securities and raise funds under Listing Rule 7.1A.

#### 6 RESOLUTION 4 - RATIFICATION OF ISSUE OF ADVISOR SECURITIES

#### 6.1 Introduction

On 22 July 2024 the Company announced that it had appointed John Handcock as a strategic advisor to the Company. In consideration for assisting with the divestment of the Company's Australian assets, introducing investors and new projects and advising the Board on project related maters, the Company issued Mr Hancock (together the Advisor Securities):

- (b) 10,000,000 Advisor Options;
- (c) 5,000,000 Shares; and
- (d) 5,000,000 Performance Rights, , which convert to Shares upon Mr Handcock introducing during the advisory's term (initially 12 months) >\$2.5 million under a capital raising by the Company and otherwise on the terms in SCHEDULE 4.

Mr Hancock's appointment is for 12 months, with either party having the right to terminate on 1 week's notice.

The Shares issued are subject to 12 months voluntary escrow from issue.

The Advisor Securities were issued without Shareholder approval using the Company's available capacity under Listing Rule 7.1. Resolution 4 seeks Shareholder ratification for the issue of the Advisory Securities.

On 16 October 2024 the vesting condition for the Performance Rights was satisfied, and the rights converted to Shares (with the issue of Shares not requiring Shareholder approval by reason of Listing Rule 7.2 exception 9).

#### 6.2 Capital structure, dilution and voting power

The Company's proposed capital structure following the Placement, including its dilutive effect, is set out in SCHEDULE 2.

#### 6.3 Regulatory requirements

Listing Rules 7.1 and 7.1A are summarised in section 5.2.

Listing Rule 7.4 allows shareholders to ratify an issue of equity securities after it has been made or agreed to be made. If they do, the issue is taken to have been approved under Listing Rules 7.1 and 7.1A, and so does not reduce a company's capacity to issue further equity securities without shareholder approval under Listing Rule 7.1 and (assuming the conditions of that rule are satisfied) Listing Rule 7.1A.

Securities issues that are approved by Shareholders under Listing Rule 7.4 are not included in calculating an entity's 15% and 10% capacities under Listing Rule 7.1 and 7.1A.

#### 6.4 Information required by Listing Rule 7.5

For the purposes of Listing Rule 7.5, the following information is provided for the ratification of the issue of the Advisor Securities:

- (a) The securities issued to John Handcock, who is not a related party of the Company, member of the Company's key management personnel, a substantial (30%+) holder or substantial (10%+) holder (both as defined in the Listing Rules) in the Company or an advisor to the Company, or an associate of any of these, or otherwise a person to whom Listing Rule 10.11 applies.
- (b) The number and terms of securities issued by the Company was:
  - (i) 10,000,000 Advisor Options, with an exercise price of \$0.02, expiry date 24 months from issue and otherwise on the terms in SCHEDULE 3;
  - (ii) 5,000,000 fully paid ordinary Shares; and
  - (iii) 5,000,000 Performance Rights, which convert to Shares upon Mr Handcock introducing during the advisory's term (initially 12 months)
     >\$2.5 million under a capital raising by the Company and otherwise on the terms in SCHEDULE 4.
- (c) The Advisory Securities were issued on 23 July 2024.

- (d) The Advisory Securities were issued in consideration for Mr Hancock advising the Company on project, investor and other strategic matters, and no funds were raised from the issue. Funds raised from exercising the Advisor Options will be used for general working capital.
- (e) The material terms of the Mr Handcock's appointment and the issue of the Advisory Securities are set out above.
- (f) A voting exclusion statement is included in the Notice.

Listing Rules 7.1 and 7.1A are summarised above.

If Resolution 4 is passed, the issue will be excluded in calculating the Company's 15% limit and 10% limit under Listing Rules 7.1 and 7.1A, effectively increasing the number of equity securities the Company can issue without Shareholder approval over the 12 months following the issues.

If Resolution 4 is not passed, the issue will be included in calculating the Company's 15% limit under Listing Rule 7.1 and 10% limit under Listing Rule 7.1A, effectively limiting the number of equity securities the Company can issue without Shareholder approval under Listing Rule 7.1 over the 12 months following the issue.

#### 6.5 Directors' recommendation

The Directors recommend that Shareholders approve Resolution 4, as it will give the Company more flexibility in being able to issue securities.

### 7 RESOLUTIONS 5 TO 7 - RATIFICATION ISSUE OF SECURITIES UNDER THE PLACEMENT

#### 7.1 Introduction

On 9 October 2024 the Company announced that it had received firm commitments to raise \$5 million through the issue of 200 million Shares at an issue price of \$0.025 per Share with 1 attaching Option (exercise price \$0.04 and expiring 3 years from issue) (**Placement Options**) for every 4 Shares issued (**Placement**).

Proceeds from the Placement will be used for a maiden drill campaign at the Rae Copper Project in Quarter 1 2025 and with the potential for Great Bear to commence later mid season using a multi-rig approach.

The Placement was cornerstoned by Mr Hancock for \$2.5 million, with the balance from investors (together the **Placement Participants**) introduced by CPS Capital Group Pty Limited, which was issued 25 million Options (**Broker Options**).

The Placement Shares and attaching Placement Options and Broker Options were issued on 16 October 2024.

The Placement and Broker Option issue were made without Shareholder approval using the Company's available capacity under Listing Rules 7.1 and 7.1A. Resolutions 5 to 7 seek Shareholder ratification for the issues.

#### 7.2 Capital structure, dilution and voting power

The Company's proposed capital structure following the Placement, including its dilutive effect, is set out in SCHEDULE 2.

#### 7.3 Regulatory requirements

Listing Rules 7.1 and 7.1A are summarised in section 5.2. Listing Rule 7.4 is summarized in section 6.3.

Securities issues that are approved by Shareholders under Listing Rule 7.4 are not included in calculating an entity's 15% and 10% capacities under Listing Rule 7.1 and 7.1A.

#### 7.4 Resolutions 5 to 7- Information required by Listing Rule 7.5

For the purposes of Listing Rule 7.5, the following information is provided for the ratification of the issue of the Tranche 1 Placement Shares:

  - (iii) Resolution 7 (issue under Listing Rule 7.1) The securities were issued to CPS Capital Group Pty Limited and its nominees, who were not related parties of the Company, members of the Company's key management personnel, a substantial (30%+) holder or substantial (10%+) holder (both as defined in the Listing Rules) in the Company or an advisor to the Company, or an associate of any of these, or otherwise a person to whom Listing Rule 10.11 applies.
- (b) The number and terms of securities issued by the Company was:
  - (i) Resolution 5 (issue under Listing Rule 7.1):

  - (ii) Resolution 6 (issue under Listing Rule 7.1A): Shares were issued at an issue price of \$0.025 per Share.
  - (iii) Resolution 7 (issue under Listing Rule 7.1) the Broker Options were issued in part consideration for services provided by CPS Capital Group Pty Limited.
- (f) The Placement Shares were issued to raise \$5 million (before costs). The use of funds is set out in section 7.1.
- (g) The material terms of the Placement were as follows:
  - (i) Subscribers would subscribe for Shares at an issue price of \$0.025, with 1 attaching Placement Option for every 4 Placement Shares issued.
  - (ii) The subscription amount would be paid, and Placement Shares issued, as soon as practicable.

CPS Capital Group Pty Limited acted as lead manager for the Placement and was paid a lead managers fee of 2% for managing the Placement, 4% on funds raised under the Placement and the Broker Options. CPS was also engaged to provide corporate advisory services for 12 months from November 2024, for which it will be paid \$10,000 per month.

Other than those set out in section 7.1 and this section, there are no other material terms in relation to the issue.

(h) A voting exclusion statement is included in the Notice.

Listing Rules 7.1 and 7.1A are summarised above.

If Resolutions 5 to 7 are passed, the issues will be excluded in calculating the Company's 15% limit and 10% limit under Listing Rules 7.1 and 7.1A, effectively increasing the number of equity securities the Company can issue without Shareholder approval over the 12 months following the issues.

If Resolutions 5, 6 and/or 7 is not passed, the relevant issues will be included in calculating the Company's 15% limit under Listing Rule 7.1 and 10% limit under Listing Rule 7.1A, effectively limiting the number of equity securities the Company can issue without Shareholder approval under Listing Rule 7.1 over the 12 months following the issue.

#### 8 RESOLUTIONS 8 TO 11 - DIRECTOR OPTION ISSUE

#### 8.1 Introduction

On 31 October 2023 Shareholders approved an employee securities incentive plan (WCN Plan).

On 27 September 2024 the Company announced that, to reward and incentivise Directors and subject to Shareholder approval, it would issue the following Options to Directors, all expiring 29 September 2024 and otherwise on the terms in SCHEDULE 6 (**Director Options**):

Resolutions 8 to 11 seek Shareholder approval for the issue of the Director Options.

#### 8.2 Regulatory Requirements

(b) Corporations Act - giving financial benefits to related parties

Chapter 2E of the Corporations Act prohibits a public company from giving a financial benefit to a related party of the company unless either:

- (i) the benefit is given on terms that would be reasonable in the circumstances if the company and related party were dealing at arm's length, or are on terms less favourable to the related party; or
- (ii) prior shareholder approval is obtained to the giving of the financial benefit.

Related party is widely defined under the Corporations Act, and includes a company's directors. Financial benefit is defined broadly and includes issuing securities. The Corporations Act requires that any consideration that is given is disregarded, even if the consideration is adequate.

Securities issues that are approved by Shareholders under Listing Rule 10.14 are not included in calculating an entity's 15% and 10% capacities under Listing Rule 7.1 and 7.1A.
