Answer:

No. cash outflows from investing activities included the payment of drilling and related services as a result of a drilling campaign undertaken.

Lefroy Exploration Limited (the "Company") does not expect to have the same level of net operating cash outflows going forward, as it is not expecting to undertake the same level of drilling activity within each of the next 2 quarters.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer:

Yes. As announced to the ASX on 23 October 2024, the Company is pursuing opportunities to commercialise its resources and advance exploration targets, including advanced conversations under confidentiality agreements with several parties in order to unlock the value of its gold assets, through a strategic partnership.

In addition to the above, the Company announced to the ASX on 28 October 2024 that it has received firm commitments to raise approximately \$3.3 million (before costs) through an oversubscribed placement to institutional and sophisticated investors.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes – as outlined above.
