## ENDEAVOR MINE REDEVELOPMENT FUNDING COMPLETED

*Milestones continue to be achieved with funding now in place to deliver cashflow.*

### HIGHLIGHTS

- **US\$20 million (~A\$30 million) Pre-payment Loan Facility documentation completed.**
- **\$2,500,000 options issued as part of the facility priced at \$1.00/share.**

**Polymetals Resources Ltd** (ASX: **POL**) (Polymetals or the Company) has completed formal documentation for its US\$20 million Pre-payment Loan Facility<sup>1</sup> with Ocean Partners.

Loan Facility funds are now available to be drawn as required to meet the Company's planned redevelopment capital<sup>2</sup> requirements to restart the Endeavor silver zinc lead mine with first cashflow on track for H1 2025.

Additionally, 2,500,000 options will be issued to Ocean Partners (or its Nominee) as part of the facility, priced at \$1.00 per share, exercisable within 24 months.

#### **Polymetals Executive Chairman Dave Sproule said:**

*"The Company continues to meet its stated objectives on time, with its senior management in place focussed on the re-development work required to bring Endeavor back online.*

*We are very much looking forward to generating first concentrates and cash flow during H1 2025."*
