Commentary related to the above results

The loss for the Company after providing for income tax for the financial year amounted to \$365,111 (2023: loss of \$2,619,776). Revenue for the period was \$580,000. Revenue was underpinned by sales of the Company's premium marine produces, including dried ling maw, into both branded and bulk purchase formats. Sales from the wholly-owned Cairns based subsidiary, Nine Ocean Fisheries Pty Ltd ("Nine Ocean") also added to the Company's revenue profile following acquisition during the Q2 of 2023FY.
