## Alcidion secures contract with Northern Adelaide Local Health Network (NALHN) for patient flow management

### Highlights

- Alcidion has signed a contract with Northern Adelaide Local Health Network (NALHN), a portfolio of the South Australian Department for Health and Wellbeing, for use of its Miya Precision and mobile clinical task management solutions.
- The deployment of Miya Precision will support real-time patient flow management; command centre operations; secure clinical task management and messaging; and mobile access to real-time data
- The Total Contract Value (TCV) is \$4.5M over a five year period, structured as an initial two-year commitment with rights to extend out to five years.
- The contract was awarded following a competitive tender process and is Alcidion's first deployment of Miya Precision into South Australia.

Northern Adelaide Local Health Network is one of the largest Local Health Networks (LHNs) in South Australia. NALHN provides a range of public hospital, community and home-based services across multiple sites in the northern and north-eastern metropolitan Adelaide region, employing nearly 6,500 staff and delivering services to more than 400,000 people in the community.

The initial focus of this Contract is to realise NALHN's forward-looking vision to implement a fully integrated, real-time demand management and capacity planning solution, by deploying Alcidion's Miya Precision platform to improve patient access to care, increase operational efficiencies and improve clinician experience across the organisation.

The Total Contract Value (TCV) is \$4.5M over a five year period, with an initial two-year term and further extensions out to five years included.

The overall solution will provide an interoperable, multi-facility digital health platform, delivering end-to-end patient flow management. Miya Precision will be integrated with the SA Health electronic patient record and other clinical applications deployed at NALHN. The solution will provide NALHN with a real-time and streamlined view of each patient's journey across NALHN facilities. Single and multi-facility real-time demand and capacity metrics will support improve patient flow across the system.

**Alcidion CEO and MD, Kate Quirke said:** “This Contract represents a significant milestone for Alcidion enabling us to support critical health information systems in the state of South Australia – where our Company was founded. Alcidion has a large team based in Adelaide who are excited to start work on this project. We are deeply committed to working closely with the Northern Adelaide Local Health Network team to leverage the full capabilities of our technology solutions. Our focused goal is to improve workflow efficiencies and health outcomes for their patients, which we hope will inform and inspire the highest standards of care for all Australian healthcare providers.”
