Results of Annual General Meeting

Bannerman Energy Ltd (ASX:BMN; OTCQX:BNNLF, NSX:BMN) (**Company**) advises that the Annual General Meeting of Shareholders was held today, 15 November 2024 at 10:00am.

Resolution 4, the Replacement of the Constitution, being a special resolution, did not pass as it failed to achieve the required 75% shareholder approval. Consequently, Resolutions 5 (Amendment to the Constitution for Virtual Only General Meetings) and Resolution 6 (Approval of Proportional Takeover Provisions) are no longer applicable and do not proceed further, as their consideration was contingent upon the successful passage of Resolution 4.

All other resolutions put to meeting were passed by poll.

In accordance with Section 251AA (2) of the Corporations Act 2001 and ASX Listing Rule 3.13.2, the Company hereby provides the results of the meeting; please refer to the information overleaf.
