## Results of Share Purchase Plan

**Lotus Resources Limited (ASX: LOT, OTCQX: LTSRF) (Lotus or the Company)** announces the results of its non-underwritten Share Purchase Plan (**SPP**) which closed at 7.00pm (AEDT) on Thursday, 14 November 2024.

The Company received a total of 174 valid applications under the SPP, representing a total valid application value of approximately A\$2,266,000. A\$203,500 was received from ineligible shareholders and those applications have been rejected.

A total of 9,064,000 new fully paid ordinary shares (**SPP Shares**) will be issued. The issue price of the SPP Shares is \$0.25, being the same price paid by investors in the Placement. The SPP Shares will rank equally with existing fully paid ordinary shares in the Company.

The SPP Shares are expected to be issued on 21 November 2024 and commence trading on the ASX on 22 November 2024. Holding statements are expected to be dispatched on 25 November 2024.

The SPP complements Lotus' successful non-underwritten two tranche A\$130 million placement to new and existing investors (**Placement**), with the A\$66.9 million (before costs) first tranche of the Placement complete. The second tranche of the Placement, raising approximately A\$63.1 million (before costs), is subject to shareholder approval at the Company's Extraordinary General Meeting on 6 December 2024.
